The M. W. the Grand Master delivered his Annual Address as follows:

#### GRAND MASTER'S ADDRESS.

Brethren:

Grand Lodge meets in the spring time of the year, when Nature is awakening from winter's sleep and putting forth all her energies to a new creation. In everything that lives a fresher vigor is infused. The thrill of awakening life influences all created beings, and the subtle forces and energies which mysteriously move us are felt with increasing power. In a fraternity whose great truths are taught by symbols the symbolism of Nature will not be unobserved. As we here take up our duties and renew our responsibilities we must, under the influence of this delightful season, be easily moved to the ready performance of old and the cheerful acceptance of new duties, sustained by the glorious hopes it holds out to us. For the resurrection of Nature is a type of that greater resurrection constantly illustrated in the Master's degree.

I am glad to be able to say that the past year is one on which we can look with considerable satisfaction. A kind and harmonious feeling has predominated. I have not been called upon to exercise any authority except in the mildest way. I know of no serious inroads upon our ranks by Death. Our relations with foreign Grand Lodges continue to be of the most amicable character. For Harmony at Home and Peace with all the bodies of our correspondence we can sincerely return thanks to the Grand Architect of the Universe.

I have appointed Bro. Juan B. Bravo representative of this Grand Lodge at the Grand Lodge of Colon and the Island of Cuba, a vacancy having occurred through the death of our late representative, Bro. Juan F. Prieto. Although the Grand Lodge of Florida is represented at this Grand Lodge, we have had no representative near that body. I have supplied the vacancy by the appointment of M. W. Bro. Robert J. Perry, Grand Master of that State, and he has kindly undertaken the duty. Bro. W. W. Estabrooke, our representative near the Grand Lodge of Iowa, having moved into the State of Illinois, vacated his office, and his place is filled by the appointment of Bro. Z. H. Church, a young and active Mason, and at present Mayor of the City of Jefferson. The Grand Master of Illinois asked for an interchange of representatives. I was glad to be able to cement our fraternal relations with the flourishing body over which he presides, and was still more gratified at the

intimation of the Grand Master that he would be glad to see Bro. Estabrooke, lately our representative in Iowa, appointed. I accordingly issued a commission to Bro. Estabrooke. The Grand Master of Illinois has appointed as his representative here a brother who, I am satisfied, will be heartily received when he presents his credentials. An exchange of representatives has been asked for by the Grand Lodge of Ohio, and negotiations with respect thereto are now pending.

I greatly regret that I had to decline an invitation from the Grand Lodge of Louisiana to represent this Grand Lodge in February last at a gathering of the Craft in the City of New Orleans. The opportunity was taken of the Great Exposition now holding there to bring together many representatives of our fraternity from all parts of the world. My other engagements prevented me from discharging what would have been a pleasurable duty.

We have been formally notified of the death of Bro. Horace Taylor, Past Grand Master of New York; of Bros. James M. Henry and William French, Past Grand Masters of Mississippi; of Bro. Isaac B. Sharp, Past Grand Master of Kansas; and of Bro. Henry Wm. Murray, Grand Master of Masons in Virginia. All of these were not only eminent in their jurisdictions as Masons, but were men of character and station, and were highly respected in the communities in which they lived.

Applications for recognition from bodies of Masons in South Australia, Mexico and Spain have been sent to the Committee on Foreign Relations. while a majority of the regularly constituted Lodges did not submit to it. A principle has been generally recognized by Masonic authorities on this continent that three subordinate Lodges could form a Grand Lodge. This is good enough law when the parent Grand Lodges offer no opposition, where often there are no more than three Lodges, and where the prevailing idea is that a Grand Lodge shall at once be formed and grow up as one of the institutions of a new territory or state. But the case is materially altered when the rule is applied to countries or colonies in which there is a large number of Lodges. It seems an absurdity that in a country where there are say twenty Lodges three of these should be able to set up a Grand Lodge and declare all the other Lodges clandesti- if they do not submit to its authority. Some modification of the rule is necessary which will protect the rights of, perhaps, the majority. The formation of our own Grand Lodge was, I think, consented to at the outset by three-fourths or more of the Lodges in the Province.

The most interesting local event of the year was the celebration on 1st July last of the Centenary of the introduction of Freemasonry into New Brunswick. The arrangements were under the direction of a committee of the Masonic organizations in St. John, and the whole of the proceedings interested not only the fraternity but the public generally. I deemed the matter of sufficient importance to justify the calling of an Emergent Communication; and Grand Lodge had the satisfaction of having present a large representation of the Craft in the Province, and the pleasure of receiving a visit Wimburn Laurie, R. able and eloquent an Orator as the Very Worshipful and Reverend Bro. D. Macrae, D. D., Past Grand Chaplain, whose address can never be forgotten by those who heard it. In this brief reference I must not overlook the services of Bro. J. Macgregor Grant, who, as Mayor of the City, not only participated in the proceedings at the Mechanics Institute, but extended generous and courteous hospitalities to representatives of Grand Lodge and to the eminent visiting Brethren.

Grand Lodge may fairly consider whether the time has not arrived when the Library can be made available to at least some extent. Although we lost all our books by the fire of 1877, some of the more valuable and many of the useful ones have been, under the energetic supervision and management of R. W. Bro. Bunting, replaced, whilst there is a constant accumulation of proceedings and exchanges, of current value, from sister Grand Lodges. These have been cared for and stored by him. Their increase must involve burthens as well as responsibility. Probably an apartment can be found in this building at little or no expense in which the books can be arranged, under the direction of the Library Committee; and, possibly, a small fee paid by those who desire to use the Library would meet all the necessary cost of light and attendance. It would be well for Grand Lodge to instruct the committee definitely. I feel bound to say, however, that this good work cannot be undertaken this year if it imposes any additional burthen on the Treasury of Grand Lodge. At the same time we must all feel that in these days of the general spread of intelligence whatever there is of value in the Library should be made available to the enquiring Craftsman.

To a much less extent than I desired I have been able to visit Lodges in the jurisdiction. In some of those meeting in this Hall the officers were installed either by myself or by the Deputy Grand Master, and they have all been visited either officially or unofficially. I paid an official visit, accompanied by the Deputy Grand Master, a fair representation of the other Grand Officers, and a number of Brethren from Lodges in St. John and from Keith Lodge, Moncton, to Zetland Lodge, Shediac, from the chair of which the Junior Grand Warden was retiring. It gave me much pleasure to again place in the East a true and tried Mason, Bro. Duncan S. Harper, and to renew Masonic fellowship with several earnest members of that Lodge. We were all most heartily and courteously entertained by them, and our visit was one of rare pleasure. This visit gave us opportunity to meet many of the Brethren

at Moncton, where Keith Lodge, under the rule of W. Bro. George M. Jarvis, is now doing most effective work. We spent a day with them, although we held no meeting, visited their new and handsome Lodge room, and saw abundant evidences of their increasing prosperity. I also visited Hiram Lodge, Fredericton, unofficially, accompanied by the Junior Grand Deacon, W. Bro. G. F. Hibbard, and spent a most pleasant evening with the Brethren. A very agreeable visit was that paid to Sussex Lodge, No. 7, St. Stephen. A number of Brethren from St. John accomparied me, and of course we had the personal attendance ... the Senior Grand Warden. We saw the Master's Degree admirably conferred by the officers of the Lodge, and met a large number of the Brethren from other Lodges of our jurisdiction in the St. Croix Valley, as well as many Masons from the neighboring State, including our representative at the Grand Lodge of Maine, Bro. D. F. Seymour. Nothing could exceed the courteous kindness of the Craft at St. Stephen. At my instance the Senior Grand Warden, R. W. Bro. J. T. Whitlock, fraternally undertook to do what I was not able to do myself, visit the other Lodges in the vicinity of St. Stephen. I have received from him a report, from which I make this extract :

Also, G. F. Pinder, P. M., C. H. Smith, Wm. Murray, J. H. Ganong; and James Piper, of Victoria, No. 26. (All the visitors in each case, except Bro. Piper, were from Sussex, No. 7.)

Both meetings were emergencies. There was no work on hand in either Lodge. The records of each Lodge are well kept, and we found the Lodge appointments good in each case and every evidence that the work is conducted in a dignified and impressive

I visit both Lodges frequently, and know they are running pleasantly and do their work well.

It is, I believe, impossible for the Grand Master to visit all the Lodges in the jurisdiction during his term of office, no matter what his desires or hopes may be at the commencement of the year. This has been the experience of all my predecessors. I believe that it would be a great advantage to the Craft, and would advance its interests, if we adopted in this Province the system of District Deputies of the Grand Master which obtains in Nova Scotia, in Quebec, in Canada, in almost all of the States of the neighboring Union. The work of laying off the Province into Districts would not be difficult; the powers given to the District Deputies could be very easily defined; the officer could be elected at each meeting of Grand Lodge, subject to the approval of the Grand Master, by the Brethren from the District. One result would be that in each District there would be some Brother with authority, as representative of the Grand Master, to visit the Lodges, foster a good understanding among them, and quicken their interest in each other. Grand Lodge itself would be better informed as to the standing of and esteem in which the principal Masons in a District are held, and would thus best know whom to honor. Many benefits suggest themselves as arising out of the creation of officers of this kind. I earnestly recommend this to Grand Lodge. If the idea is approved, the matter could go to the Board of General Purposes to next year report the constitutional regulations necessary to carry the scheme into

Lebanon Lodge has failed to make returns for this year, and has practically ceased to exist. I directed the Grand Secretary to make an effort to get it to surrender its warrant, but he was not successful. As, however, there is no probability that it will again resume Masonic labor, I have caused Sussex Lodge, Dorchester, to be notified of the fact, so that it might resume

the territorial jurisdiction of which the establishment of this Lodge deprived it. If any persons there seek Masonic light they should not be kept in darkness because the Lodge is not

I do not deem it necessary to make any detailed statement of the dispensations issued or routine work performed, as this will probably be sufficiently covered by the report of the Grand Secretary. Questions that have arisen have been disposed of as promptly as possible, but none of the decisions given involved such doubtful points as to make it necessary to trouble asked, I have stated that the constitutional amendment of last year had not and cannot have a retro-active effect. The membership rights of Entered Apprentices who were members of Lodges previous to the passage of that amendment are not affected by it. By my direction the Grand Secretary issued a circular to the Lodges, a copy of which is also annexed.

The returns which will be laid before Grand Lodge will show a gain, slight but satisfactory, in membership; and the financial statements will, I think, justify the action of the Board of General Purposes in the matter of the special assessment, particulars of which will, no doubt, be contained in the report of the Board. By that action some relief was afforded the Lodges outside the City of Saint John, without imperilling the ability of Grand Lodge to meet the interest and principal of its bonds. On the other hand, the ordinary revenue fund of Grand Lodge is not in a satisfactory condition. It is really charged with a heavier burden than it can bear. In time it will work itself clear, but now the interests of the Craft suffer. The principal charges upon it are \$500 a year for redemption of bonds, \$275 interest, and Grand Secretary's salary, \$400-a total of \$1175 against receipts of say \$1280, leaving about \$100 only for all other services. For four or five years the fund has carried a debt of five hundred dollars, which at the present time there is no way to pay. This amount might be permanently funded, and a little would be saved in interest. I fear, too, that a reduction in the Grand Secretary's salary is inevitable, although I am loth to make such recommendation, for the Grand Secretary has a good deal of work to do, and he does all his work faithfully and promptly. But we must look the situation in the face. One-third of our ordinary revenue is applied to the payment of this salary. While many Grand Lodges pay a much larger salary, I know of none that pays so much proportionately to revenue. In view of the present situation Grand Lodge must ask itself what it can fairly do with justice to all interested.

Connected with this matter is another. Practically Grand Lodge is the controlling owner of the building in which we

Receivents amount to \$1720, a gain in the year of about spon southis as not sufficient to pay the interest on the outlay salthough the situation has greatly improved, for income and expenditure are nearer now than ever they were before. Grand Lodge will not have to impose any fresh burdens of paration on account of the building, while it will continue to reduce the burden of debt. The question may now be asked should it not grapple with the whole debt, the first as well as the second issue of bonds? Is it well to accumulate money at four per cent. while it is pinching itself to pay seven or even six? The debt borne by the general revenue is a debt incurred for the building, and must be as sacredly cared for by Grand Lodge as the debt more recently created. I am fully convinced, therefore, that, if not this year, at a very early day Grand Lodge will find that the true course to pursue will be to abolish the distinction between the two funds, consolidate the debt, and make it a first charge on the whole revenue. I recommend this to your earnest consideration, reminding you that the primary object of the taxation levied in 1882 was to ensure to the Craft the possession of this fine Hall beyond all doubt, and I am convinced that Grand Lodge or her subordinates will not ask any further reduction of that taxation than is suggested this year until such a desirable result is accomplished. A slight advance in the rents now realized and the reduction of the mortgage to the capital sum of twenty thousand dollars are two things to be earnestly desired. Of the ultimate value of this fine property, situated as it is in the heart of a district that, despite present drawbacks, must constantly increase in wealth and population, I have never had

Arrangements have been made by the Ritual Committee for an exemplification of work at this communication, and the Worshipful Master of Hibernia Lodge has kindly placed his Lodge at the disposal of Grand Lodge for the purpose.

To the consideration of all the matters which come before us, Brethren, let us bring calm judgment, doing nothing hastly, nothing unnecessarily, but everything in a proper institution, whose chief object is the cultivation of a feeling of misunderstood and sometimes severely condemned. It is at empire, as in many other parts of the world, this society makes

peaceful progress. What better answer can be made to the foolish charge preferred against us of antagonism to sound systems of government than that the Grand Master of England, the future ruler of the nation, as Master of the Alpha Lodge, London, on the 17th March last initiated his eldest son into our fraternity, performing the ceremony himself with all the skill of a bright Craftsman. In Freemasonry there is no distinction of persons, and prince and peasant stand upon the same level, but the prince who actively labors to promote a knowledge of the tenets of our profession among men of his own rank and family not only teaches us a lesson, but unmistakably establishes his recognition of the fact that the security of the throne, the safety of the state, are increased as men base their lives and actions upon the principles of the Masonic brotherhood.

On motion of W. Bro. T. Nisbet Robertson it was

Resolved, That the Address of the Grand Master be referred to a Special Committee to report upon the several subjects contained therein.

Whereupon the following Brethren were appointed such Committee: R. W. Bro. James McNichol, Jr., D. G. M., W. Bro. T. Nisbet Robertson, W. Bro. William J. Logan, W. Bro. A. F. Street, W. Bro. John D. Chipman.

The Grand Secretary called the roll of Grand Representatives. The following Grand Lodges were represented: Arkansas, Canada, England, Florida, Indiana, Ireland, Louisiana, Mississippi, New York, Nova Scotia, Quebec, Scotland, Tennessee, Wisconsin, Wyoming.

The Grand Secretary (Representative of the Grand Lodge of Louisiana) read a circular he had received from the Grand Lodge of Louisiana containing a series of resolutions, which he asked Grand Lodge to consider at this session.

On motion of R. W. Bro. B. Lester Peters, P. G. M., it was Ordered, That the circular be received and laid on the table. R. W. Bro. James McNichol, Jr., Representative of the Grand Lodge of Ireland, stated that he had communicated with the Grand Lodge of Ireland concerning the Old Warrants. That the Warrant of Hibernia Lodge had never been received by the Grand Secretary of Ireland.

The R. W. the Deputy Grand Master, as President of the Board of General Purposes, submitted the Annual Report of the Board, as follows:

#### REPORT OF THE BOARD OF GENERAL PURPOSES.

#### MASONIC HALL, ST. JOHN, N. B., 22nd April, A.D. 1885.

23

In submitting their Annual Report for 1884-85 the Board of General Purposes have very great pleasure in congratulating Grand Lodge on the continued harmony and prosperity of the Craft within the jurisdiction. The various Lodges, in a true spirit of emulation, are endeavoring to perfect themselves in the ceremonial work as authorized by Grand Lodge.

The harmonious and fraternal spirit which has prevailed throughout the jurisdiction in the past twelve months has rendered the labors of the Board comparatively light, no disputes of any kind having arisen requiring settlement by the Board, either between Lodges or Members.

At a meeting of the Board held on the seventh day of May, immediately following the termination of the last Annual Session of Grand Lodge, the Board proceeded, as usual, to the work of organization, and by a unanimous vote elected Worshipful Brother T. Nisbet Robertson Vice President for the current term.

A regulation was adopted by which it was agreed to hold the regular meetings of the Board on the first Wednesday in August, November, February and April.

Brother Charles Masters having been elected Grand Treasurer, it was ordered that the funds of Grand Lodge be deposited in the names of B. Lester Peters, James McNichol, Jr., and Charles Masters.

The M. W. the Grand Master having submitted, in accordance with a resolution of Grand Lodge, a design adopted for a Centennial Medal, the Board approved of the same, recommended the Grand Master to adopt it, and, pending the action of Grand Lodge, to allow the Medal to be worn by all present Members of the Craft, and by all who may be admitted during the centennial year.

In consequence of an understanding arrived at in Grand Lodge at the last Annual Session, the Board placed in the hands of a sub-committee the whole question of the Special Assessment, and, after a careful consideration, they submitted

the following report, which was received and adopted by the Board:

To the Board of General Purposes of the Grand Lodge, F. & A. M.

Your committee have taken into consideration the whole question of the Special Assessment matter, as instructed by the Board, and beg to report as follows :

Not only has all the interest upon the bonds to the 1st August, 1884, been paid, but the principal sum has been reduced some \$1,500. leaving a balance of the bonds of \$8,500, of which \$1,000 matures on the 1st August, 1886. At that date there will be required this sum of \$1,000 and the interest maturing meantime upon the \$8,500, being \$510 per year, or for the two years \$1,020 of interest, and \$1,000 of principal, in all \$2,020.

These being our requirements, we have carefully considered the income likely to arise, and feel gratified to be able to make a recommendation that the assessment upon all Lodges outside of the City of St. John shall be reduced *twenty* cents per Member, the other Lodges being assessed as formerly.

Upon the basis of membership as per the last returns this will produce \$1,114.20 per year, or for the two years \$2,228.40, thus :

which will leave a surplus of \$208.40 after payment of our maturing obligations to August 1st, 1886.

Your committee are of opinion, therefore, that this Board might take the responsibility of directing the Grand Secretary to collect from the various Lodges for the present year the per capita tax as above mentioned, and that Grand Lodge be advised to remit twenty cents per Member, the balance of the assessment, to the several Lodges.

As this recommendation is made upon the basis of the membership of last year, and as the membership from year to year is liable to fluctuate, your committee feel strongly that it would not be advisable for Grand Lodge to abandon any of the present provisions of assessment for providing funds to meet their obligations so long as any of them are outstanding, as it might be found necessary at some future time for Grand Lodge to exercise its full power in regard to the same. If, however, it should be found safe in the future to make any further reduction in the assessment, it could be done upon the plan recommended by your committee, or upon some similar plan, as the then existing circumstances should suggest.

In conclusion, your committee feel that this recommendation reflects the spirit and feeling of Grand Lodge in this regard, as showing an unwillingness to levy more than her requirements

demand, and though, in case the recommendation be adopted and acted upon, the relief will only extend for the present to a portion, yet we trust that the remaining Members of the Craft will heartly enter into the efforts of Grand Lodge, as all have done in the past, and that the same loyal feeling that has characterized the Craft in the past, and saved to Grand Lodge the Temple of which we are so justly proud, will prevail, so that in the near future Grand Lodge may occupy that flourishing position that we all so anxiously

desire.

From the Report it is apparent that of the twenty Lodges holding Warrants from the Grand Lodge of England, seven holding Warrants from the Grand Lodge of Ireland, and six holding Warrants from the Grand Lodge of Scotland, within the Colony of South Australia, all except three have become Subordinate Lodges under the Grand Lodge of South Australia. The greatest care appears to have been taken in every step towards establishment of this Grand Lodge to comply with the recognized methods of establishing Grand Lodges. The Committee felicitate the Brethren of South Australia on the great Masonic harmony which has been secured at so early a date in the history of their Grand Lodge, and are much gratified to observe the fine Masonic sentiment of the speeches delivered from time to time during the proceedings by the Brethren who have been selected to fill high positions in the Craft and who occupy distinguished judicial and public offices in the Colony of South Australia, and rejoice that the Grand Lodge of South Australia enters upon its career of usefulness under so favorable auspices.

The committee recommend the following resolution:

Resolved, That the Grand Lodge of Free and Accepted Masons of New Brunswick with much pleasure fraternally recognizes the Grand Lodge of Free and Accepted Masons of South Australia, and extends Masonic welcome to her within the sisterhood of Grand Lodges.

#### THE FEDERAL DISTRICT OF MEXICO.

The Committee regret that as yet Masonry in the Republic of Mexico is in a very unsettled state, and while sympathizing with every effort that may be made to secure in Mexico one Grand Lodge in each State having exclusive Masonic jurisdiction, and somewhat inclined to believe considerable advance is being made in this direction, the Committee do not feel there is safety at this Communication of Grand Lodge in extending recognition to the Grand Lodge of the Federal District of the United States of Mexico, without further information in the matter. And the Committee submit the following resolution:

The Committee are in hearty accord with the Grand Master in reference to the appointment of District Deputy Grand Masters, and would recommend the following Resolution for adoption by Grand Lodge:

The Committee are gratified to know that there has been an increase in the membership of Grand Lodge during the past year, but they regret to learn that the ordinary revenue of Grand Lodge is not in a satisfactory condition. The Committee have given much consideration to this portion of the Address of the Grand Master, and entirely concur with him in the remark that the ordinary revenue is charged with a heavier burden than it can bear. After a careful and serious review of the situation the Committee are reluctantly forced to the conclusion that, for a time at least, a reduction must be made in the salary of the Grand Secretary. The Committee therefore recommend that from and after this session of Grand Lodge the salary of the Grand Secretary be fixed at \$200 per annum.

The Committee would not recommend that the floating debt of Grand Lodge be funded, as they believe that in a few years it can be paid off.

The Committee entirely concur with the Grand Master in reference to the advisability of consolidating the bonded debt of Grand Lodge and placing all the funds in one general account. They therefore recommend that Grand Lodge adopt the following Resolution :
