Grand Master's Address.

To the Officers and Members of Grand Lodge:

BRETHREN,--- By permission of an all-wise and over-ruling Providence, we are permitted to assemble on this the twenty-first anniversary of the establishment of this Grand Lodge. We rejoice that many of the Brethren who then attended, and by their counsel and advice materially assisted at the formation, are yet with us and active in our deliberations, but others whom we honored and revered have been called away.

Brethren, while we have been thus permitted to continue our labours here - we know not for how long - let us all, therefore, look humbly to Him who directs the affairs of men for constant aid and support, faithfully fulfilling our allotted tasks, each Brother feeling that the honor, welfare, and prosperity of the Craft largely depends upon his individual life and action.

During the twenty years existence of this Grand Lodge there has been a slow but steady growth of the Order. At the time of its formation there was a membership of 1,312. From this number there has been a steady increase, until at the present we have on our roll (as will appear by the Grand Secretary's report) a membership of 1,833. During this time there has been a very large increase by Initiations and Affiliations, which, I regret to say, has been materially reduced by Withdrawals and Suspensions. This question of suspension for non-payment of dues has engaged the attention of Grand Masters from time to time, but for so far without much apparent effect. I trust, however, that the various Lodges throughout the jurisdiction will give the matter their best and most careful attention, with a view to retaining their membership as far as possible.

In this jurisdiction we have to mourn the death of a number of our members. I find by reference to the returns at the Grand Secretary's office that there has been during the past year seventeen deaths reported, among whom I find the names of Past Masters James Moffat and William McNichol.

Brother Moffat had been for many years an active and honoured member of Restigouche Lodge, No. 25, having been initiated on the 15th of April, 1873. He departed this life on the 7th September last, and was interred by his Lodge with Masonic honours.

Brother McNichol, who was called suddenly away by death on the 29th September, 1887, was initiated September, 1858, in Hibernia

Lodge, No. 3, (then on the Registry of the Grand Lodge of Ireland). He was elected to the position of Worshipful Master of that Lodge in 1864-65. Brother McNichol was one of the original members of New Brunswick Lodge, No. 22, at its organization in February, 1866, and continued an active member until the time of his death.

From the Grand Lodge of New South Wales we are apprised of the death of R. W. Brother Nicholas Weeks, who held the position of Grand Secretary from the inception of that Grand Lodge until the day of his death.

The Grand Lodge of Scotland and our Grand Lodge are called upon to mourn the death of an esteemed and distinguished Brother, in the person of R. W. Brother Alexander Hay, Past Grand Jeweller of Scotland and the Representative of the Grand Lodge of New Brunswick at the Grand Lodge of Scotland, whose demise took place at his residence, Edinburgh, Scotland, on the first day of March, ultimo. It was principally through the kind interest and wise counsel of our deceased Brother that the complications confronting us at the outset of our career as a Grand Lodge in securing recognition from the Grand Lodge of Scotland were happily solved, and the pleasant and fraternal relations established between the two Grand bodies, which have continued uninterrupted to the present time.

Brother Hay was appointed the Representative of New Brunswick at the Grand Lodge of Scotland in the year 1873, and at the Annual Communication held in September of that year was created a permanent member of our Grand Lodge, with the honorary rank of a Past Junior Grand Warden, a distinction he highly prized, and which he acknowledged in the following words, written to the then Grand Secretary: "I now enter upon the duties of my office, and beg you will assure the M. W. the Grand Master of New Brunswick of my deep sense of the honor conferred upon me, and it shall be my duty to discharge to the utmost of my ability the duties of my office, thereby, I trust, cementing a true fraternal friendship between the two Grand Lodges." That he faithfully and honorably fulfilled the pledge then made is amply evidenced by his subsequent acts, not only within the portals of the Grand Lodge of Scotland, but also in his public and personal intercourse with the executive officers of this Grand Lodge and of any of the brethren of this jurisdiction having occasion to visit Edinburgh. During an extended membership in the Craft of forty years, our distinguished Brother was actively engaged in an incessant round of duty in the work and labor of his Grand Lodge. He was thoroughly alive to the best interests of the Craft he so intensely loved; possessed an intimate knowledge of the constitutions and usages of Freemasonry; was widely known throughout

the various Masonic jurisdictions, and will, no doubt, be sincerely mourned by all who have been favored with his friendship. It would be far beyond the limit of space allowed in this address to recount a tithe of the fraternal acts with which he favored us. I, however, may be permitted to state that he contracted for, and superintended, the engraving of the copper plate of the certificates of membership in this jurisdiction, and generously undertook the custody of the plate, which remained in his hands up to the time of his death, and whenever any impressions were needed he always attended to the printing and mailing of them. In the demise of our dear Brother we, who survive, are solemnly reminded of "how swiftly the sands run and how rapidly our lives are drawing to a close," and that we, too, "must soon be cut down by the all-devouring scythe of time, and be gathered into the land where our fathers have gone before us."

I would suggest that Grand Lodge, by resolution or otherwise, give expression to the heart-felt sorrow we all experience in the great loss sustained by the death of our R. W. Brother, and that a page of the records and of the published proceedings of Grand Lodge be devoted to his memory.

R. W. Brother James Webster, an accomplished Craftsman, has been recommended for appointment to the position made vacant by the death of our late lamented Brother Hay, and I have with pleasure appointed him our Representative near the Grand Lodge of Scotland, and would recommend that Grand Lodge constitute him a permanent member of Grand Lodge, with the rank of Past Junior Grand Warden.

There has been received at the Grand Secretary's office, from the Grand Lodge of New Jersey, a commission appointing R. W. Brother E. Lee Street, of Newcastle, as Representative of that Grand Lodge near the Grand Lodge of New Brunswick, in place of Brother Robert R. Call, who had been formerly appointed, but failed for some reason to present his credentials officially to Grand Lodge.

In accordance with the resolution of Grand Lodge at the last Annual Communication, certificates of indebtedness to the amount of \$5,000 have been issued in payment of stock subscribed for in the New Brunswick Masonic Hall Company. Further particulars as to dates of payment, etc., will be found by referring to the report of the Board of General Purposes.

Since our last Annual Communication the commodious and well appointed Hall owned and occupied by Zion Lodge, No. 21, at Sussex, was, with the greater part of its contents, destroyed by fire. I am happy to say, however, that the Lodge very wisely carried an amount of

insurance, which will go a long way in restoring them to their former position. In connection with this matter, I would most respectfully urge on the several Lodges in the jurisdiction the great desirability of being fully insured.

Several of the Lodges having applied for dispensations for various purposes, I felt warranted and was pleased to comply with their requests, feeling that they were actuated by a desire to advance the cause of Masonry, while at the same time improving their own position. Among those granted were several permitting Lodges to wear regalia while attending divine service.

On the 24th July last I had the pleasure of attending a service of this kind at Saint George's Church, where the Brethren of Carleton Union Lodge, No. 8, with many others, listened to a practical and instructive discourse from the Rector, the Rev. O. G. Dobbs.

I also attended with Hibernia Lodge, No. 3, on Sunday, December 18th, at Calvin Church, where the Craft and others present were edified and instructed by a sermon delivered by Brother the Rev. Alexander McDougall, Chaplain of the Lodge. This is a practice which I think might with profit be generally adopted by the Craft.

When advice has been asked by Lodges in reference to constitutional questions, answers have been freely given; but nothing of a very important nature having been presented, no official decision was called for. In many cases I preferred to leave the question at issue with the Worshipful Master of the Lodge, firmly relying on his knowledge of the Constitution, and a desire to do that which would be just and lawful.

It affords me pleasure to be able to report that the most friendly relations continue to exist between this Grand Lodge and the other jurisdictions with whom we are in fraternal communication.

By reference to the accounts of the Grand Treasurer, it will be seen that the finances of Grand Lodge are in a very easy and satisfactory condition, all demands on our treasury having been promptly met.

The past year has been rather an uneventful one in Masonic circles in this Province, and as a consequence there is nothing of much importance to report. I am pleased to say, however, that the Craft are enjoying a moderate degree of prosperity, and that peace and harmony prevail.

The Library Committee have kept the rooms open for the use of the Craft, but I regret to say that not very much use has been made of it. This state of affairs is regrettable, as there are many valuable works on Masonry, a perusal of which would be of inestimable benefit to the active Mason.

Brethren, in reference to the finances of the Masonic Hall Company. a very full and complete report was made by R. W. John V. Ellis, P. G. M., at the last annual meeting of Grand Lodge. I desire by your permission to again call your attention to this matter. The income derivable from the various parts of the building is now equal to the ordinary outlay, but the Directors who have the management of the property were compelled to incur an indebtedness in putting on a new roof, and otherwise making the premises tenantable. As, however, the property is practically in the hands of Grand Lodge, as custodians for the entire Craft in this jurisdiction, I confidently make an appeal to the members of the various Lodges throughout the Province for a voluntary contribution towards this object, with a view to placing the Directors in a position to pay off the floating debt, after which I confidently hope that the revenue will for the future be sufficient to meet ordinary expenses. A contribution of one dollar from each member of the Craft would far more than clear off all outstanding liabilities. Brethren, is it asking too much to request you to do this? I would ask Grand Lodge to consider this matter, with a view to placing it before the members of the several Lodges.

It has been my privilege and pleasure to make a few official visitations, but I exceedingly regret my inability to visit (as I felt it my duty to do) the several Lodges in the jurisdiction. After accepting from you the responsible position of Grand Master, circumstances over which I had no control occurred, which entirely prevented me from performing what I would otherwise have felt to be a pleasant and agreeable duty. However, I am pleased to say that what I was unable to do has been well and faithfully attended to by the District Deputy Grand Masters in their several jurisdictions.

Accompanied by a large number of the Brethren, who very kindly attended as Grand Lodge Officers, I installed the Worshipful Masters of Albion Lodge No. 1, Saint John's Lodge No. 2, Hibernia Lodge No. 3, Union Lodge of Portland No. 10, New Brunswick Lodge No. 22, and Sussex Lodge No. 7. On the 6th September, by invitation of the Deputy Grand Master, J. T. Whitlock, Esq., I visited Saint George Lodge No. 7, where the M. M. degree was exemplified in a very superior manner, R. W. Brother Whitlock presiding as W. M.

I also visited Midian Lodge, No. 9, Clifton, accompanied by several of the Brethren, who conferred the M. M. degree on a candidate; Past Master Thomas Walker, of Albion Lodge, No. 1, occupying the chair in his usual well known and excellent manner, the other Brethren filling their respective offices most creditably. At all these meetings we were most kindly received. 1888] GRAND LODGE OF NEW BRUNSWICK.

Report of Grand Secretary.

THE V. W. the Grand Secretary presented his Annual Report and Account with Grand Lodge, as follows:

To the Grand Lodge of Free and Accepted Masons of New Brunswick:

The Grand Secretary herewith submits his Annual Report and Account to April 24th, 1888.

1. The receipts of my office for the year just ended amount to two thousand three hundred and eight dollars and ninety-three cents. The amount has been paid in full to the Grand Treasurer and an account in detail furnished the Committee appointed by the Board of General Purposes to audit the books of Grand Lodge.

2. The returns for all the Lodges have been received and payments have been made in full, with the exception of a small balance due by one Lodge.

3. Eighteen Dispensations have been issued during the year, under the authority of the M.W. the Grand Master, as follows:

One hundred and thirty-three Certificates were issued from the office to Brethren entitled to them under the Constitution.

5. St. Martins Lodge, No. 30, has notified me of an alteration in the by-laws of the Lodge, whereby the day of the regular meeting is changed from the first Wednesday to the first Saturday.

I also received notice from Campbellton Lodge, No. 32, of an alteration in the by-laws of their Lodge, making the regular night of meeting the first Thursday in each month, instead of the first Friday.

Approved of by the M.W. the Grand Master.

6. July 22, I received from the Grand Lodge of New South Wales notice of the death of R. W. Brother Nicholas Weeks, Grand Secretary of that Grand Lodge. Brother Weeks was a very able officer. He held the position of Grand Secretary from the inception of that Grand Lodge until the day of his death.

7. July 22, I received a circular from the Grand Lodge of Connecticut, dated 18th July, setting forth that at a special meeting of Grand Lodge the charter of Hiram Lodge, New Haven, had been revoked and the officers expelled from Masonry for unmasonic conduct, and wishing the Craft to govern themselves accordingly.

8. August 10th, a commission was received from the Grand Lodge of New Jersey, appointing R. W. Brother E. Lee Street Representative of that Gand Lodge near the Grand Lodge of New Brunswick; signed by R. M. Moore, Grand Master; Joseph H. Hough, Grand Secretary.

9. August 26th, I received from the Grand Lodge of Iowa, by Bro. S. F. Matthews, of Lodge No. 22, a bronze medal for presentation to Grand Lodge, which was suitably acknowledged.

10. November 10th, I received notice of the formation of a Lodge of Instruction (called Emulation Lodge) on the 31st October, regular meetings to be held every Monday evening, under the direction of R.W. Bro. Wm. F. Bunting, P. G. M., as Preceptor,

11. March 24th, 1888, received a letter from R. W. Bro. D. Murray Lyon, Grand Secretary of Scotland, announcing the sad news of the death of R. W. Brother Alexander Hay, on the 1st March. Bro. Hay was Representative of the Grand Lodge of New Brunswick. Our thanks are due to the Grand Secretary of Scotland, R. W. Brother D. Murray Lyon, for his kindness in offering his services to attend to any business that the Grand Lodge of New Brunswick might require to be looked after.

12. A commission has been issued, by direction of the M. W. the Grand Master, under the Seal of Grand Lodge, appointing R. W. Bro. James Webster, of Edinburgh, our Representative near the Grand Lodge of Scotland.

All these communications are on the table for the information of Grand Lodge.

14. There has been a large amount of correspondence with Lodges in connection with the Craft, but none of it is of sufficient importance to refer to specially.

IN the absence of the R. W. the Deputy Grand Master, President of the Board of General Purposes, the Vice-President, V. W. Bro. Charles Masters, Grand Treasurer, submitted the Annual Report of the Board, as follows:

To the Grand Lodge of Free and Accepted Masons of New Brunswick:

Report of District Deputy Grand Master No. 1.

R. W. Bro. John D. Short, District Deputy Grand Master No. 1, submitted his Annual Report as follows:

M.W. Grand Master of the Grand Lodge, F. & A. M. of N. B.

During the year which has passed since my appointment as your Deputy, I have visited all the Lodges in Masonic District No. 1, and found them all in a very satisfactory condition.

At the regular Communication in July, I visited Midian Lodge, No. 9, at Clifton, and assisted at the initiation of a candidate. I have much pleasure in reporting that I found an excellent feeling prevailing in this Lodge, which, although few in numbers, holds its meetings quite regularly, and has a prospect of considerable work in the future.

Report of District Deputy Grand Master No. 4.

To the Most Worshipful the Grand Master, Officers and Members of the Grand Lodge of New Brunswick :

MOST WORSHIPFUL SIR AND BRETHREN:

I have the honor to submit my Report as to the condition of the Craft in No. 4 District.

I have officially visited each of the Lodges in this District during the past year.

In the absence of any constitutional provision for the creation of the office of District Deputy Grand Master, the duties and powers belonging to the office I found to be extremely limited; the only privilege that I could at all discover was that I was expected to visit the Lodges in my jurisdiction, and report on their condition. I do not think that there is

any question as to the benefit to be derived by the Craft in general from the creation of this office, and I would urge upon Grand Lodge the necessity of at once making constitutional provision defining the duties. powers, and prerogatives belonging thereto.

BENJAMIN LODGE, No. 31.

On Tuesday, the 4th of October last, being the regular meeting of this Lodge, accompanied by W. Bros. Alfred F. Street, Harry Beckwith and James D. Fowler, I visited this Lodge.

I found the Lodge in a flourishing condition financially. They own their own Hall, with considerable real estate adjoining, and are free from debt.

The W.M. conferred the First Degree. In consequence of the distance between this and the nearest Lodge, the officers have not the opportunity of perfecting themselves in the work as well as I could wish. I think a Lodge of Instruction to last about a week would be a great benefit to this Lodge, and I am sure would be highly appreciated. I could not spare the time on the occasion of my visit. I exemplified the three Degrees.

There was a large attendance of the members of the Lodge, one Brother having travelled fourteen miles to attend this meeting.

The Lodge books are well kept, the monthly dues are promptly paid, and there are few suspensions.

WOODSTOCK LODGE, No. 11.

In company with W. Bro. Alfred F. Street, I visited this Lodge on its regular meeting in October. There was a large attendance of the Brethren, although some prominent members were conspicuous by their absence.

This Lodge has a large membership, and a good average attendance. The First Degree was conferred in a very creditable manner. The work as understood by the officers is always well done in this Lodge, but it requires considerable pruning before it is in harmony with the Ritual as adopted by the Grand Lodge of New Brunswick.

As has been justly observed by my predecessor in office, the Lodge books are perfection.

ALEXANDRIA LODGE, No. 33.

I visited this Lodge at its regular meeting in January, accompanied by W. Bros. S. H. McKee, Harry Beckwith, James D. Fowler, and Bros. William Lockhart, J. Foley Parker, James A. Robinson, and James H. Hawthorn, and installed the officers elect.

Owing to a large number of the members of this Lodge being in the employ of the New Brunswick Railway, they find it extremely difficult to secure a large attendance at the regular meetings. Consequently the Lodge does not flourish as well as under more favorable circumstances it might do; however, the meetings are held regularly, the Lodge books are well kept, and the Lodge business properly attended to.

HIRAM LODGE, No. 6.

At the regular meeting in January, I attended this Lodge and installed the officers elect.

At the regular meeting in February, accompanied by W. Bros. James Simmons, Albert Boone, Whitman Brewer, and John Hall, of Alexandria Lodge, I again visited this Lodge. The W. M. conferred the Third Degree.

The Lodge books are well kept, and the cash paid over promptly. The location of their Hall is a great drawback to this Lodge.

On the whole I have to report favorably on the condition of the Craft in this District. I have endeavoured to impress upon the Lodges the necessity of promptly collecting the Lodge dues, and that should any Brother be unable to pay, to remit his dues from time to time until he becomes able,—that being, in my opinion, the surest way of avoiding suspensions and of insuring a larger attendance at our Lodge meetings.

This is the first year that all the Lodges have been visited by an officer of the Grand Lodge. I feel that to discharge the duties of the office properly, one visit is not enough. The next District Deputy Grand Master, whoever he may be, will no doubt feel it to be his duty to make his visits more frequent, as by this means he will promote a spirit of emulation among the officers of the different Lodges in his District, which I am persuaded will be for the lasting benefit of the Craft.

All the Lodges show an increased membership over last year, except St. George, No. 12, which holds its own, and St. Mark's, No. 5, which shows a decrease of nine, caused almost entirely by suspensions for non-payment of dues. Still, notwithstanding this large loss, I am able to report a net gain of four in the District.

• All the Lodges in the District are in a very satisfactory condition, and the prospects for the coming year are highly encouraging.

It has been my sad duty to officiate at the burial of Bro. Grearson, of St. George Lodge, No. 12, and Bro. James H. Ganong, of Sussex Lodge, No. 7, whose sudden and unexpected death, on April 21st, has spread a deep gloom over the whole community, particularly among the members of the Craft, by whom he was highly esteemed for his many good gualities.

Before retiring from office it affords me much pleasure to tender my sincere thanks to the Craft in District No. 5 for the hearty support extended to me at all times during the past two years in the discharge of my duties as District Deputy Grand Master, and I congratulate Grand Lodge on the prosperous condition of the Craft in Charlotte County.
