PURSUANT to notice, a Special Communication of the Grand Lodge of the Ancient and Honorable Fraternity of Free and Accepted Masons of New Brunswick was held in the Masonic Hall, Moncton, on the 16th day of June, A. L. 5891, at half-past two o'clock in the afternoon, with the following actual and acting officers

Grand Lodge was opened in ample form at half-past two o'clock, the M.W. the Grand Master in the East.

The Grand Master addressed Grand Lodge as follows:

A request having been received from R.W. Bro. Geo. R. Sangster, that the corner stone of a Church which he is now erecting in Moncton might be laid with Masonic honors, I have convened this Special Communication of Grand Lodge for that purpose. It has afforded me much pleasure so to do, that we might testify to our appreciation of the munificent gift which our esteemed brother has made in the cause of religion and to the glory of God.

By direction of the M.W. Grand Master the Grand Secretary read the note of invitation from Bro. Sangster, as follows:

MONCTON, N. B., June 2, 1891.

Most Worshipful Grand Master:

The Methodist people of this city for some time have been considering the desirability of extending their Church borders.

In order that their views may be carried out, I have decided to erect a building to be set apart for the worship of Almighty God, under the discipline of the Methodist Church in Canada.

As the builder and donor of the Church, I beg to request that the Grand Lodge of the Ancient and Honorable Fraternity of Free and Accepted Masons of New Brunswick will lay the corner stone with Masonic ceremonial.

All the necessary arrangements having been completed the M.W. the Grand Master vacated the East and gave directions to the W. Grand Director of Ceremonies to take charge of the Craft and form the order of procession.

The line of march was along Main Street to Highfield, where a halt was made at the residence of Bro. Geo. R. Sangster. The Grand Director of Ceremonies entered and met Bro. Sangster, the founder, as well as Messrs. N. L. Rand and O. S. McCully, two of the Trustees. Addressing them he said: "The Most Worshipful Grand Master of the Grand Lodge of the Ancient and Honorable Fraternity of Free and Accepted Masons of New Brunswick, having received your request to lay the corner stone of your Church according to the ancient ceremony of the Craft, is now ready to perform that duty. He respectfully requests you to proceed with him, and has directed me to conduct you to your place in the procession."

They were assigned a place in the procession with Grand Lodge. The Craft then proceeded to the site on St. George Street, where the lines opened, permitting the Grand Lodge to first reach the spot. Surrounding the lot, and in the immediate vicinity, hundreds of interested spectators viewed the proceedings.

The Grand Lodge officers took up their positions on the platform and the ceremony commenced.

The M.W. the Grand Master having announced that the Grand Lodge had assembled for the purpose of laying the corner stone of the Wesley Memorial Church, he directed all present to preserve order.

The choir sang:

"Hail Masonry Divine."

R. W. Bro. Sangster addressed the Grand Master as follows:

It gives me great pleasure, Most Worshipful Grand Master, to know that you have so kindly consented to accede to my request to lay the corner stone of this building. I have, therefore, unfeigned satisfaction in presenting you with this trowel to be used for the purpose of spreading the cement in which the corner stone is to be laid.

Grand Master Walker, in reply, addressing Right Worshipful Brother Sangster, said that it was on his kind invitation that the Craft had consented to participate in the ceremony. It was a part of the duty of the Craft to lay the foundation stone of a building devoted to such a noble purpose as this was intended — to further the cause of the Almighty and charity. It was a satisfaction to him to respond to the invitation because the edifice to be erected was to be dedicated to the service of God, who had put it into the heart of such a noble brother to devote of that, which the Creator had so generously bestowed upon him, a share to magnify His Holy Name. He hailed with satisfaction the opportunity to comply with the request, and hoped that the work thus started out so auspiciously would be the means of bearing great fruit and of good in the community.

The trowel was of solid silver, bearing the following inscription:

Presented to

THOMAS WALKER, M. D.
Grand Master Freemasons N. B.
On the laying of the Corner Stone
of the
Wesley Memorial Church,
Moncton, N. B.

June 16th, 1891.

The corner stone was then laid in due and ancient form.

The choir sang:

"Master Supreme, accept our praise."

The V.W. the Grand Chaplain made a short address, and pronounced the benediction.

The M.W. the Grand Master gave directions to the W. Grand Director of Ceremonies to take charge of the Craft. The order of procession was again formed, and the brethren marched back through several of the streets to the Masonic Hall.

The M.W. the Grand Master resumed his station in the East and called Grand Lodge to order. He expressed in warm terms the very great satisfaction he experienced in witnessing so large an assemblage of the Craft taking part in the interesting ceremonies just completed. He thanked the officers of Grand Lodge and members of the several Lodges who had come to assist in the ceremonies in answer to the call issued by his direction.

The Grand Master said that he had called this Special Communication for the purpose of attending Divine Service at Centenary Church, it being the Festival of St. John the Baptist, the V. W. the Grand Chaplain having kindly offered to preach the sermon on this occasion.

Grand Lodge was then called off. The W. Grand Director of Ceremonies was instructed by the M.W. Grand Master to take charge of the Craft. A procession was then formed under the banners of Grand Lodge, with the following Lodges in attendance:

The procession moved along Germain Street to King, thence to Prince William Street, up Duke Street to Charlotte and over it to Princess Street to Centenary Church, where the lines opened and Grand Lodge passed through, the subordinate Lodges then following. The members of the Craft occupied the central pews in the edifice, while the galleries and the rest of the space were left for the general public. Centenary choir was largely supplemented, and there were over thirty voices uniting in the singing, with Miss Hea at the organ.

The exercises began by the singing:

Praise God from Whom all blessings flow, the Fusiliers' Band assisting. The hymn commencing: Oh, thou eternal word,

followed, and the prayer was offered by V. W. Rev. G. M. Campbell, who was clad in official regalia.

A quartette composed of Bros. W. H. Horn, Marston Guillod, George B. Hegan and D. Millar Olive, sang "Remember Now Thy Creator," and the preacher read the first lesson from 1st Kings, v. The 30th chant, "Praise the Lord," was rendered, and the second lesson from 1st Corinthians, xiii., was read. Hymn 789 was then sung:

How good it is to dwell in peace.

Grand Chaplain Campbell selected his text from Amos i., 9th verse: "And remembered not the brotherly covenant."

His sermon was both eloquent and instructive, and was listened to with the greatest attention by all present.

The choir sang the anthem, "Send Out Thy Light." The offertory was for the Masonic Relief Fund.

Hymn

God of Jacob by Whose hand,

followed, and the Rev. Grand Chaplain pronounced the benediction.

The procession was re-formed; as the rain was falling heavily, the route of march was directly to the hall via Princess and Germain Streets.

The M. W. the Grand Master resumed his seat in the East and called Grand Lodge to order. He thanked the Officers of Grand Lodge and the Craft for their hearty response to his call on this occasion.

R. W. B. Lester Peters, P. G. M., moved, seconded by R.W. Robert Marshall, P.G.M., a vote of thanks to the Grand Chaplain for the able and instructive discourse with which he had favored them, which was passed by a standing vote, and tendered to the V.W. the Grand Chaplain, who made a brief reply.

V.W. H. J. Thorne, Grand Treasurer, in acknowledging the vote, said he had much gratification in stating that when the request came to the Trustees they acceded to it unanimously.

Grand Master's Address.

THE M.W. the Grand Master delivered his Annual Address, as follows:

Brethren of Grand Lodge:

Most cordially I bid you welcome to the twenty-fifth Annual Communication of Grand Lodge, and with great satisfaction I am able to announce that peace and harmony prevail within our borders. Our relations with sister Grand Lodges continue to be of the most friendly description. From my own observation, and from the reports of the District Deputy Grand Masters, I am able to conclude that the past year has been, on the whole, one of prosperity to the craft in this jurisdiction.

While during the past months much of a cheerful and encouraging nature has transpired we have had also deep cause for sorrow. A more than usually sad duty devolves upon me at this time, in having to announce the decease of two of our most eminent craftsmen.

In the providence of the Grand Architect of the Universe we to-day mourn the absence from our councils of two of my predecessors in this chair, distinguished alike for their labor and zeal in Masonry, and possessing to a more than usual degree the confidence and esteem of their brethren.

Robert Thomson Clinch, Past Grand Master, died in this city on January the 24th, aged sixty-four years. Initiated in Albion Lodge, October 7th, 1853, he from the first became a prominent figure in the craft. After serving his Lodge as Worshipful Master he was appointed Provincial Grand Master under England, an office which he held at the time of the formation of this Grand Lodge. The judicious and conciliatory course pursued by him at that time was an important factor in the peaceable establishment of the new grand body. By a unanimous vote he was elected first Grand Master of this Grand Lodge, an honor which he felt obliged to decline, feeling that the position which he held under the Grand Lodge of England must preclude it. In 1875 he was elected Grand Master, a position which he occupied for three years. For many years he has been the representative of the Grand Lodge of England near the Grand Lodge of New Brunswick.

It may well be said of our departed Brother that during his long connection with the craft he ever exhibited good judgment, a wise liberality, and a patient devotion to his highest duties, and shared in every effort to advance its best interests. A high-minded and honorable gentleman in social life, he was unusually modest and unassuming.

Endued with the divine attribute of sympathy he ever endeared himself to the young, the suffering and the needy. His winsome cheerfulness, his childlike christian character, and his steady loyalty to his sense of duty, made him a shining example for all his brethren, and won for him the reverent love of the entire community.

James McNichol, Past Grand Master, died at his home here, February 28th. Initiated in Hibernia Lodge, early in the year 1856, he at once took an active interest in masonic affairs, and, during the whole of his connection with the craft, was noted for his untiring active work and his sound judgment.

He served Hibernia Lodge as Worshipful Master in the years 1861 and 1863. He was one of the charter members of New Brunswick Lodge, and was the first to fill the chair. His active interest in the affairs of his Lodge never wavered, and for many years he was its indefatigable Secretary, an office he held at the time of his death.

As a representative of New Brunswick Lodge he assisted in the formation of this Grand Lodge, and up to the present session was always in his place.

In 1876 he was elected Grand Treasurer, an office which he held up to the time of his election as Deputy Grand Master in 1884. In 1887 and again in 1888 he received the highest office at the disposal of his brethren, and during those two years ruled the craft wisely and well.

As Secretary of the Masonic Board of Relief he for years did most valuable work, and his excellent business habits rendered easy the work of the other members of that organization.

In short, in every masonic station our lamented brother has left a record for zeal and fidelity equalled by few—surpassed by none—so fair, so true hearted, and so thoroughly to be depended upon when either counsel or hard work was required. In his business, social and domestic relations, our deceased brother was a man worthy of every praise, and has left behind him a name for sterling integrity, large-hearted liberality and faithful discharge of all his duties and responsibilities which it should be our aim to copy.

E. L. Ford, Worshipful Master of Lebanon Lodge, Sackville, died at Shafter, Texas, January 12th. An active and zealous Mason, he was deservedly mourned by his brethren.

We offer our sincere sympathy to sister jurisdictions mourning the loss of distinguished craftsmen.

Throughout the globe the hearts of all Masons have gone out in sympathy with the Grand Master of England in his affliction, owing to the death of his eldest son, the Duke of Clarence and Avondale. Like his noble father, the deceased Prince was a member

of the craft and had already distinguished himself in the performance of the duties of the high masonic offices which he held. I feel well assured that in no part of Her Majesty's dominions was more true masonic sympathy felt than by the craftsmen of this jurisdiction.

The United Grand Lodge of England also mourns the loss of their well-known and much-esteemed Grand Secretary, Col. Shadwell H. Clerke.

William Parkman, a Past Grand Master of the Grand Lodge of Massachusetts, died December 26, at a ripe old age, most highly esteemed and beloved by his fellows. It was he who as Grand Master laid the corner stone of the present Masonic Temple in Boston, October 14th, 1864.

The last year has deprived the craft in Massachusetts of one who was well known and beloved by many of us here. I refer to Samuel M. Bedlington, Past Master of Gate of the Temple Lodge of South Boston, who died November 21st, last. His was one of those gentle natures eminently fitted for the display of all the masonic virtues. I think those of you who knew him will agree with me when I say, that none could know Past Master Bedlington without associating with his name all that was good and great in the noble body to which he was an ornament.

The Grand Lodge of Maine mourns the loss of its venerable and well-known Grand Secretary, Ira Berry, who died in September last full of years and honors.

R. W. Brother Henry Brown, Grand Secretary of the Grand Lodge of British Columbia, died May 15th, 1891.

R. W. Brother Edward Mitchell, Grand Treasurer of the Grand Lodge of Canada, died in the city of Hamilton early in this year. Bro. Mitchell was well known by many of you here, and by his intimate friends was regarded with feelings of love and admiration.

I have lately received from Bro. Jose F. Pellon, Grand Secretary, a communication informing me that the United Grand Lodge of Colon and the Island of Cuba had agreed to re-establish their old name and would henceforth be known as the Grand Lodge of the Island of Cuba. The former representative near this Grand Lodge is re-nominated, and the earnest hope expressed that the good relations at present existing with this Grand Lodge be honestly continued.

In August last I received a communication from Levi C. Goodale, Most Worshipful Grand Master of the Grand Lodge of Ohio, calling attention to the fact that representatives from three or four extinct Lodges, whose charters had been forfeited by the Grand Lodge of Ohio, had pretended to organize and set up at Worthington, in the State of Ohio,

a so-called Grand Lodge of Ancient, Free and Accepted Masons, in violation of the landmarks of the order and in opposition to the M. W. Grand Lodge of Ohio, which had been in existence in that State for over eighty years.

March 8th last I received a communication from John M. Maxwell, M. W. Grand Master of the Grand Lodge of Colorado, requesting an exchange of Grand Representatives with this Grand Lodge. He recommended Brother Henry P. H. Bromwell, of Denver, for appointment as representative of this Grand Lodge near the Grand Lodge of Colorado. I had much pleasure in acceding to his request, believing with him that such interchanges of representatives "would tend to promote and strengthen the friendly relations which should exist between all Grand Jurisdictions." I have nominated Wor. Bro. Andrew McNichol as representative of the Grand Lodge of Colorado near this Grand Lodge. I have directed the Grand Secretary to transmit to Bro. Bromwell a commission in the usual form.

In my address of last year I laid before Grand Lodge a circular which I had received from M. W. Bro. J. Ross Robertson, President of the General Masonic Association of the United States and Canada, in which he called attention to the desirability of the craft in this jurisdiction affiliating with that association. During the present year I have received from him the following communication bearing on the same subject:

THE GRAND LODGE OF CANADA, A. F. AND A. M.

OFFICE OF THE GRAND MASTER.

TORONTO, January 28, 1892.

To the Grand Master of the Grand Lodge of New Brunswick:

DEAR SIR AND M. W. BROTHER: I fraternally beg to draw your attention to the claims of the General Masonic Relief Association of the United States and Canada for recognition and affiliation by your Grand Lodge. I ask your kindly consideration of the same, from the fact that we are endeavoring to accomplish results which will materially tend to prosper the Craft by driving the tramp and fraud Masons from the hunting-grounds which they have occupied so long. In the space of this letter it is impossible for me to do more than to request your perusal of the enclosed proceedings of the last meeting of the Association. I venture the hope that when you have read the President's address, pages five to fourteen, and the report of the Advisory Committee, page thirty-two, you will advise your Grand Lodge to affiliate with us, at least for a year or two, in order that you may test the merits of our Association. We can prove that we can save you many times the amount of your affiliation fee. Last year I addressed a letter to your predecessor.

At that time our affiliation fee was one cent per capita for the entire membership of each jurisdiction, at which rate your Grand Lodge would pay the sum of \$18.80.

With the view, however, of doing the greatest possible good to the greatest number, we have determined to reduce the per capita charge to one-half cent, so that instead of the above amount it would cost you \$9.40 to join us, and for this we give each of your Lodges the advantage of receiving each month our warning circulars. You will notice that on these the postage alone would to \$3.34, and with an additional amount for printing and envelopes there is very little, if any, surplus; in fact, in some jurisdictions our expenditure will exceed largely our income.

Kindly give this matter your consideration, and believe me,

Yours fraternally,

J. ROSS ROBERTSON, President G. M. R. A. of U. S. and C.

It appears to me that in view of the small cost and the probable good result, it would be well for Grand Lodge to secure the affiliation of this entire jurisdiction with the aforesaid association.

I have received a letter from Bro. W. J. Chetwode Crawley, of Trinity College, Dublin, setting forth the claims of a Grand Bazaar in aid of the Masonic Female Orphan School of Ireland, to be held in May in Dublin. In response to a request contained in this letter, I bring this matter before Grand Lodge, in the hope that some among us may be enabled to show their substantial sympathy with this worthy object.

I have appointed Bro. Joaquin Lancis as Representative of this Grand Lodge near the Grand Lodge of Colon and the Island of Cuba.

R. W. Bro. Rev. F. Partridge, D.D., Representative of the Grand Lodge of Colon and the Island of Cuba near this Grand Lodge, having removed beyond this jurisdiction and having resigned his appointment, I have nominated as his successor V. W. Bro. Rev. O. S. Newnham, Past Grand Chaplain.

R. W. Bro. William F. Dibblee, owing to age and infirmity, having resigned his position as representative of the Grand Lodge of Manitoba near this Grand Lodge, I have nominated W. Bro. Donald Munro to fill the vacancy.

I have nominated Wor. Bro. J. D. Chipman for appointment as representative of the Grand Lodge of Maine near this Grand Lodge, in place of R. W. Bro. David Brown, deceased.

So far as I have been able I have attended to the duty (always a pleasant one) of official visitation. A record of these visits is as follows:

May 7th.—Accompanied by several of the brethren from St. John, I visited Hiram Lodge, No. 6. Our reception was most cordial and fraternal, and I was pleased to find this Lodge in a prosperous condition. Wor. Master Morrison and the officers of Hiram Lodge exemplified the work of the E. A. Degree, two candidates receiving light on this occasion. I was able justly to compliment the officers upon the excellence of their work. At the close of the actual work of the evening, the officers of Grand Lodge were entertained in a most sumptuous manner at the Barker House.

December 10th.—I visited Sussex Lodge, No. 7. Sussex Lodge being held in the Town of St. Stephen, it is hardly necessary to say that the welcome accorded to the officers of Grand Lodge was most hearty hospitable and enthusiastic. Worshipful Master Smith and his officers exemplified the work of the M. M. degree in a manner very creditable to all concerned. After labor came refreshment, and the dining room of the Windsor Hotel was taxed to its utmost capacity to contain the number of craftsmen who gathered to partake of the hospitality of the St. Stephen brethren. This Lodge is strong in point of numbers, in a good financial condition, and its members enthusiastic.

December 28th.—I installed the W. M. of Albion Lodge, though I did not visit that Lodge officially.

January 5th, 1892.—I visited St. John's Lodge, No. 2, and installed the W. M. The attendance of the craftsmen was good, and the greeting we received from the retiring W. M. and the brethren was hearty.

January 7th. — At the request of the W. M., I visited Carleton Union Lodge with Grand Lodge officers, and conferred the M. M. Degree. The attendance of the craft was very large, and I found that, under the able guidance of the illustrious brother who now occupies the chair, the affairs of Carleton Union Lodge are prosperous. After the actual work we were hospitably and courteously entertained.

January 12th. — I visited Hibernia Lodge and installed Wor. Master Thomson into office for the second term. I found this Lodge in a most satisfactory condition, and under the enthusiastic mason who now rules it predict for it a prosperous year. With the truest kind of hospitality the W. M. at his own house feasted the brethren, and the evening passed pleasantly and, I trust, profitably in exchanging fraternal greetings.

January 21st.—I installed Wor. Bro. Benjamin S. Black to the chair of The Union Lodge of Portland for a second term. The condition of this Lodge is highly satisfactory, and the bountiful repast to which we were invited amply testified to the fact that the brethren were determined to sustain their reputation for hospitality.

Within a month I have visited all the Lodges on the north shore of the Province, and in each locality I received a most hearty and hospitable welcome.

Richibucto I reached on the afternoon of the 28th March, and in the evening visited Lodge St. Andrew, No. 16. I found this Lodge in a good condition, meeting in a well-furnished hall, which is the property of the Lodge.

March 29th.—I visited Miramichi Lodge, No. 18, J. D. B. F. McKenzie, Worshipful Master. They have here a fine hall owned by the craft, which is not only free from debt but is a source of revenue to the

Lodge. It was with feelings of deep regret that I found that old and enthusiastic mason, R. W. Bro. Thomas F. Gillespie, confined to his house by serious illness. Several of the brethren of Northumberland Lodge were present at the meeting, among whom were R. W. Bros. G. Lee Street and R. L. Maltby.

March 30th.—I visited Northumberland Lodge, Newcastle, R. L. Maltby, Worshipful Master. The M. M. Degree was conferred by the Worshipful Master and officers of the Lodge. The work was good and, with the exception of some verbal inaccuracies, in accordance with the ritual. In this visit I was accompanied by R. W. S. G. W. Masters and D. D. G. M. Fleming, who went up from Moncton for that purpose.

March 31st.—I visited St. John Lodge, Bathurst, R. R. Hickson, Worshipful Master. The same hearty and fraternal greeting that I had received in other places welcomed me here, and the evening was pleasantly and, I trust, profitably spent in instruction.

April 1st.—I went on to Campbellton, and in the evening visited Campbellton Lodge, No. 32, D. C. Firth, Worshipful Master. The attendance was good, the lodge room well appointed, and the work as exemplified by the officers creditable in the extreme.

April 2nd.—I visited Restigouche Lodge, No. 25, Dalhousie, W. Draper, Worshipful Master. This Lodge is in a good condition, although latterly they have done but little work. After the Lodge was closed the members and visitors were entertained by Past Master Disbrow at his residence, and an hour or two passed most pleasantly in social and fraternal intercourse.

This ended the inspection of the Lodges in that section of our jurisdiction, and I came away much encouraged as to the condition of the craft there. Each Lodge meets in a well-appointed hall of its own, and while some of them are not free from debt, in no case could I find any anxiety as to the financial condition. Peace and harmony appear to prevail, and such instruction as I was able to give, either in the ritual or in the general aims of the craft, was listened to with evident attention. I shall always entertain the most pleasant recollections of the profuse and courteous hospitality which nowhere failed, and I fervently hope my visits may be productive of good in an increased interest in the craft, and a more strict living up to the tenets of our time-honored fraternity.

A report of the dispensations issued will be given by the Grand Secretary. I need not refer to them here.

I was obliged to refuse a dispensation to bury, with masonic honors, an unaffiliated brother, as this was clearly contrary to the constitution. Sec. 2, page 46, under head of visitors says: "No brother

residing in the Province, and not affiliated with some Lodge, shall be entitled to the benefit of the benevolent fund for himself or family, nor to masonic burial."

Sec. 1, page 46, under the head of Public and Funeral Processions says: "When the wish of the deceased shall have been communicated to the Master of the Lodge of which he died a member, the Master shall apply to the Grand Master for a dispensation."

In February last I received from Zetland Lodge a request for a dispensation to install Bro. J. G. A. Belyea as Worshipful Master for 1891, and afterwards to install the officers elected for 1892. I felt obliged to refuse the dispensation to install Bro. Belyea, as I learned that the minutes of his election had never been confirmed by the Lodge, and also because the year had elapsed in which he could have served.

During the year, as is usual, I have made several rulings on questions of masonic law. Most of these, however, were explanations of plain constitutional points and need not be repeated here. To three of these questions I will refer now, because I find there exists some misapprehension on the points mentioned.

Question.—Can a dimit be granted by the Master and Secretary without a vote of the Lodge?

Answer.—No. The Master of a Lodge has no right of his own motion to grant a dimit. It must be granted by the Lodge and to that end it is necessary that a resolution should be moved and carried in the Lodge to authorize the granting of a dimit.

Question.—Can a petition for initiation be withdrawn when once received by a Lodge?

Answer.— No. The Constitution is very clear upon this point. Sec. 6, page 44, says inter alia: "A petition having been received by a Lodge cannot be withdrawn."

In answer to enquiries as to reception of candidates for initiation who possessed some physical disability, I have held that such candidates should be able literally to conform to all the requirements of the degrees.

On the 3rd of November last, Zion Lodge suffered a severe loss in the destruction by fire of their fine hall, together with the warrant, regalia and Lodge furniture. So recently as August, 1887, this Lodge suffered a similar loss. By order of the Board of General Purposes a duplicate copy of the warrant has been furnished them.

The V. W. the Grand Chaplain having kindly consented to conduct Divine service and preach before the craft on the Festival of St. John the Baptist, I caused a special communication of Grand Lodge to be summoned for the evening of that day. Despite the unfavorable state of the weather, the city lodges responded well to the call addressed to

the craft, and a large delegation from Sussex Lodge, under the charge of Worshipful Master Smith, came up from St. Stephen and took their place in the procession.

The Trustees of the Centenary Church very generously placed their fine edifice at our disposal. The service of prayer and praise was very hearty and effective, and the truly eloquent and instructive sermon of the Grand Chaplain was replete with historical and poetical allusions. The teachings and aims of masonry were most vividly portrayed by the preacher, and earnest was his appeal to the brethren to build their Temple for eternity, which they could do by faith in Jesus Christ.

It afforded me great pleasure to accede to the request of R. W. Bro. Sangster that the corner stone of the Wesley Memorial Church in Moncton might be laid with masonic ceremony. For that purpose I issued a call to the craft and convened a special communication of Grand Lodge in Moncton on the 16th day of June last. The attendance of the craft was good, and in the afternoon, with appropriate masonic ceremony, the corner stone of the new Church was laid. This fine Church Bro. Sangster has erected at his sole expense, and in so doing has set a noble example to others—for how more fittingly can a man apply that wealth with which Almighty God has crowned his labors, than in bestowing it in such a manner as will do honor to the "Bounteous Giver of all good," and how can a good man better serve his fellow-men than by striving "with worship sin to foil?"

I have received reports from the D. D. Grand Masters of Districts Nos. 1, 2 and 5, and from the D. G. Master for District No. 4. I submit these documents for your consideration. No report has been received from the D. D. G. Master of District No. 3.

R. W. Bro. Fleming, in his report, calls attention to the condition of Salisbury Lodge, which seems to be practically dead. For a long period they have had no meeting, and I submit it for your deliberation whether it would not be better to call in the warrant of that Lodge.

· I have approved a new code of by-laws for Carleton Union Lodge. Also, by-laws of Keith Lodge, with certain alterations.

The Ritual Committee, acting in concert with the Worshipful Masters of the city Lodges, has arranged for an exemplification of the ritual of the E. A. and M. M. Degrees, at this communication of Grand Lodge.

This evening at an emergency meeting of Albion Lodge, the E. A. Degree will be worked. To-morrow evening at an emergency communication of New Brunswick Lodge, the M. M. Degree will be exemplified.

To the actual and acting officers of Grand Lodge, who have accompanied me on official visits, I desire to tender my sincere thanks.

To those past officers of Grand Lodge who have kindly aided me with their counsel and advice, I feel under a deep obligation, which I here gratefully acknowledge.

It was moved by R.W. Bro. D. F. Merritt, D.G.M., and

Resolved, That the Address of the M.W. the Grand Master be referred to a special committee to report upon the several subjects contained therein.

Whereupon, the following brethren were appointed such Committee:

R.W. D. F. Merritt, V.W. Rev. George M. Campbell, and W. T. Nisbet Robertson.

I have issued upon special and regular annual returns fifty-two certificates on parchment.

Invitations were received from the M.W. the Grand Master of Rhode Island, for the Grand Officers of New Brunswick to be present and participate in the ceremonies when celebrating the Centennial of Freemasonry on the 24th June.

Bro. William H. Gerrish, Music Publisher, of Boston, Mass., presented to Grand Lodge a set of the Gerrish collection of male voices music, which he wished accepted as a slight contribution to the library of the Grand Lodge of New Brunswick.

From the Grand Lodge of New York, Vols. 1 and 2 of the History of the Most Ancient and Honorable Fraternity of Free and Accepted Masons in New York, embracing the history of the Grand Lodge from the formation, A.D. 1781.

From Bro. L. C. Hassell, President of the Fraternity Publishing Co., of Boston, Mass., a bound copy of the History of Freemasonry and concordant Orders.

November 3rd, I received from the M.W. Grand Lodge of New York a jewel for their Grand Representative, R.W. Bro. B. Lester Peters, P. G. M.

November 4, received notice of the destruction of Zion Lodge hall by fire, on the morning of 3rd November. The warrant being destroyed, the Lodge applied for a duplicate warrant. December 4, received from Carleton Union Lodge, No. 8, copies of their new by-laws for confirmation by the M.W. the Grand Master.

A communication was received from the Grand Lodge of Colon and Island of Cuba, dated December, 1891, announcing that at a special communication of that Grand Lodge, and by the unanimous consent of all the subordinate Lodges, they have agreed to re-establish the old name, on account of its propriety; so that the Grand Lodge instead of being known as the United Grand Lodge of Colon and the Island of Cuba will henceforth be called "Grand Lodge of the Island of Cuba."

The supply of parchment certificates having become exhausted, an order was given Bro. William Cruickshank, of Edinburgh, Scotland, for two hundred and fifty copies. Bro. Cruickshank filled the order with promptness.

The M. W. Grand Master of Grand Lodge of Colorado asked for an exchange of representatives.

A communication was received from the Grand Lodge of Ohio, dated August 10th, 1891, as follows:

To the M. W. GRAND LODGES, F. and A. M., throughout the world:

GREETING:—To the end that the fraternal intercourse and recognition that has heretofore existed between the M. W. Grand Lodge of Ohio and other M. W. Grand Lodges of Free and Accepted Masons throughout the world may continue without misunderstanding, I deem it my duty to call your attention to the fact that representatives from three or four extinct Lodges in this jurisdiction, whose charters were forfeited by the Grand Lodge of Ohio because of their disloyalty and rebellion, have pretended to organize and set up at Worthington, in the State of Ohio, a so-called Grand Lodge of Ancient Free and Accepted Masons, in violation of the landmarks of the order and of their duty as Masons, and in opposition to the M. W. Grand Lodge, which has been in existence in the State for eight years.

Were it not that this rebellious faction might attempt to mislead and impose upon the craft in other jurisdictions, it would be too insignificant for official attention.

Report of the Board of General Purposes,

THE R.W. the Deputy Grand Master, as President of the Board of General Purposes, submitted the Annual Report of the Board, as follows:

MASONIC TEMPLE, SAINT JOHN, N. B., April 26, 1892.

To the GRAND LODGE of F. and A. M. of New Brunswick:

The Board of General Purposes presents to Grand Lodge a report of its proceedings for the past year.

- 1. The Board has not been required to deal with any very important matters during the recess of Grand Lodge, and it is gratifying to be able to state that no matters of grievance or complaint have been brought to its notice, nor has it been called upon to exercise its power of discipline in any case.
- 2. At the first meeting of the Board, held on 21st May, Worshipful Brother T. Nisbet Robertson was chosen vice-president.
- 3. At the same meeting it was resolved that the regular meetings of the Board for the year should be held on the second Wednesday in August, November, February and April.
- 4. The Board carefully considered the memorial from Restigouche Lodge, referred to it by Grand Lodge, and after mature deliberation reached the following conclusions, viz.:
 - (a) That Restigouche Lodge exceeded its powers in passing a sentence of expulsion on Brother Ritchie.
 - (b) That the penalty sought to be imposed upon Brother Ritchie was much in excess of his masonic offence.

The Board, therefore, directed Restigouche Lodge to reconsider its verdict, and instead thereof, at the utmost, either to suspend or exclude Brother Ritchie.

5. The Board had under consideration during the year the resolution referred to it by Grand Lodge, to so amend the Constitution as to permit the annual communication of Grand Lodge to be held at other places than the City of Saint John, and after carefully deliberating upon the matter the Board now submits the following amendment to the Constitution, notice of which has been properly fyled in the office of the Grand Secretary, and recommends its adoption by Grand Lodge:

That section sixteen, page twenty, referring to the meetings of Grand Lodge, and the amendments thereto, be rescinded and the following substituted:

"The place of holding the annual communication of Grand Lodge is the City of Saint John, and the time the fourth Tuesday in But Grand Lodge, by a majority vote at any annual communication, may fix upon any other place within the Province, as the place at which the next annual session shall be held.

"In case it is proposed to change the place of meeting from Saint John, the Grand Lodge shall fix a time for the consideration of the proposed change. Should no notification be given of a proposition to change the place of meeting, on the first day of the annual session, then as a matter of course, the annual session will be held at Saint John.

"None but members of the Grand Lodge shall be present at the communications, without permission of the Grand Master or presiding officer."

- 6. The Board further recommends that the blank as to the time of holding the annual communication be filled in with the word August; but that in dealing with the matter the fullest opportunity be allowed to Grand Lodge to fix any other date which to it may seem best.
- 7. At the meeting of the Board in November a communication was received from Zion Lodge, Sussex, reporting the destruction of their hall by fire, and the loss of their Warrant, and requesting the Board to issue a new one. The Board directed the Grand Secretary to prepare a new Warrant and forward the same to the Worshipful Master of Zion Lodge. The Board has paid the cost of the Warrant -- eleven dollarspending the order of Grand Lodge as to the payment of same by Zion Lodge.
- 8. A request was made to the Board, in November, by a member of a subordinate Lodge to have an addition made to his name on the certile ficate issued by Grand Lodge. The Board decided that as the name in the certificate was the name by which the brother was known in the return made by the subordinate Lodge to Grand Lodge, and was the name which has been duly entered in Grand Lodge register, it was in advisable to make the addition asked for by the brother.
- 9. In the matter of procuring a certificate for Past Masters of subort hands of the Grand Treasurer. dinate Lodges, which was referred to the Board by Grand Lodge at the last annual communication, the Board would report that after careful enquiry it finds that the cost of five hundred certificates on parchmen would be about one hundred and fifty dollars. The Board, understand ing that its duty was merely to ascertain the cost and report the same to Grand Lodge, makes no recommendation in reference thereto.

10. The Committee appointed by the Board to audit the books and accounts of the Grand Treasurer and Grand Secretary, having discharged the duty entrusted to them, submitted a report, which was adopted by the Board, and is as follows:

To the Board of General Purposes of GRAND LODGE, F. and A. M.:

Your Audit Committee beg to report that they have examined the books and accounts of the Grand Secretary and Grand Treasurer for the current Masonic year, and find the same correct.

Report of Committee on the Grand Master's Address.

GRAND LODGE OF NEW BRUNSWICK.

THE Committee on the Address of the M.W. the Grand
Master submitted the following report:

COMMITTEE ROOMS, FREEMASONS HALL, 27th April, 1892.

To the M.W. the GRAND LODGE of New Brunswick:

The Committee to whom was referred the Address of the Most Worshipful Grand Master submit the following report:

The Committee are satisfied that the cordial and hearty welcome of the Grand Master to the twenty-fifth annual communication of the Grand Lodge is fully appreciated by the brethren, and rejoice not only that peace and harmony have prevailed throughout the jurisdiction, but that the year past has been one of prosperity to the Craft.

The members of the Fraternity will fully appreciate the touching and appropriate allusions of the Grand Master to the vacancies created by death in this grand body since our last annual communication. There are niches that only one figure can fill. Robert Thomson Clinch and James McNichol, Past Grand Masters, are not with us to-day; for, in obedience to the Divine word of the Supreme Architect of the Universe, they have passed into that spiritual temple, that house not made with hands eternal in the heavens. Honor and love for evermore to these good men gone to rest. Deep conviction, delicate feeling, warm affection, and intense activity characterized their labors for the Craft. They have not left behind them more devoted masons nor more consistent men.

The Committee recommend that suitable memorial pages be prepared and inserted in the printed proceedings of this communication, as a mark of respect to the memory of Right Worshipful Brothers Clinch and McNichol.

Other vacancies have been made during the year in this and other Grand bodies; brothers who discharged their duties with industry, fervency and zeal have ended their labors, and this Grand Lodge extends its sincere sympathy to the bereaved families, and to sister jurisdictions mourning the loss of distinguished workmen.

The Committee are also satisfied that in no part of Her Majesty's wide empire did more sincere, christian and masonic sympathy exist than in this jurisdiction for H. R. H. the Prince of Wales, Grand Master

of England, in the great sorrow by which he was overtaken, in the death of his eldest son, the Duke of Clarence and Avondale, heir apparent to the British throne; and regard the Grand Master's allusions thereto as most fitting and timely.

The Committee heartily concur in the views of the Grand Master that the interchange of Representatives between the various Grand Lodges tends to promote and strengthen the friendly relations which should exist between all grand jurisdictions.

The Committee agree with the Grand Master that it would be well for Grand Lodge to secure the affiliation of this entire jurisdiction with the General Masonic Relief Association of the United States and Canada, and would recommend that the Board of General Purposes be authorized to take the necessary steps to secure such affiliation.

The Committee join the Grand Master in the hope that some members of Grand Lodge may be enabled to show their substantial sympathy with the brethren of the Grand Lodge of Ireland, in the object which they have in view in holding a bazaar in aid of the Masonic Orphan School of Ireland.

The Committee note with pleasure that during the year the Grand Master has been enabled to officially visit so many of the Lodges in this jurisdiction, and are glad to know that in all these visits he was received in the most cordial manner, and entertained with the most profuse and courteous hospitality.

The Committee agree with the Grand Master in his refusal to grant a dispensation to instal a brother Master of a Lodge, the minutes of whose election had not been confirmed by the Lodge.

The Committee cannot, however, agree with the Grand Master in his decision that a dimit cannot be granted except by a resolution moved and carried in the Lodge to authorize the granting of the dimit.

The Committee are of the opinion that this decision is not in accordance with the latter part of section 5, under the heading of "Members and their Duty," of the Constitution of Grand Lodge. This part of the section reads as follows: "Whenever a member of any Lodge shall resign, or shall be excluded, or whenever, at a future time, he may require it, he shall be furnished with a certificate stating the circumstances under which he left the Lodge, and such certificate shall be produced to any other Lodge of which he is proposed to be admitted a member, previous to the ballot being taken."

This would clearly seem to show that the certificate must be granted, and that the Lodge has no right to refuse it. To admit that the Lodge has a right to vote upon the question admits, at the same time, that a

majority of the members have a right to refuse the certificate, which, according to the section of the Constitution quoted, they clearly have not the right to do.

In the other decisions of the Grand Master the Committee heartily concur.

The Committee are pleased to note that the custom of calling the Craft together on the Festival of Saint John the Baptist, to attend Divine Service, was again followed last year, and they trust that this method of observing the day may be continued.

The Committee note with pleasure that the Grand Master acceded to the request of R.W. Brother George R. Sangster to lay with Masonic ceremonial the corner stone of Wesley Memorial Church, erected by him in the City of Moncton, rejoice in this recognition of the religious nature of our ancient fraternity by the Church, thereby strengthening the ties existing between Freemasonry and the Christian religion, and heartily endorse the appropriate references of the Grand Master to the generosity of our worthy craftsman in the erecting of a house to the honor and for the worship of Almighty God.

In reference to the matter of Salisbury Lodge, the Committee feel that while there is any reasonable hope of the Lodge being resuscitated it would be well to afford the members every opportunity of doing so. They therefore recommend that the Board of General Purposes, with the District Deputy Grand Master for that District, be directed to make another effort to revive the Lodge during the coming year, with the understanding that if this effort is unsuccessful the Warrant will be recalled at next session of Grand Lodge.

A special communication of New Brunswick Lodge, No. 22, was held this evening at half-past seven o'clock. The Grand Master, with the assistance of officers from the several city Lodges, conferred the Degree of M. M. on the candidate in waiting, in a very effective manner. The Grand Organist, with a quartette of male voices, materially assisted in the admirable rendering of the work, which was witnessed by a very large gathering of the brethren.

The M.W. the Grand Master thanked Brother Sangster for his kind offer.

All business having been disposed of, Grand Lodge was closed in ample form.

Reports of District Deputy Grand Masters.

THE Committee to whom was referred the Reports of the District Deputy Grand Masters authorize the publication of the following extracts from the reports:

DISTRICT No. 1.

R.W. Bro. Geo. B. Hegan, Deputy for this district, says:

On the 5th November, 1891, I made a visit to Carleton Union Lodge, No. 8. W. Bro. J. V. Ellis conferred the E. A. Degree in a most satisfactory manner, and the various officers performed their duties in a way alike creditable to themselves and the lodge. There was a large gathering of the craft from both sides of the harbor and a very pleasant time was spent, the Carleton brethren being famed for their hospitality.

My next visit was to St. Martins Lodge, No. 30, on 2nd January, 1892, accompanied by Past Masters Hunt, Ewing and Melville and Bro. Horn. The Third Degree was worked by the W. M.; and I installed the officers for the coming year. So far as the work of the degree is concerned it was well done.

St. John's Lodge, No. 2, was visited on 2nd February. Although the candidate for degrees did not put in an appearance, the meeting was made interesting by its being the Fortieth Anniversary of the initiation of Past Master Bunting. The brethren were invited to a bountiful repast by the W. M., to which they did ample justice.

I next paid a visit to New Brunswick Lodge, No. 22, on the 11th February. The W. M. conferred the Master Mason Degree in a very creditable manner, and was well supported by his officers. Refreshments were served during the evening.

On the 18th of February The Union Lodge of Portland, No. 10, was visited and the Worshipful Master and Officers ably sustained their already well-earned reputation for good work.

The next and last visit was made to Albion Lodge, No. 1, on 4th March. The Third Degree was worked in good style and the lodge is in a most satisfactory state.

On the 9th of August, 1891, I wrote to the W. M. and Secretary of Corinthian Lodge asking them to let me know at what date it would suit for me to make an official visit. I received a reply from S. W.

Sprague saying at that time it would not be convenient, but later on he would let me know. I again wrote on the 22nd February, 1892, but so far have not received an answer.

I communicated with the Secretary of Zion Lodge in reference to visiting that lodge and received two letters, one from the Secretary and one from P. M. White, asking me to defer the visit until there was better accommodation. Since the destruction of the hall by fire their space was limited, and the attendance was not so great as formerly. It is well known that Zion Lodge is in a most flourishing condition.

Besides writing to the Master of Midian Lodge I spoke to several of the members in reference to a visit. The Master did not reply to my letter, but I was informed that the brethren had not met for some time and it would be difficult to get them together.

There seems to be a good feeling among the members of the various lodges in this district, and the prospects for the year are exceedingly bright.

DISTRICT No. 2.

R.W. Bro. H. B. Fleming, Deputy for this district, says:

I have to report that during the past year I have visited all the lodges in this jurisdiction, except Salisbury, No. 20.

On 21st October, I visited Albert Lodge, when the work of the Second Degree was exemplified. This lodge is in good condition financially and the officers able to perform the work satisfactorily.

On 22nd October, I visited Howard Lodge. This lodge is hard to keep up as it has very few members, and those scattered, still they hope to move into new quarters shortly when they expect more success.

On 28th December, I installed the officers of Keith Lodge, assisted by W. Bros. J. E. Masters and George Ackman. This lodge is steadily improving.

On 13th January I visited Zetland Lodge for purpose of installation, but after opening the lodge found this could not be done without dispensation, their By-Laws stating this business had to be done on 27th December, or day following. On 9th March, by instructions of the M.W. the Grand Master, I again visited this lodge and installed the officers. I regret to report that this lodge has not been working very smoothly for some time past, but trust with their new officers affairs will be more satisfactory.

On 14th January, I visited Sussex Lodge, Dorchester, and installed their officers. This lodge is in good working order and looking for a prosperous year.

On 14th March, I visited Lebanon Lodge and installed the officers. I have attended several communications of this lodge during the year and assisted them in their work. This lodge has been laboring at a great disadvantage most of the year on account of the long illness and death of their late Worshipful Master, Brother E. L. Ford, who took a great interest in the work, and tried his best to advance the interest of the lodge.

I have tried several times to arrange a meeting with Salisbury Lodge, but this seems impossible, as the members have lost all interest. The lodge has not held any meetings since I have had charge of this district.

I have examined the books of lodges visited and found them correctly and neatly kept.

DISTRICT No. 4.

R.W. Bro. D. F. Merritt, Deputy for this district, says:

As District Deputy Grand Master of the Fourth Masonic District, I would respectfully report: That during the year I have visited all the lodges in this district, and have witnessed the work in each case.

My first visit was to Benjamin Lodge, in Andover, at their regular communication in September. The attendance was good, and the work on the First Degree well performed. This lodge has made very substantial improvement in its work during the last two years.

My second visit was to Alexandria Lodge, of St. Mary's, York Co., at its regular October meeting. The attendance was not large, owing principally to it being on the evening of the opening of the Provincial principally to it being on the evening of the opening of the work Exhibition in the city of Fredericton. The exemplification of the work of the M. M. Degree was well done, and demonstrated that the W. M. and officers of Alexandria Lodge were well up in the ritual.

My third visit was to Hiram Lodge, in the city of Fredericton, at its regular communication in November. The attendance was large and representative. The lodge is well situated and has every appearance of prosperity. Three candidates were balloted for and one initiated into Freemasonry. All the work, business, ritual and otherwise of the lodge is of a most excellent character.

My fourth and last official visit was to Woodstock Lodge. On the evening of 7th January I had the pleasure, as Deputy Grand Master, of installing the W. M. and officers of Woodstock Lodge. The attendance was good, and an interest evinced that bespoke a period of prosperity. In this respect I am pleased to be able to report that we have not been disappointed. Since the beginning of 1892 a very large number have been proposed and initiated. The work has been well performed, and the officers and members are taking an unusual interest in the lodge.

This lodge owns a fine building in the centre of the business part of the town, which, besides giving them a free hall, brings them in an income to the lodge of three hundred dollars per annum. The lodge is free from debt of any kind on their building, furniture or otherwise, and have a substantial balance of cash in the treasury.

At all my visits I was most cordially received and hospitably entertained by the brethren, and for which I extend my thanks.

DISTRICT No. 5.

R.W. Bro. P. G. McFarlane, Deputy for this district, says:

Although I have not been able to visit officially every lodge in District No. 5, yet having had communication with every lodge, am able to report concerning masonry in the district.

Some lodges do more work than others, and on that account should do better work; however, it is true of every lodge that the officers would like to do better work than they do.

Victoria and Sussex Lodges has been visited frequently by the M.W. the Grand Master during the past two or three years, with the result that more attention is paid to accuracy and formality in everything pertaining to the work of the degrees; and although St. Mark's and St. George Lodges do good work, yet they desire to do the work still better.

With here and there an exception the officers of the different lodges this year are young masons, and are ambitious to work as near the ritual as they can. It is a prosperous sign to see young masons take the active interest they do in lodge affairs.

Concering Alley Lodge, I regret that I am unable to make any report.

Last winter I had the pleasure of attending a meeting held in the city of Calais, of masons representing the lodges in the State of Maine. An interesting feature of the sessions was the working of the degrees. The officers of one lodge in the presence of the District Deputy and other Grand Lodge officers and representatives worked the E. A. Degree, those of another lodge the F. C. Degree, and the officers of a third lodge the M. M. Degree. The work was afterwards criticized, and had it not been so late in the season I would have attempted a meeting of a similar nature in my district. In the evening I had the pleasure of being asked to address the large gathering of masons, but more especially of listening to many enthusiastic and soul-stirring addresses on the great subject of masonry.

I am convinced that masonry, though not lagging by any means in this district, would receive an impetus if we could see the work exemplified once or twice a year under the direction of the ritual committee. This is done at the annual communication of Grand Lodge, but it is not always convenient for the officers of lodges to attend.
