EMERGENT COMMUNICATION

HELD AT ST. JOHN, N. B., JUNE 26TH, 1904.

Pursuant to a summons issued by order of the Most Worshipful, the Grand Master, an Emergent Communication of "The Grand Lodge of the Antient and Honorable Fraternity of Free and Accepted Masons of New Brunswick," was held in the Masonic Hall, Germain street, in the City of St. John, on Sunday afternoon, the 26th day of June, A. L. 5904, at 2.30 of the clock.

The service having concluded, the procession re-formed and returned by way of Dorchester, Carleton, Coburg, Charlotte, King and Germain streets to Masonic Hall.

The Grand Master on resuming the East expressed his great gratification at the attendance of the Craft, and at the manner in which the Lodges had responded to his call. He made special reference to the presence of Zion Lodge, Sussex; the Corinthian Lodge, Hampton, and Carleton Union Lodge, St. John West, and thanked the different Worshipful Masters for their zealous co-operation. He remarked upon the pleasure he felt at being escorted by the members of Saint John Encampment, and thanked them and those from De Molay Encampment for their courteous action.

The Grand Master instructed the Grand Pursuivant to admit any Master Masons properly clothed and in good standing.

At this juncture, the Grand Pursuivant announced that the Most Worshipful Grand Master of Quebec was in waiting, desirous of paying a fraternal visit to Grand Lodge, whereupon, at the request of the Grand Master, R. W. Brother Thomas Walker, M. D., P. G. M., and R. W. Brother His Honour Judge Forbes, P. G. M., withdrew to greet the distinguished visitor.

The Grand Master of Quebec, Most Worshipful Brother John B. Tressider, accompanied by Past Grand Masters Walker and Forbes, was admitted, conducted to the East and saluted with the Grand Honours.

The Grand Master cordially welcomed M. W. Brother Tressider, expressed his great personal pleasure in meeting him and the gratification which his presence occasioned Grand Lodge.

In reply, the Grand Master of Quebec stated that he had gladly availed himself of the opportunity to visit the Sister Grand Lodge of New Brunswick and to now convey to it the hearty fraternal good wishes of the Grand Lodge of Quebec. He referred to the friendly, courteous rivalry which should properly exist between Grand Bodies, and added that he had learned with great pleasure that the condition of Masonry in New Brunswick was prosperous and progressive. Throughout, the remarks made by the Grand Master were cordial and felicitous, and were received by Grand Lodge with a great deal of applause.

Allusion to the presence of R. W. Brother Will H. Whyte, Grand Secretary of Quebec, was then made by the Grand Master, and he, in response, addressed Grand Lodge briefly and recalled the interesting fact that it was in this Lodge room that a few years before he had been elected head of the Grand Priory of Canada.

Moved by R. W. Brother Thomas Walker, M. D., P. G. M.:

That, inasmuch as the minutes of the last Annual Communication of Grand Lodge have been printed in the Proceedings of the past year and distributed, they be now taken as read and confirmed. Carried.

The Minutes of the Emergent Communication, held at Saint John on Sunday, the 26th day of June, were read, and on motion of W. Brother A. M. Rowan, G. S. B., were confirmed as read.

The Most Worshipful Grand Master delivered his annual address, its conclusion being marked with general applause.

GRAND MASTER'S ADDRESS.

BRETHREN OF GRAND LODGE :

Another year has been added to the history of Freemasonry in New Brunswick, and once again the privilege is afforded me of most heartily welcoming you to our Annual Communication.

As citizens of one of the most important outlying portions of the great British Empire we should rejoice that the year past has not been marked by any great disaster to that Empire or its people. While some of the nations have been engaged in war, with all its accompanying sorrow and misery, our Empire has, under the guidance of God, enjoyed the blessing of peace and prosperity.

As Freemasons we have many reasons for gratitude to Our Supreme Grand Master for the condition of the Craft within the Province, and for the cordial and fraternal

relations which exist between us and other Grand Lodges. Nothing can be more pleasing to a Grand Master than to be able to report the prevalence of peace, harmony and growth in his jurisdiction. It is my privilege to report that the condition of Masonry in this Province during the past year has been marked by a continuous and satisfactory growth, as well in the increase of its membership as in the improved character of its work. The balance in the hands of the Treasurer has been substantially increased. No case has arisen that called for discipline. No important matter leading to dispute or division among the brethren has been brought to our attention. The fraternal feeling which should characterize Freemasonry has prevailed in the several Lodges, and between those Lodges and this Body. That this harmony does not exist by reason of stagnation or indifference among the members of an institution is shown by the fact that our Lodges are in a flourishing condition, and our Craftsmen have not forgotten the good works of love and charity. The future of this Grand Lodge will be what we and our successors make it.

Our relations, too, with the other Grand Lodges with which we are in correspondence remain, as I have been able to report from year to year, perfectly harmonious. May the fraternal chain that binds Grand Lodge to Grand Lodge be not only a symbol of that which should bind nation to nation, but may the hopes of every Mason be soon realized in the establishment of universal peace and in the full recognition of the brotherhood of man.

While we gratefully acknowledge the many blessings which we are enjoying, let us not forget the brethren—most of whom were ripe in years and in Masonic experience—who have finished their labors and have entered into their eternal rest. Their works live after them and their names will be held by us in affectionate remembrance until we, too, are summoned to the Celestial Grand Lodge, where we shall again meet them—meet to part no more. We

tender to their surviving friends and relatives who are left to mourn in their sad bereavement our sincere and heartfelt sympathy.

W. Brother Daniel McGruar, a Past Master of Northumberland Lodge, No. 17, entered into rest at the age of eighty-seven years, on the 2nd of December, 1902. He was raised in that Lodge, then working under a warrant granted by the United Grand Lodge of England, on the 13th of September, 1859. For many years he was a very regular attendant at his Lodge and was always devoted to its interests and welfare. In the discharge of his duties as an official in his County he was attentive and painstaking, and commanded the respect of all who knew him.

Past Master John Thompson, of Zion Lodge, No. 21, died at his home in Sussex on the 21st day of September, 1903. He was of a retiring disposition, and his life was devoted to his private business, in which he was honest and industrious. Like every good Mason, he was a good citizen, and possessed the confidence and respect of his fellowmen. In his daily intercourse with those who met him in business he exemplified the excellent principles of Freemasonry. His brethren laid him to rest with Masonic honors.

St. Mark's Lodge, No. 5, mourns the loss of one of its oldest and most respected Past Masters, William D. Hartt, who died at Saint Andrews on the 19th day of October, 1903. For many years Brother Hartt was prominent in Masonic circles, and was ever ready to lend a helping hand to those deserving of assistance. The citizens who knew him best had the fullest confidence in his integrity. While he resided in Saint Andrews he was closely identified with municipal, educational and religious matters.

On the 29th day of October, 1903, Ananias McFarlane, a highly-respected Past Master of Sussex Lodge, No. 7, who affiliated with Woodstock Lodge, No. 11, in February, 1881, departed this life. He was a zealous and active Mason. In the responsible position of a railway engine driver, which

position he held for many years, he was known to be careful and trustworthy. Of a quiet and unassuming manner, he won the esteem and confidence of the public. He was a faithful and consistent worker in the Church, and was devotedly attached to its interests.

On the 10th of December, 1903, Woodstock Lodge, No. 11, was called upon to mourn the loss of its oldest and one of its most distinguished Past Masters—Brother Stephen Burpee Appleby. He was one of the "right trusty and well-beloved brethren" to whom the new warrant of his Mother Lodge was directed after the formation of this Grand Lodge. For years he took an active and deep interest in the welfare of his Lodge. He was a successful barrister, and was most highly respected by the people of the County of Carleton, who showed their confidence in him by electing him on several occasions as their representative to the Provincial Assembly and Dominion Parliament. While in later years he was not so regular in his attendance at the meetings of his Lodge, yet in his life he constantly practiced the precepts and exemplified the principles of Freemasonry.

W. Brother Lieutenant Colonel Robert R. Call, a Past Master of Northumberland Lodge, No. 17, died suddenly on the 23rd of December, 1903. He was raised in that Lodge on the 13th of December, 1864, and for forty years was an active and consistent member. In 1872 he was Grand Director of Ceremonies of this Grand Lodge. At the time of the erection of the Grand Lodge of New Brunswick he was the Worshipful Master of Northumberland Lodge, and the new warrant was directed to him as such. He was a public-spirited citizen and always took a deep interest in everything that was conducive to the development of the community in which he lived. At the time of his death he was holding the position of High Sheriff of the County of Northumberland. The duties of this office he had performed for years to the entire satisfaction of those who were brought in contact with him. He was well known in

social and military circles, and beloved by all who knew him. His friendship was true and sincere.

R. W. Brother Robert Marshall, Past Grand Master, died 27th of May, 1904. He had filled the measure of a long and an active life. For the last two or three years failing health prevented his attendance in Grand Lodge, from which in the days of his activity he was rarely absent. Brother Marshall was born in Pictou, N. S., in April, 1832, and early in life went with his parents to Chatham. In 1859 he came to St. John and had resided here continuously since. Leading a very active business and social life, he was associated with national, civic, philanthropic and benevolent organizations of this city, to all of which he cheerfully gave time, ability and generous financial support. In most of them, as well as in the religious denomination to which he belonged, he occupied positions of honor and trust. He served the City of St. John as its representative in the Provincial Assembly, and was for some years a member of the Executive Council of the Province. Brother Marshall was initiated into Freemasonry in 1860 in the Union Lodge of Portland, then upon the English foundation, and until the close of his active life took an ardent and earnest interest in all the affairs of the fraternity. He soon became the Master of his Lodge, and became a warm supporter of the plan for the organization of an independent Grand Lodge for the Province. When, in 1867, Grand Lodge was formed, Brother Marshall was its first Assistant Grand Director of Ceremonies. In succeeding years he filled other offices, and in 1878 was elected Grand Master, and was re-elected to that position in the following year. In all the concerns of Grand Lodge he took deep interest. To the boards and committees he gave much time; and in whatever position he occupied Brother Marshall was faithful in the performance of duty, bringing business ability and moderate and reasonable judgment to the solution of every question, and exhibiting true courtesy in all of his dealings with his Masonic associates, and this

may be said of him in all his work in connection with the fraternity. He was one of the most active promoters of a scheme to build in St. John a Temple worthy of the Craft, was among the first projectors of this Hall in which we are assembled, and from its formation until the day of his death was a member of the Board of Directors. Connected with every branch of the Masonic system, he filled high positions acceptably to his brethren, not only in this Province, but, in governing bodies with authority, over the whole Dominion. Everywhere brethren who were acquainted with him bore testimony to his zeal and earnestness and his devotion to the interests of our Society. Gentle, kind and charitable in his nature, he exhibited many attractive traits of character, and those intimately associated with him in Masonic labor will long remember the excellent qualities by and through which he deservedly won an honored place in the affections of our brotherhood.

I recommend Memorial pages in our proceedings in respect and honor of these departed brethren.

Sorrow has not come to us alone, for our sister jurisdictions have also been called upon to mourn the loss of many brethren of eminence and ability, and to such Grand Lodges we extend our sympathy. Official notification has reached me of the death of the following:

S. Stacker Williams, Past Grand Master of the Grand Lodge of Ohio, died April 3rd, 1904.

Joseph Alvah Locke, Past Grand Master of the Grand Lodge of Maine, died April 21st, 1904.

Charles Clarence Warner, Past Deputy Grand Master of the Grand Lodge of Arizona,, died June 13th, 1904.

George T. Cooper, Deputy Grand Master of the Grand Lodge of Colorado, died June 20th, 1904.

Since our last communication a Commission has been received designating W. Brother Hugh H. McLean, K. C., of The Union Lodge of Portland, No. 10, Saint John, to represent the Grand Lodge of Texas near the Grand Lodge of New Brunswick, in the place of R. W. Brother John A. Watson, deceased.

On the death of R. W. Brother Robert Marshall, the representative of the Grand Lodge of Italy, near this Grand Lodge, I recommended V. W. Brother Edwin J. Everett, of Albion Lodge, No. 1, Saint John, as his successor.

R. W. Brother Benjamin S. Black, the representative of the Grand Lodge of South Carolina near this Grand Lodge, having resigned on removing from this Province, I recommended W. Brother Frederick J. G. Knowlton, of The Union Lodge of Portland, No. 10, to be appointed in his place.

Upon the recommendation of the Most Worshipful the Grand Masters of their respective Grand Lodges, I have made the following appointments, namely: R. W. Brother William James Bowser, of Vancouver, as our representative near the Grand Lodge of British Columbia, in place of M. W. Brother William Downie, who now resides in the City of Saint John, in this Province.

W. Brother Tandy A. Dunn, of Bethany, as our representative near the Grand Lodge of Missouri, in place of William R. Stubblefield, whom the Grand Master of that State stated was the representative of the Grand Lodge of Manitoba, and that New Brunswick was not represented.

W. Brother Johannes Longo, of Dresden, as our representative near the Grand Lodge of Saxony.

R. W. Brother Emil Jessien, as our representative near the Grand Lodge of Hamburg in place of G. A. Laeisz, deceased.

I was officially notified by the Grand Lodge of Wyoming, that that Grand Lodge had some years ago abandoned the system of grand representatives.

I am pleased to congratulate our newly appointed representative near the Grand Lodge of British Columbia on his election a few months ago to the office of Grand Master of that Grand Lodge.

Requests from The Grand Orient and Supreme Council of Brazil, and the Grand Lodge of Queensland, Australia, for recognition and an exchange of representatives, were referred to the Committee on relations with Foreign Grand Bodies.

The visitation of Lodges has lost none of its interest to me, and after the experience of three years, I am firmly

convinced that until the District Deputy Grand Masters can be induced to make frequent visits to the Lodges in their Jurisdiction, and of this I will speak later, the Grand Master, assisted by his officers, should do that work. The fact that such a visitation will take place, and that the Worshipful Master and his officers will be called upon to confer or exemplify a degree arouses in them a deeper interest in their Lodge, and influences them to make a more determined effort to acquire a closer knowledge of the ritual. It is well known that our District Deputies do not visit the Lodges in their Districts even once a year, and that too frequently they have not the acquaintance with the ritual which would enable them to correct errors or instruct officers in their work. During my term of office I have, accompanied by one or more Grand Officers, visited every Lodge in our Jurisdiction at least once, and many of the Lodges more frequently. On every occasion we have found that our visitation was looked forward to with interest by the members of the Lodge, and that every effort was put forth to give us pleasure, and to be prepared to work a degree satisfactorily.

These visitations have, I believe, been of great service to the Craft, not only in harmonizing the work in the different sections of the Province, and in correcting the errors that necessarily creep into the ritual in Lodges which do not have frequent opportunities of receiving instruction, but also in strengthening the cordial relations that exist between this Body and its subordinates.

The social hour spent by the brethren in the banqueting hall at the close of each visitation has also been of value, as well as of pleasure, although I have sought to discourage Lodges from providing entertainments at great expense and trouble. Light refreshments in the Lodge or the adjoining banquet room meet every call of hospitality, and afford the desirable opportunity for the Grand Officers and the members of the Lodge to become personally acquainted with each other. I desire to heartily thank the brethren of each

and every Lodge for the courtesy and kindness extended to myself and those accompanying me in this respect. We have in this way been enabled to form many warm and I hope lasting friendships.

Accompanied by Past Grand Masters John V. Ellis and Thomas Walker, M. D., and a large number of Grand and other Past Grand officers, I made my first official visit of the year to The Union Lodge of Portland, No. 10, on the 4th of November, 1903. The Worshipful Master Frederick J. G. Knowlton was in the chair. There was a very large number of members and visitors present, and we were given a most cordial reception. When referring to Worshipful Master Brother Knowlton and his fellow officers at their installation last year I stated that this Lodge had fallen into good hands. The results of the deep interest taken by them in the welfare of the Lodge, and the skill and ability with which the work of conferring degrees during the year has been done, more than fully justified my remark. During the evening the Master Mason's degree was conferred upon two candidates. I was glad to be able to compliment the Worshipful Master and his officers on the very efficient and impressive manner in which the work was rendered. Careful preparation and a strong regard for due solemnity in the ritual were apparent. The brethren of this Lodge are full of Masonic zeal, and as a result the Lodge is in a very prosperous condition.

By request I visited Carleton Union Lodge, No. 8, on the 28th day of December, A.D. 1903, accompanied by a number of Grand and Past Grand officers, for the purpose of installing its officers for the ensuing year. W. Brother H. Colby Smith had been re-elected Worshipful Master. I have a most pleasant remembrance of my former visits to this Lodge, when admirable work was done by the present Master and his officers. A very pleasant feature of the evening was the presentation to the Lodge by Past Master Daniel C. Clark of an excellent portrait of the Earl of

Zetland, whose name will forever be associated with the growth and elevation of the Grand Lodge of England, and under whose hand, as Grand Master, warrants were issued for the institution of this and several other Lodges in this Province. This Lodge has a record for possessing the true Masonic spirit, and with its renewed prosperity and the excellent feeling and enthusiasm among the brethren, there can be no doubt about its future.

On the evening of the 5th January, 1904, accompanied by a staff of Grand and Past Grand officers, I visited St. John's Lodge, No. 2, and installed its officers. There was a good attendance of members and visitors. W. Brother Henry Dunbrack, who was placed in the East, must look well to his laurels. The record of this Lodge is an excellent one, and the brother who is elected its presiding officer must ever bear in mind its past traditions and work, covering more than a century. The Worshipful Brother is well known for his earnestness and possesses the confidence of his brethren, and I have no fear that with the assistance of his excellent corps of officers—several of whom are already recognized as good ritualists—he will ably sustain the reputation of this old Lodge.

On the evening of the 14th January, 1904, accompanied by Past Grand Master John V. Ellis and a large number of Grand and Past Grand officers, I visited New Brunswick Lodge, No. 22, for the purpose of installing its officers for the ensuing year. The Grand Lodge was received in a royal and enthusiastic manner. There was a good attendance of members and visitors. Brother Alexander H. Campbell, a bright and clever young man—one of the youngest members of the Lodge—had been elected Worshipful Master. It was a very pleasing incident in the ceremony of installation that the Worshipful Brother was placed in the East by his father, R. W. Brother Alexander R. Campbell, a well-tried and enthusiastic worker in the Craft. This Lodge has on its roll some of our most earnest and painstaking Past Masters,

brethren who can be found at nearly every regular Masonic meeting in the city, and who are ever ready and able to give assistance in the working of the degrees. The young Worshipful Brother will not, I am sure, allow the reception of the highest honor which a Lodge can bestow, to lessen his interest in Freemasonry.

On the evening of the 12th January, 1904, accompanied by a large number of Grand and Past Grand officers, I visited Hibernia Lodge, No. 3, by request, to instal its officers for the ensuing year. There was a large number of members and visitors present, and we were accorded a most fraternal welcome. Brother Frederick C. Jones—the Worshipful Master elect—and an excellent staff of working officers, were duly installed. The growth and prosperity of this Lodge are well known. It has always been noted for the warmth and enthusiasm of its members. Exceedingly good work has been done by the Masters of this Lodge, and we have the earnest hope that the Worshipful Brother who has been honored this year, will not allow the spirit of Masonry or the record of the past to wane or be impaired. An enthusiastic Master begets enthusiasm among the members of a Lodge.

On the 16th of January, 1904, I visited Lebanon Lodge, No. 28, at Sackville, accompanied by Past Deputy Grand Master William B. Wallace, and V. W. Brother J. Twining Hartt, the Grand Secretary, at the request of W. Master Daniel Jordan, for the purpose of installing its officers. There was a good attendance of the members. We also had the pleasure of meeting several of the brethren from Acacia Lodge, Amherst, N. S. Assisted by R. W. Brother Wallace as Grand Director of Ceremonies, I duly installed Brother Thomas Murray, the Worshipful Master elect and his officers. This Lodge, although small in numbers, has since its reorganization done good work. The efficiency of the work and the enthusiasm of its members are largely due to the energy of our good brother Past Master Daniel

Jordan. Worshipful Master Murray does not lack in ability or zeal, and if there is any falling off in the prosperity of Lebanon Lodge it will be, I believe, owing to a cause over which he has no control.

On the 4th of March, 1904, I visited Albion Lodge, No. 1, accompanied by Past Grand Master John V. Ellis and R. W. Brother Benjamin Allen, then Deputy Grand Master, now Most Worshipful Grand Master of the Grand Lodge of Canada in the Province of Ontario, and a large number of Grand and other Past Grand officers. We were received very cordially. The Worshipful Master, W. Leonard Ellis, M. D., was in the chair. The attendance of members and visitors was large. The second degree was conferred upon one candidate by the Worshipful Master, assisted by his excellent staff of officers. This Lodge is first on the roll of Lodges, and its officers have never failed to endeavor to make it second to none in the correctness and impressiveness of its work. The keen emulation among the city Lodges to present the best work in conferring each degree has resulted in very great excellence of work in most of the Lodges. W. Brother Ellis has a still stronger call upon him for zeal and earnestness, for he is a son of R. W. Past Grand Master John V. Ellis, the well known and distinguished Mason.

Accompanied by a large number of Grand and Past Grand officers, I again officially visited The Union Lodge of Portland on the 4th of May, 1904, for the purpose of seeing its new Worshipful Master, J. Edgar March, M. D., and his staff of officers confer the third degree. There was a very large attendance of members and visiting brethren, and we were given a splendid reception. The work was done very accurately and impressively, showing very careful, thorough and accurate knowledge of the ritual. This Lodge deserves much credit for the great interest which its officers have taken in seeking to present our ritual in a perfect manner. They have not only sought to give the words with accuracy, but to impress the candidate with the meaning and intention

of the degree, and in a great measure have succeeded. I was particularly well pleased with the floor work, and I have pleasure in complimenting the officers on their skill and ability. W. Brother March is an admirable leader and his officers, inspired by his enthusiasm, gave him good support. There was an excellent choir and the degree was rendered with musical accompaniments, which greatly added to its effectiveness.

On the 20th of July, 1904, accompanied by the Very Worshipful the Grand Secretary, I went to Albert County to visit the Lodges in that part of the Jurisdiction. We were joined at Albert by Past Grand Chaplain Rev. Allan W. Smithers. In the evening we visited Albert Lodge, No. 34. On account of the absence of the Worshipful Master Charles S. Paterson, Past Master James E. Fullerton was in the chair. The attendance was small, but it appeared that there had been a large addition to the Lodge during the past year, and that the new members were taking an active interest in the working of the degrees. An hour or two was pleasantly and profitably spent by the officers exemplifying portions of the third degree under the direction of the Grand Secretary. We were glad to find a greater interest was being taken in the Lodge than on our former visit. The absence of the Worshipful Master was regrettable.

On the following evening, July 21st, 1904, we visited Howard Lodge, No. 15, at Hillsboro. We were most cordially received. There was a large attendance of members, but no work. The Worshipful Master, Abram Sherwood, occupied the chair. This Lodge is in a very prosperous condition. Portions of the third degree were exemplified, and the Grand Secretary spent an hour instructing the Brethren on opening and closing the Lodge and on the floor work of the degrees. The officers and brethren evinced much zeal in the work, and I have no fear that this Lodge, with its active membership, will be allowed to suffer for lack of interest. The visit was much appreciated by the officers and members

of the Lodge. Our good brother, Past Grand Chaplain Rev. Allan W. Smithers, is deserving of special commendation for the interest that he has shown in the welfare of Howard and Albert Lodges.

On the 25th of July, 1904, accompanied by the V. W. the Grand Secretary, J. Twining Hartt, W. the Grand Director of Ceremonies, Henry S. Bridges, and Worshipful Brothers James E. Stewart and Reverend George A. Leck, of Restigouche Lodge, I visited Campbellton Lodge, No. 32, at Campbellton. We received a very cordial welcome. The Worshipful Master Brother Dugald C. Firth, Past Deputy Grand Master, was in the chair. The third degree was conferred in a very satisfactory manner. The Brethren acted wisely in placing in the East one who had shown such deep interest, not only in his own Lodge, but in the advancement of Freemasonry generally. It would be difficult to find a more deserving and faithful brother. Among those present was Past Masters John McAllister, John White and J. P. Jardine, who very justly possess the respect and confidence of their brethren.

I visited Restigouche Lodge, No. 25, at Dalhousie, on the 26th July, 1904, V. W. the Grand Secretary and the W. the Grand Director of Ceremonies being with me. The Worshipful Master W. Brother Claude Brown being unavoidably absent, W. Brother Past Master James E. Stewart was in the East. The day had been extremely hot, and the Lodge room in the evening was uncomfortably warm. With the assistance of the Grand Secretary the third degree was conferred. The regular officers who were present did their work very well. The Lodge is not large, and I feel that its prosperity must depend to a great degree upon the zeal of its Past Masters and the interest they may take in its welfare. I trust that these brethren will by their constant attendance at its regular meetings give encouragement to the younger members. W. Brother James E. Stewart is a pillar of strength to it. His son was the candidate during the evening.

On the 11th August, 1904, accompanied by the V. W. the Grand Secretary, and W. Brother Henry S. Bridges, the Grand Director of Ceremonies, I went to Andover for the purpose of visiting Benjamin Lodge, No. 31. W. Brother John McKenzie, the Deputy Grand Master of that District, and Brother Dr. Guy B. Manzer, of Woodstock Lodge, joined us on our way up the river and added greatly to the pleasure of our visit. We found the Lodge in a very prosperous condition, and we were much gratified to learn that the Brethren of Andover had recently purchased ground in a central spot and were making preparations for building an elegant Hall. The Lodge deserves much credit for its activity. W. Brother Stanley Sutton, the Worshipful Master, presided in the East, and with an excellent staff of officers conferred the third degree in a very creditable manner. Among the Past Masters present were W. Brothers J. Allen Perley, Senator George F. Baird, Benjamin Kilburn, Joseph B. Porter, Alexander Straton and Thomas Lawson—all ready and qualified to assist in working the degree. This was my first visit to Benjamin Lodge, and I was delighted to find the interests of Freemasonry in this locality so well guarded.

The next evening, August 12th, 1904, I made my second visit to Woodstock Lodge, No. 11, at Woodstock, along with the Grand Chaplain, V. W. Brother Rev. George D. Ireland, the V. W. the Grand Secretary, the Worshipful the Grand Director of Ceremonies and W. Brother George W. Rothwell of Ashlar Lodge. We received a hearty welcome. There was a very large attendance of the members of the Lodge. The Worshipful Master W. Brother John McKenzie, who is also Deputy Grand Master of this District, occupied the chair, and assisted by his well skilled and well drilled officers and Past Master Emerson L. Hagerman, conferred the first degree upon two candidates in a very efficient and impressive manner. The floor work was especially well done, and testified to the care with which the Master had instructed

his officers. Woodstock Lodge is the banner Lodge of the Province in regard to membership and wealth, and if the other Lodges in the Jurisdiction do not look well to their laurels, Woodstock Lodge will soon stand highest for the excellent character of its work. Its lodge room is large and beautifully furnished, and with such active and skilled craftsmen as the present Master, R. W. Brother Donald Munro, whom I find still acting as Secretary, W. Brother Emerson L. Hagerman and others whom I might mention, in constant attendance at its meetings, splendid results may be expected.

An Emergent Communication of Grand Lodge was summoned and duly held at the Masonic Temple, in the City of Saint John, on Sunday, the 26th day of June, 1904, for the purpose of attending Divine service. There was a very large attendance of the brethren of the city Lodges, and of Corinthian and Zion Lodges, besides many brethren from other parts of the Province. The zeal of the brethren of Corinthian and Zion Lodges in providing a special train and in coming in such numbers is very commendable, and I, as well as the other officers of Grand Lodge, fully appreciated their ready response to the call of this body. A procession most creditable in size, appearance and conduct was formed under the direction of W. Brothers the Grand and Assistant Grand Director of Ceremonies, and Grand Lodge marched to St. Stephen's Church, where service was conducted by V. W. Brother the Grand Chaplain, assisted by V. W. Brother Past Grand Chaplain Donald MacRae, D. D. An able and instructive sermon was delivered by the Grand Chaplain, the text being "Trust in the Lord and do good" (Psalm xxxvii: 3). The offertory, amounting to \$75, was in aid of The Home for Incurables. At the conclusion of the service the procession was reformed and the brethren returned to the Temple, where appropriate resolutions were passed thanking the Trustees of Saint Stephen's Church for the use of the building, and the Grand Chaplain for his admirable sermon. In this connection I

most heartily thank the officers and Knights of St. John Encampment, and those of DeMolay Preceptory who so generously joined them, for their thoughtfulness in giving a splendid escort to Grand Lodge in the procession. The presence of the Sir Knights added very materially to the appearance and effect of the ceremony.

Many questions have been submitted me during the year by the various Lodges, and in every case it was only necessary in reply to suggest the proper course to pursue or to call the attention of the brethren to the constitution and existing regulations of the Grand Lodge.

A number of the usual and ordinary dispensations have been granted. They will be found in the Report of the Grand Secretary.

I desire to thank the Board of General Purposes for having placed in our proceedings of last year, and thus laid up on perpetual record, the faces of our esteemed Past Grand Masters William Wedderburn and John V. Ellis. It may be a small matter, but the practice is an excellent one, and will, I trust, be continued until we have portraits of all Past Grand Masters available for future reference.

Mrs. Robert Marshall, the widow of our late and much respected Past Grand Master Robert Marshall, has donated his beautiful Grand Master's apron to Grand Lodge. I accepted the gift on behalf of the Grand Lodge, and now suggest that a formal acknowledgment of acceptance of the apron be forwarded to the donor.

The reports of the District Deputy Grand Masters will be laid before you. In respect to these officers, I am pleased to be able to report that the Board of General Purposes, to whom the question of procuring suitable regalia for official use by District Deputy Grand Masters was submitted, has extended its report so as to cover the status of these officers of Grand Lodge. I most heartily recommend that the suggestions of the Board be adopted. Outside of the Grand Master, there is no more important officer in connection

with Grand Lodge than the District Deputy Grand Masters. If their work is not faithfully done, Masonry suffers. I do not know the practice in other Grand Lodges, but I do know that until some reward other than the mere fact of their being Deputies for a year is bestowed upon them they cannot justly be expected to do a much greater and more useful work than any other officer is called upon to perform. Deacons, Sword Bearers and Standard Bearers, who have little or no duty, have past rank. It is impossible for me to conceive any good reason why a similar honor should not be bestowed upon brethren who are called upon to give both time and means for the advancement and promotion of the interests of our Grand Lodge, and upon whose faithful discharge of their duties the welfare of the Private Lodges, and indirectly the welfare of Grand Lodge, so largely depend. I would most respectfully suggest that you give this matter your careful consideration, and if necessary amend our constitution so as to carry out the suggestion of the Board.

I also recommend that Grand Lodge place the usual sum of two hundred dollars at the disposal of the Grand Master for the instruction of the Lodges.

When I accepted the office to which you kindly elected me three years ago I did so with a full appreciation of the duties and great responsibilities that fall upon one who presides over this Grand Lodge, and also with a feeling of diffidence when I considered how many well-tried and prominent Masons had been my predecessors, who, when building the edifice of Freemasonry in this Province, had well laid its foundations. I felt, however, that the very success of the former Grand Masters was a guarantee to me that the true Masonic spirit prevailed, and that I would receive the co-operation of every member in the discharge of those duties and in meeting those responsibilities. In this I made no mistake, for at the end of a term of three years I have to make acknowledgment of a genuine and loyal

support from nearly every officer and individual of this body. The position has been one of pleasant associations and memories. Let us then, Brethren, cultivate and cherish a spirit of devotion to those principles of religion and morality which our institution teaches, and let us hand over to those who follow us not only our robes of office pure and untarnished, but an institution free from the promotion of ends personal to ourselves, and inspired by but a single purpose, the promotion throughout the world of the essential qualities of true manhood.

Before closing I desire to express my warm appreciation of the many courtesies which have been extended to me by my brethren during the term that I have had the honor of presiding over this Grand Body. I have sought to perform the various duties of the office to the best of my ability, and where my personal professional duties came into conflict with my duties as Grand Master, I have as far as I was able thrown aside personal matters and given my duties as Grand Master the precedence. The office is an honorable one, and it may well be the ambition of every member of Grand Lodge to hold it. That, however, is impossible, but it is possible for every brother to do what in him lies to cultivate good fellowship, to maintain the dignity and to advance the principles of the Craft. By doing this he will have the reward of seeing brotherly love, relief and truth prevail, a result which should be the highest aim of every good Mason. I desire to thank the officers and members of Grand Lodge who have so often and so willingly assisted me in the performance of my duties. If my term of office has been marked by any growth or measure of prosperity in the fraternity it is due to the officers and members who have given me a loyal support. I would specially mention our Grand Secretary, V. W. Brother J. Twining Hartt, who has not only performed his duties faithfully and to my entire satisfaction, but who has so willingly and generously responded to every request for advice and counsel. I would

also like to call the attention of the brethren to the very valuable and continuous services rendered by the Grand Secretary to Grand Lodge, and in view of the time and labor required for the discharge of his duties I would strongly urge that the salary paid him be increased.

Brethren, give my successor the same kind consideration and help that you have given me and there need be no fear for the future of Grand Lodge.

And now, brethren, let us enter upon the discharge of the duties which devolve upon us with the earnestness and devotion that our beloved institution demands, ever bearing in mind that the Grand Architect is watching over us. May His guiding hand so control us that whatever is done will result in promoting the honor and prosperity of the Craft throughout the jurisdiction.

REPORT OF BOARD OF GENERAL PURPOSES.

The President of the Board of General Purposes, the R. W. Deputy Grand Master, presented the Board's report for the year, and on his motion it was received and laid on the table. It was as follows:

To the M.W. GRAND LODGE, F. & A. M., of New Brunswick:

The Board of General Purposes presents the following report respecting matters which have received its attention during the past year:

The Board has held five meetings, at the first of which, on September 17th, 1903, it organized by electing W. Brother David Dearness, P. A. G. D. of C., its Vice-President.

In accordance with the Board's resolution, an edition of six hundred copies of the Proceedings of 1903 was printed in much the usual form and distributed as has been the custom. Following the action of the preceding year, steps were taken to procure the photographs of Past Grand Masters Wedderburn and Ellis, and these were reproduced and inserted in the Proceedings. The Board entertains the hope that in due course of time Grand Lodge will possess the portraits of all its Past Grand Masters, to be so preserved in its records.

An order for two hundred and fifty parchment certificates was placed with the British American Bank Note Company, of Ottawa, and the same was filled in November last. This supply has, however, recently become exhausted, and it was found necessary to place an order for a similar number, one hundred of which have already been received.

The matters referred to the Board by Grand Lodge at the last Annual Communication were four in number, viz.: (1) That of Trustees for Subordinate Lodges; (2) The proposed amendment to the Constitution permitting of dual membership and its bearing upon the provisions of

the Constitution; (3) The matter of preparing and publishing a digest of the Proceedings of Sister Grand Lodges, and (4) The procuring of regalia for the use of District Deputy Grand Masters. The Board has given to these matters due consideration, and now begs to report its views.

The first matter was originally referred to by the then Grand Master, R. W. Brother J. Gordon Forbes, in his address in 1901, when he suggested that a General Act of the Legislature be obtained, by means of which Masonic Halls could be held for the Craft even though the Lodges owning these halls should cease to exist.

The Board has not been able to satisfy itself that at the present time any such legislation is desirable, and it so advises Grand Lodge.

Nevertheless, examination of the question has impressed the members of the Board with the great importance of the subject. There are now in the Province several Masonic Halls, the property of Lodges, held principally in trust. The Board recognizes the possibility that these trusts are not always effective, that the appointment and reappointment of Trustees may not be kept up, that vacancies occurring may not be filled, and that in time the title by which the property is held may be impaired or become quite obscure. It is advisable, therefore, for all Lodges which own real property to carefully look into the matter, and to see if it be not possible to obtain incorporation for Trustees by special legislation, or by a company organization in some form under the Joint Stock Companies Act, which will enable the property to be held perpetually for the use and benefit of the Craft or to be readily transferred should it be so desired. There should be no delay or unnecessary postponement of this important matter, and each Lodge ought to be in a position to deal with it for itself in a business-like manner.

The Board suggests that this matter be brought directly to the notice of the Lodges in such a way as the V. W. the Grand Secretary may find most convenient; and, further, that that officer be requested to ask for a special return from

each Lodge next year, showing whether it owns or holds real estate, how held, the estimated value of the property, and the nature and amount of any charge or incumbrance upon it.

As to the second matter, the Board is of the opinion that the adoption of the amendment to strike out Sec. 19 of "Private Lodges" would not conflict with any other provision of the Constitution save that in Section 1 of "Proposing Members," where it is provided that a certificate of his former Lodge shall be produced when a brother is to be balloted for. The Board therefore suggests that should Grand Lodge adopt the above amendment, the words in the seventh line of this Section, "the certificate of his former Lodge," be struck out, and the words "satisfactory evidence of his Masonic standing," be inserted in their place.

As to preparing and publishing a Report on Foreign Correspondence, the members of the Board were not unanimous in their views, but the following resolution was finally carried and is now submitted as the Board's recommendation, namely: That it is not desirable to depart from the practice of Grand Lodge in this matter.

In reference to District Deputy Grand Masters, the Board has gone beyond the subject referred to it, namely, that of regalia, and has considered the status of these officers and their jurisdiction, and having done so it respectfully advises that District Deputy Grand Masters being appointed officers of Grand Lodge with some responsibility, should be given rank immediately preceding the Senior Grand Deacon, with the title of "Worshipful." The clothing should be, in color and style, the usual clothing, the collar and apron, of a Grand officer, the emblem of office to be a square within a circle, suspended as in the case of other office-bearers from the collar, and a representation of the Jewel may be worn on the apron. Past District Deputy Grand Masters should be allowed rank immediately after the District Deputy Grand Masters and be entitled to wear the clothing, but not the emblem of office pendant from the collar; if an emblem of

the past rank be worn it is to be the square within the circle, but in the form of an oval locket jewel and upon the left breast.

The Board is of the opinion that—having regard to the limited general duties of the office in such a small jurisdiction as that of New Brunswick—the number of Districts had better be reduced from five to three, and as is the case now, no District Deputy to be appointed for the District in which the Deputy Grand Master resides. If Grand Lodge adopts these suggestions the matter of re-arranging the Districts might be left to the Board, the Grand Secretary in the meantime, under its direction, to give notice of the necessary amendments to the Constitution to carry them into effect at the next Annual Communication of Grand Lodge.

The Audit Committee has presented its report upon the accounts of Grand Lodge, and the Board, having adopted the same, herewith embodies it:

That Grand Lodge do not concur in the action of Hibernia Lodge, as it is of the opinion that a Subordinate Lodge has no power to confer the rank of Past Master upon a Brother who has not regularly passed the chair of his Lodge.

Grand Lodge then took recess.

TUESDAY EVENING,

August 23rd, 1904.

Grand Lodge resumed Labor at eight o'clock, the M. W. Grand Master in the East.

W. Brother W. Alder Trueman presented his credentials as representative of the Grand Lodge of Costa Rica. The Commission was dated at San Jose, April 8th, 1902, and signed by Edmund A. Osborne, Grand Secretary.

W. Brother Fred J. G. Knowlton, Grand Pursuivant, presented his credentials as representative of the Grand Lodge of South Carolina. The Commission was dated at Charleston, August 19th, 1904, and signed by Charles Inglesby, Grand Secretary.

After the Commissions had been read, the two representatives were presented to the Grand Master, who welcomed them on behalf of Grand Lodge, and called for the Grand Honours.

Both the Worshipful Brothers spoke briefly in acknowledgment.

It being now 8.30 o'clock, Grand Lodge proceeded to the order of the day—the election of Grand Officers.

The Grand Master appointed as Scrutineers R. W. Brothers Alexander R. Campbell, P. G. W., John McAllister, P. G. W., and W. Brother Frederick H. Wetmore, M. D., who thereupon took the customary obligation.

Moved by R. W. Brother Thomas Walker, M. D., P. G. M., seconded by R. W. Brother The Hon. J. V. Ellis, P. G. M.:

That the Report of the Board of General Purposes be taken from the table and considered section by section.

Carried.

The several sections of the report were read and adopted *seriatim*, and then on motion of R. W. Brother Thomas Walker, P. G. M., and W. Brother Henry S. Bridges, G. D. of C., it was resolved:

That the report of the Board of General Purposes, as a whole, be adopted and entered on the minutes.

Also, on due motion it was ordered:

That the reports and statements of the Grand Treasurer and Grand Secretary be taken from the table and filed.

The Committee on the Grand Master's address presented their report, and the Chairman, R. W. Brother His Honour

Judge Forbes, P. G. M., after reading it, moved, seconded by W. Brother Henry S. Bridges, G. D. of C.:

That the report be received, adopted and spread upon the minutes.

Carried.

The following is the report:

REPORT ON THE GRAND MASTER'S ADDRESS.

To the M.W. Grand Lodge of New Brunswick:

Your Committee, to whom the Grand Master's address was referred, beg leave to report:

That they have carefully examined the same and its various recommendations. They beg leave to congratulate Grand Lodge on the conscientious and intelligent manner in which your Grand Master has performed the duties connected with his high office, and the very able and statesman-like account of his stewardship that he has rendered to Grand Lodge.

The arduous task of visiting the several Subordinate Lodges entails a vast amount of labor, and to a professional man this is a great sacrifice. We fully realize the importance of this work. In order to keep in touch with the life and work of Grand Lodge this labor must be attended to if growth and activity are to be sustained; and we congratulate Grand Lodge and the Grand Master on the faithful discharge of this important duty.

We also congratulate Grand Lodge on the harmony and concord which prevails within its borders, and the happy relations which have been maintained with Sister Grand Lodges. How much of this is due to the wisdom and judgment of the Grand Master, you can estimate and appreciate.

Grand Lodge joins with the Grand Master in his tribute to the worth and eminence of our departed brethren in this and other jurisdictions, and when we pause for a moment and survey our depleted ranks, remembering that this place that now knows us will soon know us no more. That here we, too, have no continuing city. Let us so build character on the Free Masonic foundation, "Faith, Hope and Charity," that when the Master Builder comes to inspect our work we may hear His words of commendation, "Well done, good and faithful servant;" and so, while we deeply sympathize with those who have sustained a personal loss, yet as Masons, who have the Holy Bible as the light on our altar, we mourn not as those without hope.

Your Committee would earnestly direct the attention of Grand Lodge to the timely suggestions of the Grand Master as to the duties and rank of District Deputy Grand Masters; yet they believe the visit of the Grand Master and his officers will still be necessary to stimulate the Craft in well-doing, and we earnestly trust the new Grand Master may emulate the zeal and supervision of our Brother now retiring.

Grand Lodge joins with the Grand Master in appreciating the worth and Masonic skill of our Very Worshipful Grand Secretary, and the aid and services he has rendered to the Craft in the past. They regret that the state of the finances of Grand Lodge will not permit them to recommend such an addition to his salary as in their judgment would be a fair recompense for the services he is now rendering. They, however, recommend that the sum of \$100 be added to the salary of the Grand Secretary for the present year.

Grand Lodge would desire to place on record their due appreciation of the great services rendered to Grand Lodge by the retiring Grand Master. Faithful in the discharge of every duty; firm and wise in his rulings; vigilant and watchful over the Craft, our Grand Master lays down the gavel of his office retaining the love and esteem of every

member of Grand Lodge and the assurance that in his hands the gavel so ably wielded by his predecessors has in every way been controlled by a master hand, and that he has fully justified the thrice repeated choice of his brethren.

We concur in the recommendation of the Grand Master to continue the grant of \$200 for the matter of instruction.

R. W. The Hon. John V. Ellis, P. G. M., presented a report of the Committee on Foreign Relations, and the same having been read, he moved:

That the report be received and adopted and entered on the minutes.

The motion was seconded by R. W. Brother His Honour Judge Forbes, P. G. M., and was carried.

To the M.W. Grand Lodge of New Brunswick:

The Committee on Relations with Foreign Grand Lodges reports that among papers submitted to it are some printed documents signed by "James Walter Smith, Grand Master," and "John William Smythe, Grand Secretary," impugning the standing of the Grand Lodge of Western Australia, founded in the year 1900 and recognized as a legally formed Grand Lodge by the Grand Lodge of New Brunswick. Our representative at the Grand Lodge of Western Australia is R. W. Robert Wigglesworth, of Perth, and its representative with us is R. W. Brother Daniel Jordan, of Sackville. An examination of their papers furnishes no sufficient reasons to assume that the body which the first named gentlemen represent was a regularly formed Grand Lodge. Your Committee do not, therefore, think it necessary to do more than state the fact.

The Committee has also examined a pamphlet setting forth the proceedings connected with the formation and inauguration of the Grand Lodge of Queensland. This Grand Lodge was formed by about twenty-five Lodges under the Irish constitution and fourteen under the Scottish constitution, say about forty Lodges in all. Apparently there are in the State of Queensland one hundred and forty Lodges. It is not quite clear to your Committee whether or not the English Lodges were asked to unite in the formation of this Grand Lodge. The Grand Lodge was formed on April 25, 1904. R. W. Brother George Samuel Hatton, Past Provincial Grand Master under the Irish constitution, was elected Grand Master, and a brother of the same constitution was elected Deputy Grand Master. The Committee is impressed with the general regularity of the proceedings attending the formation of the Grand Lodge by those who carried them on. But it seems to be a fact that a minority of the Lodges, none of them on the English constitution, participated in the movement. The Committee, therefore, ask time before making a final report on this subject, so that, if possible, the general views of the majority of the Craft in Queensland on the whole subject may be ascertained.

On motion Grand Lodge proceeded to the installation of officers for the ensuing year, when Very Worshipful Brother Edwin James Everett, Grand Master elect, was invested and installed by R. W. Brother Arthur I. Trueman, P. G. M., and was saluted and proclaimed: "Most Worshipful Grand Master of the Antient and Honourable Fraternity of Free and Accepted Masons of New Brunswick."
