#### GRAND MASTER'S ADDRESS.

#### BRETHREN OF GRAND LODGE:

As the Grand Master of the "Antient and Honourable Fraternity of Free and Accepted Masons of New Brunswick," I stand before you on this the Fifty-Second Annual Communication, and extend a most hearty welcome to the assembled members of the Craft.

We have come together to transact the routine business of Grand Lodge, and to join in deliberation and work. I sincerely trust that our associations may be pleasant and that nothing may occur to mar our good fellowship.

Having completed a second term as Grand Master of the Masonic Order, it becomes my duty to give an account of my stewardship. In doing this I can truthfully say, I have exercised my best judgment in dealing with the duties of the office, and will feel well rewarded if the members of the Craft are satisfied. I now beg leave to present my report.

Last year I made mention of the awful world tragedy, and humbly offered a prayer to the Supreme Ruler of the Universe, that He, who determines destiny, might see fit to bring peace to our troubled world before another annual meeting of Grand Lodge. In His all wise Providence Almighty God has been pleased to bring the terrible war to a close, and we meet tonight in a world brooded over by the Dove of Peace.

From the genesis of our noble Order, in the dim ages of antiquity, until the present time, there have been no more momentous happenings than those which led to the signing of the armistice and the results of the subsequent peace conference.

Last spring, Germany made her supreme bid for victory. Ludendorf and Hindenburg, the master strategists of the Teutonic peoples, launched a mighty offensive against the western front. It was their purpose to separate the British from the French army. They almost succeeded. Victory for them and defeat for us wavered in the balances, but the wonderful valor of British and Allied troops, led by General Foch, assisted by Generals Haig and Pershing, together with the direction and blessing of Almighty God, turned apparent defeat into glorious victory. Germany was forced to ask for an armistice, thus confessing her defeat.

One of the spectacular incidents that grew out of this, was the surrender of the German high seas fleet to the British and United States navies. An impressive tribute to the efficiency and power of the mighty protecting navy that for over four years kept ceaseless vigil of the seas and made victory possible.

As members of the "Antient and Honourable Fraternity of Free and Accepted Masons," we humbly thank God for having freed the world from the menace of militarism, and given democratic freedom to the free peoples of the world.

Standing here on the threshold of world peace, it would seem fitting that we frankly face the new problems that peace has brought, and ask what should our attitude as Masons be? And when I say "as Masons," I mean as good citizens, for a good Mason is always a good citizen. The main pillars of our Order spells good citizenship, and I take it that we as good Masons are desirous of helping to better present day conditions.

For four years our leaders have told us that the end of the war would usher in new world order; that the relationships of life would be readjusted; that democracy would express itself in different terms. We are beginning to realize that this is true, and that in the period of readjustment we face strenuous days.

We look across the seas and we behold radical socialism and anarchy, under the guise of Bolshevism; we sincerely

hope it may stay on the other side and may not be permitted, even there, to last very long. In the Mother-land there is much of unrest; this is especially true in the labor world; hundreds of thousands have been out on strike. A Scotch labor leader recently made the statement that they were not striking for either wages or hours; if they got what they asked for they would strike again, till they asked what could not be given, they were out to do away with the capitalist class altogether. While this may be an extreme utterance it indicates the feeling of unrest and discontent that is present in the British Isles.

Now while we as Canadians must of necessity be interested in world conditions, our immediate concern is our own country, and it is of this I desire to draw your attention.

During the four years of war, we sent from Canada something like four hundred thousand men. These men are now coming back, already over one hundred thousand have returned since the signing of the armistice. Let us try and get their point of view.

For from one to four years they have been living in the open. They have, as soldiers, been under strict discipline; their actions have largely been controlled by those higher up. Before their enlistment they occupied every conceivable position. They now come back to find that the industrial world is undergoing a period of readjustment. To the man who worked indoors, perhaps in a bank or an office or store, the four walls seem almost a prison compared with the outdoor life to which he has become used, on the other hand they are called upon to take up the work where they laid it down, and it is most difficult.

In most departments of industry and business there have been changes, and things are done differently. They are now called upon to practice a certain new initiative and it is not easy. Many come back with broken health and shattered nerves, they are not normal either mentally or physically. It is true a certain number of the men have had their positions held open, but this is true of only a small proportion, the majority must seek work in the open labor market.

A returned man said only the other day, "I think of things that happened four years ago before I went overseas, as though they happened but last week. I can't seem to realize that four years have dropped out of my life." Another said, "I was a clerk behind a ribbon counter before enlisting, now for two years I have been an officer, commanding large numbers of men; to go back behind the counter is repugnant to me, yet I am not fitted for anything else, but I cannot and I will not go back to measuring ribbons."

So I counsel, that in dealing with returned men, you should practice moderation; and taking the things I have mentioned into consideration, deal kindly with them.

Again we are facing industrial changes and readjustments. The ending of the war closed many war industries, including the munition factories, and threw thousands all over Canada and millions in the Allied countries out of employment. Much material that had been bought by the different governments for war purposes, must now be sold by these governments to be manufactured into various commercial commodities. To give an example: The United States Government found itself, after the signing of the armistice, with one hundred million pounds of copper, which it must sell in the open market; this competes with producing industries. This will mean a slacking off of work and result in non-employment.

It will also take considerable time to change war industries into commercial pursuits. Many of the women who have become experts, will refuse to give up their work and so will compete in the labor market, making it that

much harder for men seeking employment to find satisfactory jobs.

For four years we have been living abnormally. Prices have soared beyond all reason, wages have been raised, till the laborer and the mechanic are receiving remunerations such as were never paid before.

Now we hear a cry, and it is natural, for a speedy lowering of the cost of living. Our best minds are puzzled, not knowing where to begin. If they begin by cutting wages, then the labor world, through their Labor Unions, will organize strikes, for men must have good wages to meet the present high cost of living. If wages are not lowered, many commodities cannot be sold cheaper without bringing a loss to the producer. This is true both with the farmer and the industrial world.

It is to be feared that in this readjustment period, that is just before us, we will pass through strenuous days, and again I counsel you, my brethren of the Masonic Order, to practice moderation and use your influence and energy to help determine our future, with the best interests of all as the primary consideration of each.

There are other vital questions that must be faced, such as the presence of foreigners within our gates. The policies of the political parties and various moral and social issues of vital interest to the community and the nations.

In all of these momentous issues, I feel confident that the members of our noble Order will give their best thought. They will not allow themselves to become extremists, but will use their best endeavors to solve these present and live questions, so as to promote the common good of all, and when issues of outstanding moral quality shall be thrust upon us for our consideration, we will again strive to stand for that which will bring the greatest good to the largest numbers.

Our Order has continued its healthy growth during the past Masonic year. I extend a hearty greeting to those who have been elevated to the honorable position of Master Mason in the various subordinate Lodges within the jurisdiction since our last Annual Communication.

I sincerely hope that the high quality of manhood that has made the Masonic Order outstanding among Fraternal Institutions, may continue to characterize its personnel. I wish to emphasize the necessity of careful discrimination in the admittance of new members, that our future membership may continue to be made up of honorable men.

I would also take occasion to point out to the assembled brethren, that the honor of our loved Order rests on the shoulders of each individual member. "I beseech you therefore, brethren," that ye live worthily. Cultivate the principles of temperance, fortitude, prudence and justice that constitutes the bed rock of Freemasonry.

#### UNVEILING OF HONOR ROLL.

On the fourth day of April I was invited by the Worshipful Master of Keith Lodge, No. 23, in the City of Moncton, to attend the unveiling of an Honor Roll. in memory of the brothers of that Lodge who had enlisted for overseas service during the war.

Accompanied by a large number of the officers of Grand Lodge I proceeded to that city, and in as impressive a manner as possible unveiled the Roll of Honor, which had been engraved and hung upon the walls of their Lodge room. At this time I took occasion to give the following address.

#### Worshipful Master, Officers and Members of Keith Lodge and Visiting Brethren:

As the "Grand Master of the Antient and Honourable Fraternity of Free and Accepted Masons of New Bruns-

wick," I am present tonight on the invitation of your Worshipful Master, Brother John P. Weir, to preside over the ceremonies incident to the unveiling of a tablet, which has been engraved and now hangs upon the walls of your Lodge room, in honor of, and bearing the names of the brothers who have enlisted from this Lodge, and went out from among us to play an honorable part in the War which, for four long, weary years, wrought such destruction, created such havoc, resulted in the death of so many millions of men, and brought sorrow to the homes of the peoples of the nations.

These men in common with over ten thousand Brother Masons, good and true, from all over our Dominion, "fought the fight and kept the faith," till the eleventh hour of the eleventh day of the eleventh month of 1918; when victory crowned their efforts and our dishonorable enemies were overcome.

It is only natural that we should spend a few moments in retrospect on an occasion of this kind. In thought we go back to those momentous days in 1914, when Kaiser William of Germany, and his military advisors, drunk with desire for world dominion, launched their legions against defenceless Belgium, and unprepared France, and laughing at "Britain's contemptible little army," thought to win swift victory. The issue was well defined. Germany stood for the ideal of military control, and war as the determining factor in human destiny. While the Allied nations stood for principles of democracy, the right of every nation, great or small, to work out its own destiny and honor in international relationships. It was not surprising therefore that the free peoples of democratic nations rose up to withstand the German hosts, and with grim determination held German might at bay, while Britain, France and Italy welded a machine that could turn back the foe and preserve for future generations the

heritage of democratic freedom that had been handed down to them.

The whelps of the Lion's brood came at the Mother's call and a United Empire dedicated its all on the altar of sacrifice, that freedom might not be vanquished. And now democracy has triumphed. Victory is ours, but at what a price. We are told that over seven million men died in battle, or of wounds received in battle (almost as many as the total population of our fair Dominion of Canada), and what of the untold numbers who were dishonored, foully done to death on the high seas, murdered by German and Turkish troops. What of the homes left desolate? The orphaned children and the crippled manhood throughout our Empire and the world, not to speak of the expenditure of billions of dollars which has placed a heavy financial burden, not only on the shoulders of those who now live, but on the shoulders of their children as well, for many generations to come.

In the grim fighting, the awful suffering, and in the glorious victory, our Masonic Order has lived up to that outstanding principle of loyalty, which is not only the watchword of every true Mason, but is the very foundation on which our Order stands, — Loyalty to God, loyalty to truth, and loyalty to one's country.

This tablet now about to be unveiled breathes the same thought. The members whose names are inscribed are men in whose breasts there beat hearts of high resolve and splendid loyalty. When duty called, they laid aside their peaceful pursuits and donning the garb of soldiers, went out "not knowing whither they went," but their sense of duty and their loyalty to those principles of democracy, for which the Allied nations stood, was their guiding star.

We know they did their duty, and the members of this Lodge as a whole, does honor to the Lodge in keeping this tablet as a perpetual reminder how that thirty-three

members of Keith Lodge responded in the hour of the world's danger, and I sincerely hope that each Lodge within this jurisdiction will erect a suitable memorial to those who have lived, and fought and died, for the principles so dear to us all.

I understand the brothers whose names are on this tablet, were fortunate in that none were killed in action and only one has died since return, and may I express the hope that they will all be spared to return from the theatre of war to their homes and loved ones, and to again assemble in their Lodge room as was their custom before going overseas.

After the unveiling of the Roll of Honor, I called upon P. G. Chaplain Rev. A. D. Archibald, who was personally acquainted with the brothers who were being honored, and he delivered an address of an intimate nature in a very acceptable manner.

After the ceremonies of unveiling were completed, Grand Lodge and visiting brethren were invited to the Methodist Church, where a very sumptuous repast was served by the ladies of the church. After which we returned to the Lodge room where addresses were delivered by P. G. M. Dr. H. V. B. Bridges, P. G. C. Rev. A. D. Archibald, P.G.M. Dr. Thos. Walker, Rev. P. A. Walker, of Amherst. and others.

A very enjoyable evening was spent in this manner.

#### MASONIC PEACE CELEBRATION.

The United Grand Lodge of England is the Mother Grand Lodge of Freemasonry. It is making plans to mark the declaration of Peace by a great celebration in London in June next. The celebration will extend from the twenty-third to the thirtieth of the month. The Grand Master and Grand Secretary of the Grand Lodge

of New Brunswick have been invited by cablegram and letter to be present.

The proposed gathering will be most impressive. It will probably be the largest in the history of Freemasonry, as there are some eighty Grand Lodges in various parts of the world in fraternal relation with England.

It might not be out of place to state here that there have been two outstanding Masonic meetings held in London in recent years. The first was at the time of the Jubilee of the late Queen Victoria. Upon that occasion some ten thousand prominent Masons met in Albert Hall. The second occasion was in June, 1917, which was the two hundredth anniversary of the formation of the Grand Lodge of England. A great assemblage gathered. The present Grand Master, the Duke of Connaught, occupied the chair. Official delegates were present from the Grand Lodges of Ireland and of Scotland.

#### NECROLOGY.

As we are again met in Grand Lodge, we are reminded how uncertain is life. Each succeeding twelve months, witnesses the passing of many of our Craft. When we strike hands in comradeship during the Annual Communication, we do not know how many there are who, before another gathering of the Craftsmen, will become members of the supreme Grand Lodge on high.

It becomes my sad duty to call the roll of those, who, during the past twelve months have taken their demit from the Lodge below and we trust have joined the Grand Lodge above, where the Supreme Architect of the Universe presides.

- New Brunswick Lodge, No. 22. ROBERT J. MELVIN, P.M., died February, 1919.
- Keith Lodge, No. 23. GEORGE R. SANGSTER, P.S.G.W., died February 20, 1919.
- The Union Lodge of Portland, No. 10. WILLIAM B. ROBERTSON, P.G.Pursuivant, died March 22, 1919.
- Northumberland Lodge, No. 17. JOHN H. TROY, Grand Steward, died April 2, 1919.
- Zetland Lodge, No. 24. JAMES INGLIS, died April, 1919.

These brethren were all honored members of the Craft. Their departure has left gaps in our ranks; gaps which will be filled by others it is true, but their going has left sorrow in our hearts. We miss their fellowship.

There is one of our loved departed that I desire to especially mention; not that we honor him more, but he was an outstanding figure, both in Masonry and as well in public life. In the war he fought courageously and died an heroic death. I speak of Lt.-Col. A. E. G. McKenzie, D.S.O.

#### OFFICIAL VISITS.

During the past Masonic year, I have made twenty-one official visits to Lodges in various parts of our jurisdiction, and would have visited every Lodge in the jurisdiction if I had not been prevented by the quarantine. I will now proceed to give a detailed account of my visitations.

On the twenty-third day of June, upon the invitation of the Worshipful Master, I visited Hiram Lodge, F. and A. M., in the capital city of Fredericton. I was accompanied by the following officers and members of Grand Lodge: R. W. G. Secretary J. T. Hartt, G. D. of C. Geo. D. Ellis and G. Tyler Robt. Clerke. It was my privilege on this occasion to attend divine worship in Christ Church Cathedral, and listen to an eloquent and impressive sermon by the Very Rev. Dean Neales. After the service we repaired to the Lodge room and I installed R.W. John A. Morrison as Deputy Grand Master.

On the seventh day of August, I visited St. Martins Lodge, No. 3. I was accompanied by a large number of the brethren of Grand Lodge, among whom were R. W. Dr. Thomas Walker as Deputy Grand Master; E. H. Cairns, Senior Grand Warden; Brother Cairns, of the City of Ottawa, as Junior Grand Warden; G. D. Ellis, Grand Director of Ceremonies; S.P.McCavour as Grand Secretary.

We received a very warm welcome from Worshipful Master Bentley. The third degree was conferred on two candidates. With the close of the Lodge, the brethren assembled in the dining room and spent a very pleasant hour over refreshments.

My next visit was on August 19, when Grand Secretary J. T. Hartt, Geo. D. Ellis, G. D. of C., and myself left St. John on the 1.20 p.m. train en route for Dorchester. We were met in Moncton by D. D. G. M. Edgett and W. M. Weir, of Keith Lodge. After supper Brother Edgett took

us in his car and drove to Dorchester, where we visited Sussex Lodge, No. 4. W. M. Chapman gave us a most cordial welcome. It was purposed to confer the third degree, but when the candidate was examined in open Lodge, it was found that he lacked sufficient Masonic information to warrant advancement. After his retirement the M. M. Degree was exemplified by the officers of Grand Lodge. Light refreshments were later served.

The following day, August 20, in company with Grand Secretary, the G.D. of C. and W. Brother W. F. Tait, acting D.D.G.M., and a number of brethren, we left by automobile for Sackville. Upon our arrival, we were heartily received and given a most open hearted welcome. We witnessed the third degree conferred on two candidates. The officers of Lebanon Lodge took the first section, and the officers of Grand Lodge the second. After light refreshments we returned to our hotel about midnight, having had a most enjoyable and profitable evening.

The next day we returned to Moncton and in the late afternoon went to Hillsboro in Brother Edgett's car. After partaking of the evening meal in Prince Albert Hotel, we visited Howard Lodge, No. 15. We received a royal welcome from the acting Worshipful Master and a large gathering of brethren from Hillsboro, Albert and Moncton.

As the Worshipful Master of the Lodge had removed from Hillsboro, P. M. Brother S. Hume acted as Worshipful Master. The M. M. Degree was exemplified in a creditable manner. After the work of the evening, Grand Lodge was invited to refreshments in a nearby hall. The ladies of the Red Cross Society served a nice tea and we spent a most pleasant hour.

The following day, which was the twenty-second day of the month, we left in Brother John Berry's car for Albert. That evening we visited Albert Lodge, No. 34, accompanied by a large number of brethren from Moncton, Hillsboro and Albert. Worshipful Master Lewis received and welcomed us and then exemplified the E. A. Degree in a very acceptable manner. Later, light refreshments were served, after which we returned to our hotel and then at 11.30 o'clock started for Moncton in Brother Edgett's car. We arrived in Moncton at 1.30 in the morning, tired but happy.

That night, accompanied by a number of brethren, I visited Tweedie Lodge, No. 41. W. M. Geo. V. Steeves received and welcomed Grand Lodge very cordially, and then exemplified the F. C. Degree in a very creditable manner.

Very interesting remarks were made by R.W. Brother Geo. Ackman, Captain Masters, and a number of others. The Craft was then called to refreshments and a very pleasant hour was spent.

In all the above meetings the work was criticized in a friendly manner by the R.W. Grand Secretary and myself, which criticisms were kindly received by the brethren, and I hope that much good resulted.

On September the 16th, accompanied by Grand Director of Ceremonies Geo. D. Ellis, and Dr. W. S. Morrison, we left St. John at 6.45 a.m. to visit Lodges in the northern part of the Province. Arriving in Woodstock we found the Grand Secretary waiting for us. At 3 o'clock W. Brothers Mair and W. J. Dibblee kindly drove us in their car to Florenceville, where at 8 p.m. we visited Carleton Lodge, No. 35. We were warmly welcomed by W.M. McClintock, who then exemplified the E.A. Degree, after which ice cream was later served and a pleasant evening came to a close.

At 10 a.m. the following morning, Brothers Mair and Dibblee drove us to Andover and at 8 p.m. we visited Benjamin Lodge, No. 31, and were heartily received and welcomed by W.M. Stratton, who then worked the F. C.

Degree in a most creditable manner. Grand Lodge was then invited to their beautiful dining-room, where the ladies had prepared a most bountiful supper which was very much enjoyed, and a very pleasant hour spent in song and story. The brethren of this Lodge are most enthusiastic Masons and the Lodge is in a very healthy condition. They have a beautiful building and take the best of care of it.

The next afternoon, which was the eighteenth day of the month, we went by train from Perth to Grand Falls, arriving at 4.30. At 8 o'clock we visited Colebrooke Lodge, No. 39. We were received and welcomed by acting W.M. Merritt. The E. A. Degree was exemplified very acceptably, and instruction was given by the Grand Secretary which was much appreciated by the brethren present.

Colebrooke Lodge is now passing through a most trying time. Many of the members live long distances from the Lodge. A number are overseas, some have lost interest, and sometimes those remaining get discouraged. The Lodge room is well kept and everything about it is clean, bright and comfortable. We tried to encourage the brethren as best we could, and hope that our visit will have good results.

Again the next day we left Grand Falls for Edmundston. We arrived at 6.20 p.m. We were met by a number of the brethren and driven to the Royal Hotel. After supper the brethren took us to the moving pictures where we spent a pleasant hour. We then visited Bethel Lodge, No. 40, accompanied by W. Brother Stevens, acting Senior Grand Warden. We were received and royally welcomed by Worshipful Master Dayton. The E. A. Degree was conferred on Vernon Kenneth Cameron, in a most creditable and impressive manner. We were then invited to their banquet room where a tempting lunch was served and a pleasant hour spent. After breakfast the next morning, some of the brethren came for us and drove us around Edmundston, and at the kind invitation of Donald Fraser & Sons, took us through their new \$2,500,000 pulp and paper mill. It is certainly a wonderful plant. We enjoyed very much the privilege of inspecting this new pile of buildings.

There was a large attendance and after the Lodge closed a pleasant hour was spent. Refreshments were dispensed and a musical entertainment given.

On January the 10th, I proceeded to Hampton. The officers of Grand Lodge were in attendance. We visited "The Corinthian Lodge, No. 13," and installed Brother John Henry Marr as Worshipful Master, and other officers. "The Corinthian Lodge" entertained us in their usual hospitable manner.

On the fourteenth day of the same month, accompanied by officers of Grand Lodge, I visited Hibernia Lodge, No.3, and installed Brother Samuel Walter McMackin Worshipful Master, and the other officers into their respective offices. A pleasant hour was also spent over refreshments and in listening to a musical entertainment.

On the twentieth, accompanied by Grand Director of Ceremonies, Geo. D. Ellis and the Grand Organist, D. Arnold Fox, also a large number of other officers, I visited Hiram Lodge, No.6, in the City of Fredericton, and installed Brother Charles Andrew MacVey as Worshipful Master, also the other officers into their respective stations. After the work of the evening, Grand Lodge was invited to the banquet room, where the ladies of the "Order of the Eastern Star," had provided a banquet in their usual hospitable manner. A very fine musical and literary entertainment was also provided.

March 18. In company with the Grand Secretary, Grand Director of Ceremonies, and a large number of brethren from Newcastle, Chatham, Campbellton and Moncton, I visited Restigouche Lodge, No. 25, and I certainly was surprised and pleased beyond measure at the appearance of their Lodge room, the way we were received and the way in which the first degree was worked. In contrasting the visit to this Lodge with my visit there in 1917, I was reminded of the words of our Ancient Grand Master, Solomon, King of Israel "My son despise not the chastening of the Lord, neither weary of His correction. For whom the Lord loveth He correcteth even as a father the son in whom he delighteth."

As I reported to Grand Lodge a year ago, in my visit to this Lodge in 1917, I was disappointed and hurt and I applied the rod. And the Lodge like a wise son took the correction in the spirit in which it was administered, viz., that of kindness, with the result that they now have a beautiful clean room in which to meet, and their work will compare very favorably with that of any other Lodge.

Worshipful Master MacKinnon is certainly to be congratulated on his staff of officers, and the interest and enthusiasm manifested, and Restigouche Lodge is to be congratulated on their live Master and Officers.

The ladies served a banquet at the close of the evening work, which was much appreciated by those present.

Addresses were made by the Worshipful Master, Grand Director of Ceremonies Ellis, District Deputy Grand Masters McDonald, of Chatham, and Edgett, of Moncton, Past Deputy Grand Master Col. J. D. B. F. MacKenzie, Worshipful Brother J. P. Weir, of Keith Lodge, and Brothers Andrew and Firth, P.D.G. M., of Campbellton Lodge, and Junior Grand Deacon Jarvis, of Chatham, and others.

#### RECOMMENDATIONS.

There is now a movement being launched to provide, in this province, a suitable Protestant Orphanage. A number of the brethren of Grand Lodge have suggested to the Grand Master that our Order should have a part in this very necessary movement. I very heartily concur in this and would strongly recommend that this matter be considered by the Board of General Purposes.

I also recommend that the usual grant be made next year, for instruction to subordinate Lodges.

#### SPECIAL DECISIONS.

On October 17 last, application was made to me from Sussex Lodge, No. 7, through R.W. J. T. Whitlock, for information whether a dispensation would issue for the burial of an unaffiliated Mason. To this the R.W. Grand Secretary was directed to reply in the negative.

On the twenty-first day of March I received a communication from Carleton Union Lodge, No. 8, requesting the Grand Master's ruling on a matter that has frequently come before Grand Lodge, namely, the admission to membership of a person who has lost a limb.

The gentleman in question is a veteran of the South African War, and on account of injuries received in that war, his left leg was amputated at the hip. Otherwise the gentleman is of unquestionable character and in every respect is fully qualified, and I believe would make a good Mason. And as this question may frequently come up, as our men are returning from the front, it is necessary that the question should at once be settled.

I have given this matter my most earnest consideration, and find that as far back as 1871, Grand Master Wedderburn refused a dispensation to initiate a man who had lost his left arm. Also one who had lost his foot, which decisions were remitted to the Board of General Purposes for their opinion, who decided that the loss of a foot is an insuperable objection to the initiation of a person otherwise qualified.

In 1873, Grand Master Ellis gave as his decision, and it was also declared by Grand Lodge, "that candidates must be physically qualified to fulfil all the requirements of initiating, passing and raising, and that however much it may be regretted that in particular instances, the Craft is, 1919]

by an adherence to the ancient regulations, deprived of the membership of otherwise worthy applicants, the interests of Freemasonry are best conserved by a due observance of the ancient landmarks of the Fraternity."

Also in 1875, it was decided that a candidate must be "a hale man, sound, not deformed or dismembered," as the landmarks of Masonry prescribe. This ruling was endorsed by the committee appointed to report on the Grand Master's address.

I also find that the decision of the Board of General Purposes, of the Grand Lodge of England, September 4th, 1918 is, "The Board feel that it is impossible to lay down a hard and fast rule as to the initiation of a candidate not perfect in his body within the meaning of Article 4 of the Ancient Charges, prefaced to the Book of Constitutions. But the Board are of the opinion that, when the defect does not render a candidate incapable of learning our art, there is no reason why he should not be initiated, provided he is able to understand our secrets and mysteries and to explain or exemplify them when properly called upon."

I therefore must give it as my decision that no man can become a Mason, who is not physically qualified to fulfil all the requirements of initiating, passing and raising.

#### GENERAL CONSIDERATIONS.

The members of Grand Lodge should feel deeply grateful that there has been a steady increase in the Fund of Benevolence. It has reached the splendid figure of \$19,000.00.

In my visitations to various Lodges, I have been deeply impressed with the very considerable number of Masons that are lost to Active Masonry, each year, because of withdrawals and suspensions. This should receive due attention from Grand Lodge, and also from subordinate Lodges.

One cannot visit the various Lodges of the jurisdiction without being favorably impressed with the attractiveness of Lodge rooms. Masons throughout the Province are justly proud of their homes.

During the year I granted dispensation to R.W. Brother Francis F. Burpee, and other brethren, to hold a Lodge of Instruction in the City of St. John. I am pleased to report that there has been a good attendance and much valuable instruction given.

In closing my address, I wish to express my deep sense of appreciation for the kindness, uniform courtesy, and beautiful hospitality which has been extended to me by the members of the Craft throughout the jurisdiction. I would also thank the officers and members of subordinate Lodges for their hearty fraternal welcome. I cannot find suitable words to convey my gratitude to the officers and members of Grand Lodge, and particularly R.W. Grand Secretary J. T. Hartt and the Grand Director of Ceremonies W. Brother Geo. D. Ellis, who accompanied me in my various official visitations. They were truly brothers.

I sincerely trust that the Great Architect of the Universe may abundantly bless the Grand Lodge and all members of the Craft during the coming year.

#### Total membership, 27th December, 1918, 3,983.

A supply of parchment certificates was ordered and received early in the year - 313 was the exact quantity at a cost of \$1.50 each. This is three times the price of a few years ago. The average annual issue of certificates is about 200.

The dispensations authorized by the M.W. Grand Master were thirty in number. In seven of these, permission was granted to wear Craft clothing at Divine Service; three were to elect and install officers due to local health regulations which prohibited public and social gatherings in December and January last. A quite unusual dispensation was one to confer degrees on a serving brother under Section 17 "of Private Lodges."

In seventeen cases degrees were conferred at short intervals on brethren about to leave the jurisdiction.

The Grand Lodge of Ireland has appointed M.W. Brother Daniel C. Clark its Grand Representative, the Grand Lodge of Alberta, W. Brother Aaron Lawson, and

that of the Philippine Islands, W. Brother William S. Morrison, M.D. The commissions have been received and duly delivered.

R.W. Brother Sidney E. Lang, of Winnipeg, has been duly commissioned by the Grand Master, as our representative near the Grand Lodge of Manitoba.

Vacancies in the representation of foreign Grand Lodges have been created by the deaths of R.W. George R. Sangster and W. Ernest Hutchison who, for long years, were the representatives of Kansas and Rhode Island respectively.

#### J. TWINING HARTT, Grand Secretary.

The following reports and financial statements were presented and read in full. They had been previously submitted to the Annual Meeting of "The Masonic Grand Lodge Corporation" and severally adopted.

#### REPORT OF HALL COMMITTEE.

TO THE MASONIC GRAND LODGE CORPORATION:

The Managing Committee of the Masonic Hall beg to submit the following report:

On assuming charge of the Hall, they found several changes advisable, which have necessitated considerable expenditure, but which they are convinced will prove beneficial.

The large chimney on the side of the building was in a dangerous condition, and had to be taken down and repaired from the roof up. Owing to the great amount of staging required, and the high cost of labor and material, this was an expensive operation, costing \$425.00.

The installation of the heating apparatus has been completed, and is giving entire satisfaction, but the excessive cost of coal has been a matter of much concern.

The store formerly occupied by H. Green has been thoroughly renovated, and leased to a satisfactory tenant at a substantial increase. A further increase has also been made in the other rentals, resulting in a larger revenue from these stores. Your Committee would recommend for your consideration a further expenditure on some of these stores, thus making them more desirable rentals.

On July 6, a serious fire occurred in the premises occupied by the Military Department, doing a great deal of damage to this portion of the building, and burning through the floors to the halls above. Considerable damage was also done by smoke to the Blue Lodge room and entrance, as well as to the hall leased to the Mystic Shrine, and occupied by the Temple Club. The total loss by this fire was appraised at \$1,654.98. The damage has been repaired, and the Blue Lodge room redecorated to the entire satisfaction of your Committee.

The lease of the Royal Kennebecasis Yacht Club having expired, the rooms occupied by them have been leased to Municipality of the City and County of Saint John, for Court Chambers. It has been found necessary to install new lighting in this portion of the building; the old wiring being defective, was condemned by the Inspector. This has been done in the most up-to-date and improved manner.

Your Committee would suggest that the incoming Committee be empowered to connect this portion of the building with the present heating plant, thus making a substantial saving in fuel.

No further progress has been made in the negotiations with the Mystic Shrine, referred to in former reports.

All of which is respectfully submitted.

The Annual Meeting of the Masonic Grand Lodge Corporation was held at Freemasons Hall, Germain Street, at 2.30 o'clock this afternoon, the M.W. Grand Master, Daniel C. Clark, President, *ex officio*, in the chair.

The minutes of the last Annual Meeting, as printed in the Proceedings of Grand Lodge, were read and, on motion of R.W. Julius T. Whitlock, were confirmed.

W. George D. Ellis, as Chairman of the Managing Committee of the Hall, submitted the Committee's Report for the year, and the same, after being read, was, on motion of W. Brothers Rowan and Mowatt, received and adopted.

In the absence, through illness, of V.W. H. Russell Sturdee, Grand Treasurer, the Accounts of the Corporation and of the Fund of Benevolence were presented by R.W. F. J. G. Knowlton, who also read the Report of the Auditors thereon.

On his motion, seconded by V.W. A. W. Sharp, it was *Resolved*,

"That the Financial Statements and Reports be adopted and referred to Grand Lodge for confirmation."
