**ANNUAL MEETING.**

SAINT JOHN, August 26, 1926.

**T**HE ANNUAL MEETING of "The Masonic Grand Lodge Corporation" was held this afternoon at 2.30 o'clock at Freemasons' Hall, Germain Street, pursuant to notice issued with the proclamation summoning the Annual Communication of Grand Lodge.

Grand Lodge was opened in *ample* form and with solemn prayer by the V.W. Grand Chaplain at 3.30 o'clock, and the brethren joined in the reading of the twenty-fourth Psalm.

On motion of R.W. Bro. Albert E. Pearson, P.G.W., seconded by R.W. Bro. J. Gordon Forbes, P.G.M., "the minutes of the Annual Communication in August last were taken as read and confirmed."

The following telegram from R.W. Bro. Julius T. Whitlock, P.G.M., was read:

The M.W. Grand Master addressed Grand Lodge as follows:

## GRAND MASTER'S ADDRESS.

## BRETHREN OF GRAND LODGE:

Another year has been added to the history of Masonry in this jurisdiction, and I welcome you to this Fifty-Ninth Annual Communication of the Grand Lodge of New Brunswick, with feelings of very great satisfaction at the excellent reports which will be presented to you from the various officers of Grand Lodge, and from the Board of General Purposes. At the same time, I fully realize my own shortcomings, and how much I might have done to further promote that true spirit of Freemasonry, which so actuated the lives and actions of those who have occupied this office before me. However, so well was their work done, and so strong was the foundation which they builded, that the Craft has prospered, notwithstanding.

Since we met a year ago, many have passed from our midst to enter the Celestial Lodge above. On Christmas morning we learned with deepest regret of the death of R.W. Bro. Thomas Walker, B.A., M.D. Bro. Walker was born in Hampton, N. B., March 20th, 1840, was descended on the paternal side from Elizabeth Yates, a sister of the famous Penderell Brothers, who were instrumental in saving the life of King Charles II, after the Battle of Worcester, for which they received from the King, a pension, to be paid to their heirs forever. Bro. Walker was in receipt of that pension, which has passed on to his eldest son. Bro. Walker was raised in Albion Lodge, No. 1, became Master of that Lodge in 1877, and again occupied the chair a few years later. He was elected Grand Master in 1889, and for the five years following. He was again elected in 1897, and held office for two years. This, in itself, expresses better than any words of mine, the appreciation of the Craft for our beloved Brother.

Bro. Walker was a splendid ritualist, and for years was the Grand Lodge authority, taking particular interest in the Third degree. This is perhaps not the place to refer to his connection with other Masonic bodies, in all of which he was greatly interested, and in many of which he attained the highest position.

## VISITS TO LODGES.

Pressing business engagements prevented me from making as many visits to the private Lodges as I would have liked. I did, however, in company with other Grand Lodge officers visit the following Lodges: Albion, No. 1; Saint John's, No. 2; Hibernia, No. 3; Woodstock, No. 11; Zion, No. 21; New Brunswick, No. 22; Benjamin, No. 31; Campbellton, No. 32; Alexandria, No. 33; Ashlar, No. 36; Colebrooke, No. 39; Bethel, No. 40.

On some of these visits, I installed the Master and officers of the Lodge, on other occasions we witnessed the degree work of the Lodge, and on this point I am very pleased to report a marked improvement, and very great desire on the part of the officers of the various Lodges to learn the ritual, as laid down by the Ritual Committee. I have been very much indebted on these several visits to the R. W. Junior Grand Warden and to the W. Grand Director of Ceremonies, for the use of their autos.

My visit to Albion Lodge, on January 22, was on the occasion of its Centennial Celebration. W. Bro. Frank A. Godsoe occupied the chair, and R. W. Bro. Edward H. Cairns delivered the historical address. The Worshipful Master at this gathering invited me to accept for the Grand Lodge the beautiful Mosaic Pavement installed by Past Master William Nonnenman, and presented by him to Albion Lodge. The acceptance of this beautiful specimen of the Craftsman's work gave me great pleasure, and I trust that its perfectness will ever be an example and an inspiration to all who are privileged to examine it.

On my visit to Campbellton Lodge on March 16, I presented the Lodge with a sett of Ashlars and with the great Lights, gifts from the members of the Craft in Saint John, suitably inscribed, to mark the appreciation of the brethren in Saint John of the loving kindness shown to Bro. Mence, of Albion Lodge, after the calamity which befell him on the Gaspé Coast, and while in the hospital at Campbellton.

I feel deeply grateful to all the Lodges visited for the courtesies extended to us, and assure them that they made this part of the Grand Master's work a real pleasure.

In my last report I referred to the invitation of the Grand Lodge of Ireland. The published reports of their Bicentenary Festival have since come to hand, marking one of the greatest Masonic gatherings ever assembled. One of the features of the Festival was the unveiling

of a portrait of the M.W. Grand Master, the Earl of Donoughmore, K.P.

Through the Grand Secretary, I received an invitation from the M. W. Grand Master of the Grand Lodge of Canada, in the Province of Ontario, to meet with them on the occasion of their Seventy-first Annual Communication, but as this meeting was held in Port Arthur I was reluctantly compelled to forego the pleasure of attending.

Because of Saint John's Day, December 27, falling on Sunday, and because of the full moon being on December 29, I granted requests from seven Lodges to change their date of installation. It would appear to me that the ten Lodges who are now governed by the moon, might well consider changing their meetings to a fixed date. The introduction of the auto has made it much easier for the members to attend Lodge from a distance.

I have made the following appointments as Grand Representatives: W. Alexander Burnett Brown, P. G. D., Grand Superintendent of Works, near The United Grand Lodge of England; V.W. S. M. Herford near The United Grand Lodge of New South Wales; W. John G. B. Jones near the Grand Lodge of Indiana; Jose C. Diaz near the Grand Lodge Isla de Cuba; Chester De Rocher near the Grand Lodge of Florida.

His Royal Highness the Duke of Connaught, Grand Master, has been pleased to appoint me Representative of The United Grand Lodge of England at this Grand Lodge, in place of R.W. Bro. Thos. Walker, deceased.

At the request of Mrs. Walker, and the members of her family, I accepted, on behalf of Grand Lodge, the portrait of our late Past Grand Master, Thos. Walker. The presentation was made at a meeting of Albion Lodge by Bro. Edward B. Walker, the youngest son of our late Brother.

I have been called upon to decide the vexing question of qualification, and have followed the rulings of former

Grand Masters, whose decisions have been confirmed by Grand Lodge in sessions — that an applicant, who through the loss of any member, is not in a position to perform all the requirements of initiation, is not eligible. I have given considerable thought to this matter, and some study as to what other Grand Jurisdictions are doing. At the last quarterly meeting of The United Grand Lodge of New South Wales, the M. W. Grand Master, Bro. John Goulston, brought in a very extensive report, and recommends important changes in the practice of the Grand Body. He says in part: "It is also the policy of the Grand Lodge of New Zealand and of many Grand Lodges in the United States of America, and I have definite information that these Grand Lodges are accepting maimed candidates. It is interesting to know that this has been the practice of the Grand Lodge of England — the Mother Grand Lodge of the world — since 1857, for on 23rd June, 1857, Lieut.-Col. J. H. King was initiated in Lodge Prince of Wales, No. 259, under the Grand Lodge of England, he having lost an arm at the Battle of Inkerman in the Crimean War. I also understand that in February, 1918, the Board of General Purposes of the Grand Lodge of England referred to that circular, and reported that, 'acting upon the precedent set in reported cases,' it had prepared a new circular letter 'carrying out the principles that have been accepted since the development of Operative into Speculative Freemasonry.' That circular was as follows:

"Representations have been made to the Board of General Purposes that cases of hardship may occur if no maimed but otherwise qualified man is allowed to become a Freemason. The Board feel that it is impossible to lay down a hard and fast rule as to the initiation of a candidate not perfect in his body within the meaning of Article 4 of the Ancient Charges prefaced to the Book of Constitution; but they are of opinion that when a defect does not render

the candidate incapable of learning our art, there is no reason why he should not be initiated, provided he is able to understand our signs and symbols, and to explain or exemplify them when properly called upon.

"Each case of this description must be decided by the members of the Lodge, to whom the candidate is personally known, subject to the investigation and approval of the Master of the Lodge, who is officially responsible that the candidate is in a condition to comply with the requirements above-named, and subject in Provinces or Districts to the sanction of the Provincial or District Grand Master, and elsewhere to the sanction of the Grand Master, after submission of the circumstances.

"As will be seen from the quotation from the circular of the Board of General Purposes of England, the matter of admitting incapacitated candidates is left generally to the Masters of the Lodges. Among the various Grand Lodges of Australia, some have altered their Constitutions in this respect. I do not propose to follow that example, but believe that the capabilities of each candidate should be taken on their merits, and that no maimed candidates should be admitted without the authority of the Grand Master.

"There remains the question of the use of our ritual in relation to such candidates. It might in cases be impossible to adhere to the wording of the ritual, though not necessary to depart from its meaning in spirit. While, therefore, I consider we may receive applications from bodily defective candidates for admission, I think the attention of Masters of Lodges should be drawn to the need for careful oversight in this matter in respect to every such candidate, and it appears to me best that a Master, when applying for leave to admit a defective applicant, should be required to show that he has adequately considered the actual course of the ceremony in regard to such applicant. Application for



sanction to admit a maimed candidate must therefore be made by the W. M. of the Lodge to the Grand Master, through the Grand Secretary, on printed forms that will be supplied by the latter."

Because of this changed view of so many English-speaking Grand Lodges, and particularly because of this circular of the Board of General Purposes of The United Grand Lodge of England, I would recommend to Grand Lodge that in future this matter be left to the members of the Lodge to whom the application is made, subject to the approval of the Grand Master.

I have been confronted with an increasing number of requests to issue dispensations for the conferring of degrees within shorter time than the Constitution provides, on the ground that the applicant is moving away, and I recommend the Masters of all Lodges to seriously consider before accepting candidates who are not reasonably sure of remaining in the jurisdiction, for a time at least after having been raised.

The splendid condition of the several funds of Grand Lodge, are a personal gratification to me. Particularly do I wish to refer to the Sinking Fund account, which has increased \$6,118.72 during the year, and fully justifies the promoters of that fund in the great faith which they placed in the members of the Craft in New Brunswick.

In view of the ever-increasing work of the Grand Secretary, due to the increase in the number of Lodges, their growing membership, and the fact that he has taken up the work of Lecturer, I therefore suggest that Grand Lodge increase the salary of the Grand Secretary.

The reports of the various officers of Grand Lodge will be presented, as will also the reports of the District Deputy Grand Masters. The increasing interest taken in the work by these officers is a great benefit to the Craft, and a great help to the Grand Master.

I am reminded that the early Masonic Lodges in the Province of New Brunswick, with few exceptions, held their meetings under authority of the Grand Lodge of Nova Scotia, which claimed to be carrying on its work according to the old constitutions granted by His Royal Highness, Prince Edwin at York, A.D. 926. Just what rights were conferred upon the Fraternity by Prince Edwin, who is said to have "loved Masons well," and just what was meant by the old constitutions, or old institutions, are matters of debate, but the One Thousandth Anniversary of the traditional date of their origin should not be allowed to pass without mention. A matter of more immediate concern to us, however, is the early history of the Lodges in this jurisdiction, active and defunct, and I would suggest to some of the energetic students, of whom we have several, a formation of a Club along the lines of the Nova Scotia Lodge of Research to complete and place on record all that can be obtained of these Lodges and their founders.

It behooves us as Masons to hold together and live in love and unity, to be true to our allegiance, to be charitable to others, to avoid secret societies organized for political purposes, especially those that falsely claim Masonic support, and as individuals to work for civil and religious harmony, and international friendship.

I desire to thank the Past Grand Masters, and the past and present Grand Officers, who have helped and supported me so much in the discharge of my duties.

The annual report of the V.W. Grand Secretary was submitted and read, and on motion of R.W. Bro. Gordon Forbes, P.G.M., seconded by R.W. Bro. LeBaron Wilson, P.G.M., the report was adopted.

## REPORT OF THE BOARD OF GENERAL PURPOSES.

*To the Grand Lodge of Free and Accepted Masons of New Brunswick:*

The Board of General Purposes presents its report relating to matters which have engaged its attention during the year. Regular quarterly meetings and one special meeting were held. The Senior Grand Warden, R. W. Bro. Herbert Priestman, was elected Vice-President.

The death of R. W. Herbert E. Goold caused a vacancy among the appointed members and which the M. W. Grand Master filled by the selection of R. W. Bro. G. Percy Burchill, Past Grand Warden.

The administration of the Fund of Benevolence was continued by the same Committee as last year, viz., the M. W. Grand Master and Past Grand Masters J. Gordon Forbes and LeBaron Wilson.

Fifteen applications for aid were received and all were granted by the Committee to the amount of \$1,000.00. This is the largest appropriation so far made in any one year; but how gratifying it is that the income of the fund, always increasing, continues to be more than equal to the yearly needs. It has been found by the experience of later years that it is expedient and more satisfactory, to have the application made by the Master and Secretary of the Lodge and for the V. W. Grand Treasurer to issue his cheque in their joint favour.

The Board has acquired the Masonic Manuals belonging to the estate of the late Past Grand Master Walker and in future these authorized Manuals will be obtainable from the Grand Secretary's office as in earlier years. For the present the price will be one dollar per copy.

The Board directed the purchase from The Pantagraph Printing Co. of Bloomington, Ill., of forty copies of this year's "List of Regular Lodges, Masonic" and a copy was

sent to each Lodge in the jurisdiction and two to Freemasons' Hall for the use of the Lodges in Saint John. The cost, including duty, was \$23.87. Each Lodge should see to it that the list is always available in the anteroom.

Some years ago copies of the then list were procured and distributed in like manner.

At the Board's request there has been prepared a memorandum of the portraits of Past Grand Masters which hang on the walls of this Lodge room. The memorandum was entered on the minutes of the Board and is here inserted for the information of Grand Lodge and as a record for the future.

A case of physical disability was brought before the Board, at its March meeting, by the Master W. Bro. W. J. Weir and two other members of Keith Lodge. The facts, as presented, were that a resident of Moncton, well and favourably known, had made application to Keith Lodge and had been duly accepted on ballot. It was then found that he had an artificial foot. While serving overseas during the war he was wounded and his foot amputated. The Committee from Keith Lodge strongly advocated that the rule excluding a person so maimed be, in this case, relaxed and stress was laid upon the fact that it was while serving his country at the front that the loss had been suffered. The whole subject of disability was fully discussed. The Board was informed that this case had been submitted to the M. W. Grand Master on November last and that he had then ruled, in accordance with decisions approved of by Grand Lodge, that the disability precluded the person from being received into the Craft. It was Resolved, "That the Board concurs in the ruling made by the M. W. Grand Master."

The Directors deem it unnecessary to make any further comment on the accounts or any reference to the financial position of the Corporation which the Auditors' Report so clearly indicates. The recommendation of the Auditors as to transferring the sum of four thousand dollars from the General Balance is placed before the Corporation for consideration.

The Hall Committee has made the following report respecting the building:

The Managing Committee of the Masonic Hall beg to submit the following report:

During the year it was not necessary to make any repairs to the outside of the building, except some repairs to the window casings of the stores, and also to the skylight and roof.

On account of the Executors of the Blake Estate closing up the business of G. & E. Blake, your Committee was compelled to take over the lease of the store at November 1. The store was found to be in such bad state of repair that it required quite an expenditure to make it tenantable. We were fortunate in procuring a tenant at an increase of rent over the former lease for a term of three years from May 1.

In December, the apartments of the Scottish Rite were renovated by whitewashing ceiling and painting the walls. We secured a seven year lease from the above.

The lease of the Potts store No. 96 was renewed for three years, the same rent as formerly. The lease was made in favor of Mr. Roy F. Potts.

In June, more extensive alterations to the heating system were made by our engineer, to make it more efficient and economical.

In July, a hard wood floor was placed in the Vaughan store.

"That the report be received and, as usual, printed in the annual proceedings of Grand Lodge.

#### REPORT OF COMMITTEE ON FOREIGN RELATIONS.

*To the Grand Lodge of Free and Accepted Masons of New Brunswick:*

Your Committee on Relations with Foreign Grand Bodies, having called your attention last year to the want of harmony between York Grand Lodge of Mexico, working exclusively in the English language, and the Grand Lodge of the Valley of Mexico and other Mexican Masonic bodies working in Spanish within the same jurisdiction, now have pleasure in reporting a very great improvement in the situation.

The Supreme Council of the Scottish Rite in Mexico issued in 1919 an edict in which it declared York Grand

Lodge to be an irregular body, and forbade its members and adherents, including Grand Lodge Valle de Mexico, to hold any Masonic communication with the Foreign Grand Lodge or with Masons of its obedience. York Grand Lodge retaliated by forbidding its adherents to hold communication with the Supreme Council or any of the bodies working under it. This practically meant non-intercourse with all Mexican Lodges working in the Spanish language.

Last year the Scottish Rite authorities relented. With expressions of brotherly kindness, they annulled the edict of 1919, and decreed that from the date of the new edict, July 8 of last year, brethren in good standing under York Grand Lodge could be accepted as regular Masons. York Grand Lodge was quick to respond by releasing its members from the prohibitions imposed upon them; and there has been much gratifying evidence of friendly feeling between the Mexicans and the Foreigners within the last twelve months. Nevertheless, York Grand Lodge does not as yet recognize any of the Mexican Grand Bodies as regular; though its Grand Master, in his address to Grand Lodge in April last, expressed a hope that in process of time a closer connection with them might become both possible and desirable. Where kindness and tolerance are taking the place of contention, this hope may well be indulged.

Not only in Mexico, but elsewhere throughout the Masonic world, there is a growing sense of unity; yet the understanding of the meaning of Masonry that prevails in some countries leaves much to be desired.

Your Committee has no recommendations to make to Grand Lodge at the present time.

The Patent having been read, the R.W. Deputy Grand Master congratulated M.W. Bro. Ellis on the distinction conferred and R.W. Bro. J. Gordon Forbes, P.G.M., representative of the Grand Lodge of Scotland invested him with the jewel of office which had been sent with the Patent of Appointment. Grand Lodge greeted the new representative of the Mother Grand Lodge with the Grand Honours and applause and the Grand Master resumed the East.

The Special Committee on the address of the M.W. Grand Master submitted the following report and the same was read by the Chairman R.W. Bro. James Vroom:

## REPORT ON THE GRAND MASTER'S ADDRESS.

*To the Most Worshipful Grand Lodge of Free and Accepted Masons of New Brunswick:*

Your Special Committee to whom was referred the Most Worshipful Grand Master's address beg leave to report as follows:

The sorrow with which the members of Grand Lodge received the announcement of the loss of our oldest Past Grand Master, R.W. Bro. Thomas Walker, and others in the long list of those whose passing from their earthly labours is mentioned in the address, was feelingly expressed at the time. Your Committee recommend that their names be suitably inscribed in the report of proceedings.

The M.W. Grand Master, in his brief reference to his official visits to private Lodges, makes no mention of his unofficial visits, which were frequent and always welcome. It is gratifying to learn that he finds progress and improvement throughout the jurisdiction; and his official acceptance of the excellent portrait of the late Past Grand Master Walker, and of the beautiful Mosaic Pavement presented through Albion Lodge, are incidents well worth noting, as is also his privilege of bearing to Campbellton Lodge a token of remembrance from the brethren in Saint John.

That the regular meetings of some of our Lodges are still governed by the phases of the moon is a quaint reminder of days gone by. Your Committee would be sorry to see it swept away for practical reasons; but the practical reasons put forward by the Grand Master are sound, and in accordance with the tendency of the times, and the Committee therefore endorse the suggestion of the M.W. Grand Master.

Grand Lodge has listened with interest, and must give careful attention to the recommendations of the M.W.

Grand Master in respect to applicants for degrees who are maimed, but who are otherwise qualified for admission to the Craft. Your Committee concur in the recommendation that the matter be left, in each case, to the decision of the Lodge immediately interested, the approval of the Grand Master to the reception of the petition having first been obtained; feeling sure that this approval will never be given without full knowledge of the circumstances. The only further precaution your Committee would suggest is that no applicant who has been rejected by one Lodge for incapacity should be accepted by another.

That Lodges would do well not to accept applicants who are not reasonably sure of remaining in their jurisdiction, for some time at least, after being raised, is a new suggestion; but it calls for due attention. In admitting a candidate, the welfare of the Lodge is to be considered, rather than the welfare of the candidate who is not then a Mason. To admit members who will not be well grounded in the tenets of the Order cannot be to the benefit of the Craft.

The M.W. Grand Master's proposal that a Masonic History Society, or Lodge of Research, be formed in this jurisdiction is addressed to us as individuals, and it is to be hoped that it will meet with acceptance. If so, Grand Lodge might be induced to bear the cost of printing its proceedings, and perhaps should also make provision for preserving old manuscripts and other objects of historic interest.

We may well ponder the good advice with which the Grand Master closes his address. Freemasons are an organized body of chosen men. Their political influence will always be sought. We need to remember that our object as a Fraternity is not to build up a powerful organization, but to build character, to promote good works, and to see that Brotherly Love prevail.

The recommendation that the Grand Secretary's salary be increased to compensate for increased labors and responsibility must meet with the approval of Grand Lodge—a definite motion should be forthcoming to effectuate the desired result.

Bridges, P.G.M., and express to him the sympathy and good wishes of Grand Lodge.

The M.W. Grand Master: Grand Lodge will now take recess.

Grand Lodge was opened in *ample* form and with solemn prayer at 2.30 o'clock.

*The M.W. Grand Master:*

"Right Worshipful Senior Grand Warden and Brethren:

This Special Communication has been called for public worship at Christ Church Cathedral, which our Very Reverend and Very Worshipful Brother the Dean has kindly permitted us to use for the occasion.

It is fitting that we should from time to time thus publicly acknowledge our belief in T.G.A.O.T.U., and pay that homage which our ritual enjoins. It seems to me peculiarly fitting that this should take place in the capital city of our Province, an early centre of Masonic influence, and at this particular time.

The first and only Lodge of Moderns in New Brunswick, known as New Brunswick Lodge, No. 541, on the registry of the Grand Lodge of England, was established in Fredericton in 1789. Four years later there were two Lodges of Antients working here, side by side, under warrants from the Grand Lodge of Nova Scotia, known respectively as Solomon's Lodge, No. 22, and Hiram York Lodge, No. 23. These and other Antient Lodges in the Province claimed to be working, as stated in their warrants, "according to the Old Constitutions granted by His Royal Highness Prince Edwin at York, Anno Domini Nine Hundred Twenty and Six," just one thousand years ago.

There is nothing in our present organization which we can definitely trace to the charter said to have been granted by King Athelstan in 926, or to the good offices of Prince Edwin, who was the King's half-brother; but the date unquestionably marks an important event in the history of Operative Masonry. The period which has elapsed since that date we may roughly divide into two—five hundred years of the growth of Operative Masonry, in the glorious days of the cathedral builders, and five hundred years of colonial expansion and the development and spread of Speculative Masonry, in the age now drawing to a close.

It is a marvellous tale, full of tantalizing uncertainties, as everyone knows who has tried to read it; but thus looking back upon a thousand years of English Masonry, we may well thank God and take courage."

A public procession was then formed in front of the Masonic Hall, Grand Lodge being preceded by representations from Albion Lodge, No. 1; Hibernia, No. 3; Hiram, No. 6; Sussex, No. 7; Woodstock, No. 11; The New Brunswick, No. 22; Alexandria, No. 33.

The procession moved by way of Queen Street to Christ Church Cathedral, entering by the west door.

V.W. Bro. the Very Reverend Scovil Neales, M.A., D.D., Dean of Fredericton, Past Grand Chaplain, and the V.W. Grand Chaplain conducted the service; and the Grand Chaplain preached the sermon.

The benediction was pronounced by the Dean.

The procession of the Craft re-formed and returned to Masonic Hall by way of Brunswick and Queen Streets.

The M.W. Grand Master resumed the East.

Moved by R.W. Bro. H. V. B. Bridges, P.G.M., seconded by R.W. Bro. John Thornton, D.G.M.,

"That the thanks of Grand Lodge be voted to the Very Reverend the Dean and the Chapter of Christ Church Cathedral for having granted to the Craft the very high privilege of gathering in the Cathedral this afternoon for Divine Worship."—*Carried* by a standing vote.

Moved by R.W. Bro. LeBaron Wilson, P.G.M., seconded by V.W. Bro. A. Ernest Everett, Grand Treasurer,

"That the earnest thanks and appreciation of Grand Lodge be extended to the V.W. Grand Chaplain for the sermon to which the brethren had so eagerly listened at this afternoon's service."—*Carried*.

Moved by R.W. Bro. George D. Ellis, P.G.M., seconded by R.W. Farris S. Sawaya, P.G.W.,

"That Grand Lodge record its gratitude to the organist, Bro. William J. Smith, A.R.C.O., and the Cathedral Choir for their signal contributions to the beauty and solemnity of the service."—*Carried*.

Grand Lodge was then closed in *ample* form.

## SERMON

V.W. C. GORDON LAWRENCE, M.A., *Grand Chaplain.*

"Understandest thou what thou readest?"—ACTS viii., 30.

THERE are two great text books in Freemasonry. They were commended to your attention early in your Masonic career. Without some knowledge of them you can never become proficient in our art, nor can you share largely in our mysteries. They are the Books of Nature and of Revelation.

\* \* \* \* \*

From the Book of Nature we may learn much about the character of our Supreme Architect. Evidences of a wise and mighty plan present themselves to the enquiring mind. We learn that the Great Spirit who was the Builder was the Designer as well. The Beauty of the Design bears witness to the spirit of an Artist.

From the immensity of space we learn of His infinite greatness. From the immeasurable power of natural forces; the sun's power to hold all the innumerable worlds in place, the irresistible power of the tides, the terrible power of the earthquake; from such as these we learn how omnipotent is their Author. From the certain succession of day and night, summer and winter; from the regular return of the planets in their courses, we learn how orderly is the mind of the Great Designer. From the glory of the sunset, and the wonder of the snowflake, and the sigh of the night wind, we know that in Him Wisdom and Strength are combined with Beauty. "The sun's look and the sea's voice and the earth's wonderful breath" all bear the impress of the Divine Artist.

The Book of Nature is beyond our limited comprehension. Mankind has proceeded but a little way in an attempt to read it. After all the centuries we are still like little children just beginning to learn the art of reading. But our efforts receive constant encouragement. Before the dawn of history men in Chaldea and Egypt had begun to study the stars. At last the telescope was invented and turned toward the sky. "I have seen farther into space than any other man" said Herschel, "I have seen stars so far away that the light from them can only reach the earth after a journey of many years."

An undreamed-of section of Nature's Book was opened for us by the invention of the microscope. Louis Pasteur and others, who were still at work when we were born, uncovered for us the infinitely small. In the days of the Hebrew psalmists it was considered a grand experience, rare no doubt to the Jew of that day, to "go down to the sea in ships and see the works of the Lord and His wonders in the deep." But we live to see even greater wonders in a single drop of water.

Chemistry, in the modern sense, is an entirely new science. The discovery of radium by Curie is only the better known of many equally wonderful that have been made in our lifetime. Elements and forces entirely new to us must now be taken account of in our reading of Nature's witness to her Creator, and a restatement of natural philosophy becomes necessary.

We shall never exhaust the treasures of the Book of Nature. Our little day ends before we have fairly begun the task. The multiplicity of interests that have arisen from the division of labour distracts our attention. My brothers, I implore you, turn aside now and then from your bank books, your catalogues, and your ledgers, and make for yourselves opportunity to "contemplate the glorious works of the Creation and to adore your great Creator."

\* \* \* \* \*

There is also to be studied the Book of Revelation. "As a Mason, you are to regard the Volume of the Sacred Law as the great Light in your profession." The Book of Nature shows us God portrayed in the inanimate part of the Universe. In the Book of Revelation we see Him reflected in the mind of Man. But the image is not constant. It changes according to the ability of mankind to reflect it. In the words of Robert Browning it "decomposes but to recompose again."

In the early ages of history the almighty nature of the Deity was uppermost in man's mind. He is realized then as a terrible Person who must be satisfied and propitiated with costly sacrifice. In that stage of Revelation the human attitude to the Creator is that of fear.

There came in the course of time the realization that the infinite might of the Creator is controlled according to a purpose. He is not subject to whims nor sudden fancies. He does not act from caprice nor from spite. His purpose is right and His character is that of righteousness. With this development in man's idea of God there came the problem how to explain what appears to be the unfair treatment afforded to many whose lives are apparently exemplary. The inscrutable mystery of pain still remains to taunt us. But notwithstanding difficulties insuperable men came to believe that God is altogether upright and holy.

At last the ideas of might and holiness are supplemented by a discovery of His tenderness and mercy. To speak of the dawning consciousness as a discovery is only to look at the development from man's side. If you prefer to say that God revealed these truths about Himself you imply that the human mind had become sufficiently qualified to receive them. The Divine Master does not pass His apprentices to a higher degree until they have made themselves fit to receive it. The mystery of the Divine tender-

ness could not have been communicated to those who had not yet been initiated into the knowledge of His righteousness. "To him that hath shall be given" for he alone has the ability to receive.

By God's tenderness is meant His sympathy with, and provision for, the weak and the unfortunate; His pity for the wayward and the oppressed. The Book of Revelation proceeds to record that in the reign of Caesar Augustus came One who penetrated more deeply into the mysteries than any before and who assures us that "God is Love."

The human mind had all through the ages been qualifying itself to perceive new features of the Divine countenance. The human character had been coming gradually to such a state that it could more adequately receive an impression of the Divine. Mankind is ever trying to place itself in proper position to receive an ever grander expression of the Most High. To attain to that proper position is man's part of the great process. Always in the mind of the Master there is the desire to enlighten the suppliant. Always in the suppliant there has been something to hinder complete vision. Who knows how often by a Hand unseen the human race has been guided along the path of progress? Achievement is no less human because it has been inspired from on high.

\* \* \* \* \*

So we have, my brothers, these two great Books of Nature and of Revelation. They each proclaim, but in a tremendously grander style, just what we have tried to express in hymns and psalms and music and ceremonial, viz., the greatness and the holiness and the loving-kindness of that Great Spirit in Whom we "live and move and have our being." Freemasonry requires of us a due attention to them both. Neither alone is sufficient for proficiency in our art. It may be (let us say it reverently) that neither is yet complete. God, we may be sure, has not

yet exhausted His resources. The Great Designer has plans, (is it not likely?) that are not yet outlined on His Trestle Board. Why should we suppose that He has ceased to plan, and to create, and to adorn? Why should we suppose that we have received already all that He has to reveal? Because the first degree is wonderful may not the next be more wonderful still? This little taste of life has afforded its achievements, its triumphs, its satisfactions. Here in the midst of numerous hindrances, with a desire for the better only faintly experienced, we have nevertheless enjoyed at least a glimpse of the Light Supernal. But awaiting our fitness to appreciate them are all the possibilities that can originate in the loving mind of an Infinite Parent.

\* \* \* \* \*

On a certain occasion an officer of a royal household was returning from a pilgrimage to the Temple. "Sitting in his chariot he read Esaias the Prophet." There approached him one who courteously enquired, "Understandest thou what thou readest?" His reply was that which comes to your lips as you attempt these great text books in Freemasonry, "How can I, except some one should guide me?"

The bewilderment which overwhelms us as our eyes are opened to the Light; our inability to comprehend the Heavenly Wisdom; our fear of misinterpreting what concerns us so greatly; these compel one to ask that "some one should guide me."

The Guide, my brothers, is never lacking. Along a path unknown, led by a Hand unseen, mankind proceeds on its way toward perfection. For the Architect is Himself the Builder; the Author is Himself the Interpreter; God is Himself our Guide.

## REPORTS OF DISTRICT DEPUTY GRAND MASTERS.

### DISTRICT No. 1.

**MOST WORSHIPFUL GRAND MASTER:** Herewith I beg to submit my report as District Deputy Grand Master of District No. 1. In doing so I am glad to be able to state that I have completed a visit to each Lodge in the District.

It was my privilege to accompany you on your official visitation of St. John's Lodge, No. 2, on January 5; of Hibernia Lodge, No. 3, on January 12; of The New Brunswick Lodge, No. 22, on January 14, and of The Union Lodge of Portland, No. 10, on January 19. celebration of Albion Lodge, No. 1, which event fell on the same date. The installing of W.M. Price, Wardens and other officers of Fownes Lodge was duly carried out, and we afterwards spent a pleasant hour with refreshments and intercourse with the brethren.

Fownes Lodge is anxious to make progress, is fortunate in having a very painstaking secretary, and deserves all the support that Grand Lodge can give. #### DISTRICT No. 2.

### DISTRICT No. 3.

MOST WORSHIPFUL GRAND MASTER: I beg to present my report as District Deputy Grand Master for District No. 3 for the year ending August, 1926.
