



Briefly reviewing the past year, we have every reason to feel grateful, and render thanks to Providence for the many blessings we have received, and while world conditions are not as bright as we would hope, nothing of a serious nature, that time and sound judgment cannot rectify, appears on the horizon. Our Canada has stood up well during the period of depression, in fact much better than other countries.

#### OFFICIAL VISITS.

Upon assuming office in August, 1928, I expressed the desire to be able to pay an official visit to all the private lodges in the jurisdiction, and thus observe the class of work as put on by the individual Lodge, as well as to look over the quarters occupied, and see the progress being made by the different lodges. I am pleased to be able to report that outside of four of the Saint John City Lodges, that suffered the loss of their meeting place in the Masonic Temple fire (and were meeting in very small and inadequate quarters), all the Lodges in the Province have been

paid an official visit by Grand Lodge Officers during my term of office. The following Lodges have been visited during the year:

November 2, 1929, visited Sunbury Lodge, No. 42, Fredericton Junction, the first degree being conferred, and the work was very creditably carried on. The attendance was possibly the largest in the history of the Lodge.

November 11, 1929, visited Saint Martins Lodge, No. 30, Saint Martins. A good representation of brethren from Saint John were present. Immediate Past Master, Worshipful Brother Howard occupied the East. The Third Degree was exemplified by officers from Saint John Lodges, Worshipful Brother Duncan occupying the Chair. The attendance was very small, and while the building and surroundings show that this Lodge in the past had been a prosperous one, I was keenly disappointed with its present outlook, and after discussing the situation with the few faithful brethren who attended the Meeting, learned that the harmony which once existed in the Lodge was a thing of the past, and had no hesitation in so stating to the brethren assembled. I am pleased to learn that conditions now show considerable improvement, and feel sure that this year's report will be more encouraging.

November 4, 1929, visited Zetland Lodge, No. 24, Shediac. The Master Mason Degree was conferred in a very creditable manner and a very large number were present.

December 27, 1929, visited Keith Lodge, No. 23, Moncton, where it was my privilege to again have the pleasure of installing the officers for the New Year.

January 11, 1930, on invitation, visited Tweedie Lodge, No. 41, Moncton, for the purpose of installing the newly elected officers.

January 22, 1930, was pleased to accept an invitation to install the officers of Lebanon Lodge, No. 28, Sackville, a goodly number of Grand Lodge Officers being present.

April 30, 1930, visited Alexandria Lodge, No. 33, Devon. The First Degree was conferred in a most excellent manner. The large attendance, particularly of young members, showed that the Lodge is progressing.

May 1, 1930, visited Hiram Lodge, No. 6, Fredericton. The First Degree was conferred in a satisfactory manner, and from what I could learn, after seeing the degree work, I would surmise that a friendly rivalry exists between Alexandria and Hiram Lodges as to their work. The Lodge room of Hiram Lodge is very homelike and attractive.

May 6, 1930, visited Sussex Lodge, No. 7, St. Stephen. The First Degree was exemplified in a very creditable manner. The attendance was large. On this occasion we suffered from the non-arrival of our Regalia, the forwarding of same having been overlooked from the place of last visit. We were kindly provided for by a number of the Senior Officers and Sussex Lodge very graciously accepted our apologies for having to appear without the proper Regalia.

May 7, 1930, paid an official visit to Alley Lodge, No. 14, Upper Mills, the Second Degree being conferred in a creditable manner. The Lodge is entitled to special mention for the activity shown in its work, considering its situation, and the distance that some of its members have to travel in order to attend.

May 8, 1930, visited Victoria Lodge, No. 26, Milltown, the Second Degree being well conferred. The good work of R.W. Brother Vroom, Worshipful Brothers Hiltz, Budd, Laughlin and other active past officers being especially noticeable in Sussex. Alley and Victoria Lodges.

May 30, 1930, visited Blackville Lodge, No. 43, Blackville, the Third Degree being conferred. This Lodge is not showing the progress I would desire in keeping with its equipment, and I would judge is suffering from poor attendance, and the lack of interest of some of its former

strong supporters, a condition which I trust will gradually improve since it has been drawn to its attention in a kindly manner. I am looking to our good friends from Northumberland and Miramichi Lodges to take Black-ville, No. 43, under their care.

June 3, 1930, it was my pleasure to again return to Charlotte County and visit Mananook Lodge, No. 38, Grand Manan. The Third Degree was conferred. The work clearly showed lack of rehearsals of its officers. I am convinced that Mananook can improve its work very materially if the officers will take more interest, supported by the members, and also encourage its Past Masters to co-operate. The Lodge quarters are convenient and the building shows every evidence of good care.

June 4, 1930, visited Saint George Lodge, No. 12, St. George. This Lodge is well supported by its officers. The Third Degree was conferred in a most creditable manner. The attendance was large, particularly when taking into consideration that a large number of its members were assisting to fight the fire which was raging in the nearby town of St. Andrews.

June 5, 1930, was pleased to visit Saint Mark's Lodge, No. 5, the mother Lodge of Right Worshipful Brother James Vroom, and to have the pleasure of dedicating their hall to the uses of Masonry. The ceremony was carried out previous to the exemplification of the Third Degree, and while it was a matter of great regret that the beautiful town of St. Andrews should be visited by such a disastrous fire on the day previous, the attendance was good, the work of a high character, and the future of Saint Mark's Lodge seems assured.

One very gratifying feature in connection with the Official Visits is to know that the Lodges are, in nearly every case, meeting in attractive and well kept rooms, thus adding materially to the comfort of the attending members.

The work in the majority of the Lodges is very creditable and the ritual as far as possible is being well adhered to, but I still feel that the outside Lodges are laboring under considerable difficulty in not receiving the proper instructions in the correct ritual, and as suggested in my report of last year, I feel assured that this will be the case, until such time as Grand Lodge appoints a Traveling Lastwater, who can spend considerable time with the

ease, until such time as draint bouge appendix the ease, until such time as draint bouge appendix the interested members. I consider this the only solution to the existing difficulty and trust that Grand Lodge will authorize the incoming Board of General Purposes to carry out this suggestion. I do not consider that it will be a matter of great expense and feel strongly that the outside Lodges are entitled to this consideration.

Before closing my remarks, in connection with official visits, I especially wish to thank the good brethren of Fredericton, Devon, St. Stephen, St. Andrews and Milltownfor the entertainment and courtesies extended during our necessitated stop-overs in their towns, which tended to make our visits most enjoyable.

I have made no attempt to enumerate the names of the brethren who accompanied me on my Grand Lodge visits. I was well supported on every occasion by officers and members from nearby Lodges as well as, in a good many cases, by brothers from a considerable distance. If I attempted to enumerate the names of the brothers, I am quite sure some might be overlooked and rather than have this occur, I take the opportunity of thanking all officers and members who in any way assisted in making my visits pleasant and successful. On every occasion we were most hospitably entertained, and banquetted in every instance, in some cases at a great deal of expense. Same were thoroughly enjoyed by all Grand Lodge officers, but I sometimes wonder if it is not too great a tax on some of the smaller Lodges to go to the expense they do in some cases, in entertaining the Grand Lodge officers. We received nothing but the kindest treatment from all and feel confident that the Official Visits have not only been a success, but have tended to bring the individual Lodges and Grand Lodge more closely together.

#### AMENDMENTS TO BY-LAWS.

During the year a number of applications were reeeived from private Lodges asking the approval of Amendments to By-Laws. In most cases, only slight changes were necessary in order to make same more applicable to their present requirements. In some cases copies of the old By-Laws were submitted and I feel convinced that some of the Lodges in the jurisdiction are using very old By-Laws and that a revision would materially improve same, and this brings up the question—if a Uniform Set of By-Laws cannot be compiled that, with the exception of the amount set for fees and dues and time of meeting, might not be adopted for the use of all the private Lodges. Of course, this is a matter for the consideration of the Lodges and with the exception of having the approval, is not one for Grand Lodge.

#### DEDICATIONS.

I have already referred in my report of Official Visits to the Dedication of Saint Mark's, No. 5, Lodge Room at St. Andrews. This Lodge for some years occupied the same hall that they have now returned to, and since early in the year have been working under dispensation permitting them to use the hall for Masonic purposes until same was duly consecrated. This ceremony was carried out on June 5th and the brethren are to be complimented on the appearance of their Lodge room and surroundings.

On special invitation of Westmorland Lodge, No. 44, Port Elgin, it was my privilege to have the honor of dedieating their new hall. Since this Lodge received its warrant some nine years ago, it has been meeting in leased premises and decided the time had come to provide a Masonic Home of their own; and putting forth considerable energy, hard work and finance, they have succeeded in their laudable enterprise. A property was purchased by the Lodge and the work of the formation of a hall was proceeded with; and today the efforts of the brethren of Westmorland Lodge has placed in their hands a neat, commodious and well appointed hall—which stands as a great credit to all those who in any wise have aided the object.

The ceremony of dedication was greatly enhanced by a splendid male choir from Moncton, under the direction of the Grand Organist, Wor. Bro. J. G. MacColl, and in addition to the choral work several special numbers were well rendered by Bros. H. S. Austin and A. L. MacKendrick. The music rendered during the evening was enthusiastically greeted by the large gathering of Brethren present.

The attendance at the ceremony was about one hundred and twenty; and many brethren came from far and near to assist the Port Elgin brethren in the dedicatory ceremonies, and to offer their hearty congratulations. Previous to the ceremony of dedication, the visiting brethren were splendidly entertained at a most enjoyable supper provided by the members of Westmorland Lodge and their lady friends, under the able direction of P.M. Wor. Bro. Nicholson—no effort being spared to cater to the wants of the inner man.

I was particularly pleased to have present at the dedication ceremony R.W. J. D. B. F. McKenzie, Past Grand Master, who during his term as Grand Master issued the Dispensation to Westmorland Lodge.

R.W. Bro. A. R. Fraser, who might be termed the Father of Westmorland Lodge, was also present. Bro. Fraser was the first Master of Westmorland Lodge and still retains his membership, being very active at all times in anything concerning the future welfare of the Lodge, in the formation of which he was the leading spirit.

As mentioned above, the attendance was particularly large and the evening proved a most enjoyable one. The members of Westmorland Lodge are to be congratulated for the foresight manifested in the procuring of such a well located building and assuming the financial burdens they have in this connection. It is the sincere wish of Grand Lodge that, as in the past, this Lodge may prosper.

### RULINGS AND DECISIONS.

No contentious question has come before me during the last year, which I think is conclusive evidence that harmony exists pretty well throughout the jurisdiction. Only one decision that might be mentioned in my report was given, and that was in connection with a private Lodge that wished to make use of their room for the discussion of matters of public interest. I can do no better than quote my reply, which if concurred in, may settle the question for future similar requests:

"As regards the communication from ..... Lodge, requesting the approval of using the floors of the Lodge while in session, I think that possibly this matter can be decided by the members of this Lodge themselves, or can be very safely laid over for the present. While it is commendable to see the members interested in matters of public interest, it is only on rare occasions that any body can view the situation from the same viewpoint, and I can readily see where a question arising, that at the start may not seem to be contentious. may gradually prove to be one of that nature, and in a small centre might cause division in the Lodge. I would suggest that such matters be discussed after the business of the Lodge has been concluded and the Lodge closed. However, I may possibly be viewing same from a situation that may never arise, but it is so easy to create a feeling on matters of Public Interest that I think such discussions should be kept clear of the Lodge."

Have not thought it necessary to mention the name of the Lodge making the request, as I feel that my ruling, if concurred in, should cover the whole jurisdiction.

#### FINANCIAL.

Our Financial Position at the close of the year ending July 31st, 1930, shows that Grand Lodge is on a sound basis, and while I will not enter into details, as same are fully covered in the audited report of the Very Worshipful Grand Treasurer, might briefly state for the information of those present that our assets at present total the tidy amount of \$67,396.45, made up as follows:

The donation to the New Brunswick Protestant Orphans' Home as per resolution of Grand Lodge of August 22, 1929, amounting to \$2,943.70, as well as payment to Saint John Masonic Temple Ltd. of \$35,000.00, as authorized at Emergent Communication of Grand Lodge held in West Saint John, March 21, 1929, having been fully paid.

#### GRAND LODGE QUARTERS.

The Board of General Purposes have undertaken to lease from the Saint John Masonic Temple Ltd. permanent quarters in the new Temple, and while the building at time of writing is not complete, the V.W. Grand Secretary has been occupying his office for some months. The quarters consist of a Grand Secretary's Office, Library and Lobby, together with the use of the main Lodge Room for the Communications of Grand Lodge at a rental of \$1,500.00 per annum.

The Board of General Purposes has taken action for the proper furnishing of the Library and Grand Secretary's office. and when complete, Grand Lodge will have very convenient, commodious and attractive quarters.

Invitations were received during the year from the Grand Lodge of Nova Scotia, Grand Lodge of Prince Edward Island and the Grand Lodge of Ontario, asking me to be their guest at their Annual Communications. The Grand Lodge of the Province of Ontario was at the same time celebrating its 75th Anniversary. I regret, however, that I was unable to accept any of the above invitations.

The reports of the Right Worshipful Deputy Grand Master and Worshipful District Deputy Grand Masters, which will be laid before you in detail will show that the different districts have been pretty well covered and that good progress in Masonry is being made. The activities shown throughout the jurisdiction, particularly by the younger Masons, has convinced me that, if these Lodges are supported as they should be by Grand Lodge and frequent visits made by members of nearby Lodges, the improvement will be very noticeable during the next year or two.

I can assure the individual Lodges that it has been a great pleasure to me to have the opportunity of paying every Lodge in the jurisdiction an official visit and trust that my successor may take as much pleasure and enjoyment out of his visits as I have. If he does, I feel convinced that he will consider the time well spent.

### GRANTS FROM FUND OF BENEVOLENCE.

As you will note from the Very Worshipful Grand Treasurer's report, the amounts granted from the Fund of Benevolence for relief during the past year amounts to \$1,325.00, which item is in itself a small one. I regret that I cannot convince myself that we have the proper method of handling such grants. While I do not wish to infer that grants in the past have been made where probably there was no immediate need for same, there are cases where a possibility exists of the good graces of any private Lodge being imposed upon.

One case particularly came to my notice this year through an investigation that the Masonic Board of Relief of Brooklyn made at our request. Several grants had been made to the interested person without the true information of this person's position being laid before the Lodge, the reason being that no one in the vicinity was in possession of the knowledge.

There are also some cases throughout the jurisdiction where some of our members or families are, or will very shortly be, in need of assistance, and I trust that the recommendation as contained in the report of the Committee that passed on the Grand Master's Address last

year may be thoroughly considered at this session of Grand Lodge. The report, as you will remember, reads as follows: "The Grand Master's desire to see upon the Trestle Board of Grand Lodge, the design of an object worthy of achievement by our noble Order is heartily shared by the Committee and recommended to Grand Lodge for deliberate consideration at the next Annual Communication."

Within the last few weeks, I had the opportunity of thoroughly inspecting the Masonic Home at Windsor erected by the Grand Lodge of the Province of Nova Scotia, and, while at present, I am not making any recommendation as to the establishment of such a home in the Province of New Brunswick, I think the Grand Lodge of Nova Scotia is to be congratulated upon their foresight in the erection of such an institution and the manner in which same is conducted. I was deeply impressed and after discussing the surroundings with some of the Masonic Brethren at present inmates of the Home, came away convinced that those whose circumstances are such as to necessitate the care of this Institution are most fortunate indeed in having the opportunity of passing the closing days of their lives in such a beautiful Home.

I therefore trust that the Grand Lodge of New Brunswick may, not later than this session, take steps that will eventually be productive of some scheme whereby any member of our Fraternity, who in his declining years finds himself without Finance to Sustain or Friends to Support, may have the assurance that his future will not be left to the unkind world to determine, but that those whose privilege it was his to call by the name of brother, may still stretch forth the helping hand to support him in his old and dark days.



Twining Hartt, who has been most attentive and painstaking throughout, and made our visits more enjoyable by his presence, kindly advice and instruction given during the Degree Work of the different Lodges.

Also, I desire to express my sincere thanks to the Very Worshipful Grand Treasurer, Brother Ernest H. Cameron, for his courtesy and prompt attention to the financial details of the Craft throughout the year.

I also wish to mention the support accorded by the Worshipful Grand Director of Ceremonies, Brother A. Vye Gibson, and the Worshipful Assistant Grand Director of Ceremonies, Brother W. Perley Barnhill; also by Right Worshipful Brother A. R. Fraser, who was always willing to assist at home or abroad, and very kindly looked after duties either as Grand Director of Ceremonies or Assistant Grand Director during the absence of Worshipful Brother Gibson.

As I am soon to retire from office and will shortly be called upon to hand over the Gavel of Authority to my Successor, I wish to state that I have thoroughly enjoyed serving you to the best of my ability, and while my two years of office have been strenuous ones, caused to a considerable extent by the loss to the Fraternity of our Masonic Temple, the many acquaintances I have formed throughout the jurisdiction and the delight experienced in meeting my Masonic Brethren has amply repaid me for any energy that I have put into the work.

I sincerely trust that my Successor in Office may be accorded the same courteous receptions throughout the jurisdiction that were given me, and if so, I feel certain that at the end of his term of office, he will feel as I do today, that the Honor conferred upon him has indeed been an expression of the goodwill and brotherly love which have actuated and inspired Masons throughout the world, to give of their best for the upbuilding of our noble Craft, and I do not think it would be amiss at this time to close my address by quoting the inspiring lines from that noted poem dedicated to "The Spirit of Men," which probably

During the past year, the Board held regular quarterly meetings and also a special meeting preparatory to this Annual Communication. The Vice-President of the Board was R. W. Bro. John Thornton, P. D. G. M.; and the same Committee as last year, viz., the M. W. Grand Master and R. W. Bros. LeBaron Wilson and George D. Ellis administered the Fund of Benevolence and received and considered the applications for relief.

The income of the Fund for the year, as shown by the Grand Treasurer's statement, was \$2,630.00.

The Investments stand at \$58,000.00 to which the sum of \$2,000.00 of the cash balance will now be added; so the Capital of the Fund may be placed at \$60,000.00.

As the warrants of the five Lodges in Saint John were destroyed in the Fire at Masonic Hall, it will be necessary to issue a duplicate warrant to each of the Lodges to replace the one lost. Suitable full sized parchments have been obtained from Spencer & Co., London, and the work of engrossing is now in progress; but the Board has had to realize that the cost of a finished warrant will much exceed the fee originally fixed by the Constitutions. Due notice has therefore been given of amendments to the scale of fees increasing the amount both for an original and a duplicate warrant to fifty dollars. This sum represents the present actual cost.

The Printing Account includes a new edition of the Constitutions, 1,000 copies at a cost of \$156.00; and these copies are obtainable at 30 cents each. It may not be amiss to state that not all the Lodges are mindful of the regulation "that a copy of the Constitutions of Grand Lodge shall be presented to every candidate when he receives the Master's degree."

A new supply of the travelling cards has also been printed and the card lengthened to give space for the

member's signature. The travelling cards were authorized by Grand Lodge in 1914 and hitherto they have been issued to the Lodges as applied for without charge, but, in future, to cover the printing and postage, a price of 10 cents each will be asked.

By the Financial Statement of the Grand Treasurer it will be seen that two accounts which have been of much interest latterly, have been closed, the Sinking Fund and the Insurance Fund. As to the Sinking Fund, the sum of \$602.00, arrears of Assessment in full, was paid in during the past year; the Bonds of the N. B. Masonic Hall Company and of the Grand Lodge Corporation were taken up at maturity and the full balance of \$2,943.70 remitted to the New Brunswick Protestant Orphans' Home.

In November last, a communication was received from The United Grand Lodge of England containing a statement of the Basic Principles, eight in number, on which that Grand Lodge could be invited to recognize any Grand Lodge applying for recognition. The statement had been drawn up, said the V. W. Grand Secretary, "with a view to present in concise form those fundamental principles which have been held by English Freemasonry from the very beginning and by Grand Lodge since its earliest assembling more than two hundred years ago." The correspondence will be printed in full in our Proceedings of the year.

To complete the Regalia for the officers of Grand Lodge, silver gilt jewels for the sixteen Full Dress Collars have been ordered from Spencer & Co., and also six undress "Suits" for Grand Stewards, aprons and collars, leather lined and metal gilt jewels. Thus the full Dress and the Undress Regalia will each consist of twenty-two complete "Suits."

At its communication in June last, Keith Lodge No. 23, Moncton, by resolution extended to Grand Lodge a cordial invitation to hold its Annual Session in the Masonic Temple in that city in the event of the New Temple in Saint John not being sufficiently advanced; and the Board now expresses its appreciation of this thoughtful action by the Brethren of Keith Lodge.

# REPORT OF THE DIRECTORS.

TO "THE MASONIC GRAND LODGE CORPORATION":

In continuance of the report made at the Annual Meeting last year the Directors have now to state that the Deed to the "Saint John Masonic Temple, Limited," of the land and premises on Germain Street was duly executed and delivered in September last. Also, that in accordance with the resolutions of the Corporation and of the Directors quoted in the report, the sum of \$35,000.00 of the Insurance monies was shortly afterwards paid over to the Temple Directors.

At its December Meeting the Board was in receipt of the following letter:

#### TO THE GRAND SECRETARY, CITY:

I beg to enclose you herewith rough sketch of the second floor of the new Masonic Temple showing the Library and Board Room, Lobby and Grand Secretary's office with vault accommodation which have been provided in this building for Grand Lodge purposes. The annual rental attached to this accommodation is \$1,500.00, which includes the use of the Blue Lodge Room together with reasonable wall space for the hanging of pictures, etc.

With this letter and sketch was also a general description of the proposed premises by the Architect Bro. Garnet W. Wilson, and after full consideration your Directors by resolution accepted the proposal and approved of the described quarters and the amount of rental.

The above papers are entered in full upon the Board's records.

The office has been occupied by the Grand Secretary since the first of May, and a Committee has been appointed to attend to the furnishing and fitting up of the apartments so taken over for Grand Lodge purposes.







Singing by the choir:

Come Charity, with goodness crowned, Encircled in thy Heavenly robe; Diffuse thy blessings all around To every corner of the globe.

Most Worshipful Grand Master: "May the Great Architect of the Universe, the Giver of every good and perfect gift, bless this Temple (Lodge) and grant to the Brethren here assembled in needful supply, the Corn of Nourishment, the Wine of Refreshment and the Oil of Joy." Amen.

Response: "So mote it be."

Singing by the choir:

To Heaven's high Architect all praise— All praise, all gratitude be given, Who deigned the human soul to raise By mystic secrets sprung from Heaven.

The V.W. Grand Chaplain was conducted to the altar and offered this prayer:

Almighty, All-wise and Eternal God! Thou who art the Great Architect, Creator and Ruler of the universe, we implore Thee to vouchsafe Thy blessing upon this assembly. We have met here to dedicate this Temple in Thy name. good of our fellow men. The M.W. Grand Master passed through the procession to the East and the Grand Officers then resumed their places.

The Grand Honours were then given.

Proclamation was likewise made from the West and from the East and the Grand Honours repeated each time.

The Brethren were then seated.

# ADDRESS BY THE GRAND CHAPLAIN

# V.W. BROTHER THE REV. BRICE D. KNOTT.

Two years ago the members of the Masonic Fraternity were lamenting the loss of the Temple, which had served the Craft so well for many years. But today out of the ruins of the old a new and better Temple has arisen and members of this Ancient and Honourable Fraternity from every part of the Province of New Brunswick have gathered here with grateful hearts to assist the M.W. Grand Master in dedicating this most beautiful structure to the service of God and their fellows, in due and ancient form.

Masons are greatly impressed with the elaborate and ornate beauty of King Solomon's Temple as depicted in sacred writ and Masonic history. When King Solomon and Hiram, King of Tyre, had together inspected the work of the Masters, the craftsmen and the apprentices, they passed judgment upon it and pronounced it "Well Done." Glorious was that ancient Temple in its unity, sacred in its completeness, Holy in its service to the ever living God.

It was made abundantly clear in the solemn dedicatory Prayer of King Solomon that the usefulness of the Temple was to be measured by the extent to which it might be made available in the improvement and advancement of the chosen human race.

Masonry has patterned, as far as possible, its material structures after that magnificent Temple of the far distant past and at the same time has deduced its moral and spiritual tenets from the significant appointments and adornments of the Holy Temple.


Thus, even to the present day, have come to us the glories and renown of the Ancient institutions having the burden of the same sweet song of faith, and hope, and love, founded on the Temple and its adornments, and its furniture, in their harmonious and beautiful proportions, its exquisite and shapely columns, its rare tracery and devices, its elegant and choicest ornaments, proclaiming throughout the resounding aisles, and through the crypts, the naves, the arches, that while Faith is the evidence of the Heavenly Temple, the love born confidence in one another is the crowning virtue of Brotherhood.

The completion of this modern and commodious edifice reflects credit upon the architect and all associated with him in the work. To the Fraternity, also, great praise is due on their part in carrying forward this enterprise in a period of depression. It is an exhibition of unbounded love for the Fraternity and of faith in its future, and of confidence in the Brethren. With ceremonies, whose origin reaches back into antiquity, it has been dedicated with corn, wine and oil in the name of God to Freemasonry. In the name of the Holy Saints John to Virtue and in the name of the Whole Fraternity to Universal Benevolence.

Masonry first and foremost pays its respects to God. Mankind has always and everywhere held to some conception of God. The belief in a Supreme Being is inherent in human nature and so thoroughly interwoven with our nature is the sentiment, that it is impossible for any one, at any period of his life, wholly to divest himself of it. Masons are taught to reverence and adore God. The God as revealed in Holy Writ, especially that God who manifested Himself through the Temple of old, is the one worshipped by every Mason worthy of the name. To this Holy God he makes his supplication and to Him he looks for succor and guidance in the varied circumstances of life. As he stands at the altar of his Lodge with his brethren as witnesses, he must affirm that his trust is in God, and if unwilling so to affirm he cannot receive the confidence and approbation of Masons. I repeat the first and supreme teaching of Masonry is the realization of God in our midst. All ages of moral and spiritual progress have been marked by a sense of God. The Jewish people having no brilliancy of aims, philosophy or art, a little people in a tiny land, were raised to a dignity and influence unique among the nations by their consciousness of God. At the heart and centre of Israel's worship and witness was the thought of the Temple on the hill, with its silent chamber lighted only as on golden Cherubim and blood-besprinkled mercy-seat fell the radiance of the



Shekinah of God and when the Jew realized in his history the unfolding of a Divine purpose, felt in it the heartbeat of an everlasting love, he arose to a new stature and had a message for the whole world. Their glory faded when they lost their consciousness of God. It behooves us as Masons to follow our ancient brethren who founded Masonry at a time when agnosticism was prevalent and who desired to keep a light on the altars of Masonry and in the world the fire of true and reverent devotion to an all-wise God in whose image man was made, and in whose name this Temple is dedicated.

This Temple has been dedicated in the name of the Holy Saints John to Virtue. Masonry stands for everything which is morally good. Let this genius of Masonry preside over our conduct and under her sway let us perform our part with becoming dignity; let us preserve an elevation of understanding, a politeness of manner, an evenness of temper; let our recreations be innocent and pursued with moderation; and never let irregular indulgences lead to the subversion of our system, by impairing our faculties or exposing our character to derision. Virtue requires that in conformity to our precepts, as patterns worthy of imitation: we should let the respectability of our character be supported by the regularity of our conduct. Virtue will shine more brightly when illumined by the great light. It teaches us to what we should give our lives, and that unselfish service is one of its choicest fruits. Then as citizens of the world, loyal in all our engagements to our King and Country and the Craft, we shall be living examples of virtue to which we have dedicated this Temple.

In the name of the whole Fraternity, this Temple has been dedicated to Universal Benevolence. Charity has long been a distinguishing characteristic of Masons. It grows out of his appreciation of the unnumbered blessings bestowed upon him by Deity; and properly exercised is the greatest pleasure man can enjoy. The bounds of the greatest nation or the most extensive Empire cannot circumscribe the generosity of a liberal mind. Men in whatsoever situations they are placed in, are in a measure, the same. They are exposed to similar dangers and mis1930] GRAND LODGE OF NEW BRUNSWICK. 455

fortunes; they have not wisdom to see or power to prevent the evils incident to human nature; they stand, as it were, in perpetual suspense between hope and fear, sickness and health, plenty and want. A mutual chain of dependence subsists through the race. All human beings are, therefore, proper objects of the exercise of charity. Hence, by sympathizing with our brethren in misfortune, by restoring peace and tranquility to agitated spirits, we serve the great aims of the Masonic System.

Masonry is a true, universal Brotherhood, numbering among its ranks the great in every human sphere; a fact which demonstrates that Freemasonry is an institution honoring to God and beneficial to man. The fact of its time-immemorial age and its world-wide prevalence shows, that as to its moral principles; its social order; its system of jurisprudence and government; its stability and permanence; its educating influence; its adaptability to the conditions, needs and aspirations of free and progressive people everywhere; its humanizing efficacy; its non-partisan and non-proselyting character; its perpetual and voluntary charity; and, in short, its "modus vivendi et operandi"; it contains within itself the essential and necessary elements of a true universal brotherhood, destined to exist and prosper, world without end.

Solomon's Temple fell before the ravages of barbarous force. The lapse of time, the hand of war, the ignorance of man, have destroyed many valuable monuments of antiquity. Freemasonry, notwithstanding, has survived. The attentive ear receives the sound from the instructive tongue, and the sacred mysteries are safely lodged in the repository of a faithful breast. Solemn truths are imprinted upon the memory and thus the excellent tenets of the institution are transmitted unimpaired through a succession of ages.

The task of speculative Masonry is to see that under the Great Architect of the universe the various Masters, Craftsmen and Apprentices are guided by the great lights in the construction of the Temple of Character. As they pass through the various precincts of the Temple in search of light and finally discover its sacred Truths, may their lives reflect the light of the truths learned. Then, when

the working tools are laid aside, they will have merited the password that will admit them to that more glorious temple, that house not made with hands, Eternal in the Heavens.

R.W. Bro. J. Gordon Forbes, Senior Past Grand Master, addressed Grand Lodge and despite his ninety odd summers spoke with much of his wonted vigor and enthusiasm and his remarks were frequently applauded.

Singing by the choir:

Master Supreme! Accept our praise Still bless this consecrated band. Parent of Light! Illume our ways And guide us by thy sovereign hand.

May Faith, Hope, Charity divine Here hold their undivided reign. Friendship and harmony combine To soothe our cares and banish pain.

May Wisdom here disciples find— Beauty unfold her thousand charms; Science invigorate the mind— Expand the soul that virtue warms.

May pity dwell within each breast---Relief attend the suffering poor; Thousands by this our Lodge be blest, Till worth, distress'd, shall want no more.

Grand Lodge was declared closed in ample form.

The Officers of Grand Lodge assembled about the altar and on being joined by the M.W. Grand Master and M.W. Brother John A. Rowland, retired in procession.



credible manner. I was very fortunate in having several Past Masters from Moneton in attendance, whose presence and support added greatly to the pleasure of my visit.



After some discussion, which took place in regard to the small attendance at the regular Communications, the Lodge closed by singing the National Anthem, and all left for their respective homes.

I have attended practically all the Communications of Benjamin Lodge during the year and am able to say that the work done by the Worshipful Master, Brother Corey, and his officers are up to the standard of this Lodge. 



# COMMUNICATIONS FROM THE UNITED GRAND LODGE OF ENGLAND REFERRED TO IN THE REPORT OF THE BOARD OF GENERAL PURPOSES

Dear Sir and R.W. Brother,

I am desired by the M.W. The Grand Master, H.R.H. the Duke of Connaught, K.G., to send you a statement of the Basic Principles on which this Grand Lodge could be invited to recognise any Grand Lodge applying for recognition by the English Jurisdiction.

The statement has been drawn up with a view to present in concise form those fundamental principles which have been held by English Freemasonry from the very beginning and by Grand Lodge since its earliest assembling more than two hundred years ago.

It is thought desirable that every Jurisdiction with which this Grand Lodge is in friendly relationship should have this statement specially brought to its notice.

# BASIC PRINCIPLES FOR GRAND LODGE RECOGNITION.

1. Regularity of origin; i.e., each Grand Lodge shall have been established lawfully by a duly recognised Grand Lodge or by three or more regularly constituted Lodges. 1930] GRAND LODGE OF NEW BRUNSWICK. 465

2. That a belief in the G.A.O.T.U. and His revealed will shall be an essential qualification for membership.

3. That all Initiates shall take their Obligation on or in full view of the open Volume of the Sacred Law, by which is meant the revelation from above which is binding on the conscience of the particular individual who is being initiated.

4. That the Membership of the Grand Lodge and individual Lodges shall be composed exclusively of men; and that each Grand Lodge shall have no Masonic intercourse of any kind with mixed Lodges or bodies which admit women to membership.

5. That the Grand Lodge shall have sovereign jurisdiction over the Lodges under its control; i.e., that it shall be a responsible, independent, self-governing organisation, with sole and undisputed authority over the Craft or Symbolic Degrees (Entered Apprentice, Fellow-Craft, and Master Mason) within its Jurisdiction; and shall not in any way be subject to or divide such authority with a Supreme Council or other Power claiming any control or supervision over those degrees.

6. That the three Great Lights of Freemasonry (namely, the Volume of the Sacred Law, the Square, and the Compasses) shall always be exhibited when the Grand Lodge or its subordinate Lodges are at work, the chief of these being the Volume of the Sacred Law.

7. That the discussion of religion and politics within the Lodge shall be strictly prohibited.


8. That the principles of the Antient Landmarks, customs, and usages of the Craft shall be strictly observed.
