ANNUAL MEETING

## GRAND MASTER'S ADDRESS.

## BRETHREN OF GRAND LODGE:

It is with unfeigned pleasure I bid you welcome to this the Seventy-second Annual Communication of The Grand Lodge of New Brunswick. We come here to Grand Lodge to renew old acquaintances, to form new, to learn what our Brethren abroad are doing, to profit by their experiences, and to wisely legislate for the good of our Beloved Order, to rejoice with those who rejoice, to weep with those that weep. Let us therefore who are here assembled in the providence of God, humbly and reverently worship and adore our Great Creator for His goodness and the tokens of His favour, and pray He may grant us the desire and earnest purpose to serve Him with more zeal and faithfulness in the future than we have done in the past. I trust that thus your deliberations will prove of profit to all and make for a stronger, firmer upbuilding of the Craft in this jurisdiction and have a far-reaching effect upon our friends and neighbours wheresoever dispersed.

My first duty is to acknowledge with warmest fraternal affection and pride the honour conferred upon me by the members of Grand Lodge in electing me to this high office; and to express my sincere thanks to the brethren throughout the jurisdiction who have given me their personal assistance and the many evidences of their friendship and good will. Besides these brethren from our own jurisdiction we have lost three Grand Representatives near other Grand Lodges, M:W: James A. Beckwith, Grand Representative near the Grand Lodge of Ohio. Col. Beckwith visited with us at our last Annual Communication and those of us who were privileged to meet him could not but admire him for the depth of his Masonic knowledge and his great love for the Craft.

We cherish the memory of these Brothers whose passing has broken our ranks. To the Brethren of Sister Jurisdictions who mourn the loss of leaders we extend fraternal sympathy.

One cannot but be struck with the large number of Masons that are lost to us, as far as active support is concerned, from year to year, by withdrawals and suspensions.

Perhaps too much responsibility is placed upon the Secretary of a Lodge and he may lack the assistance of the other officers and the members in helping to keep the roll of membership.

These brethren are nominally Masons, but it is more than a financial loss that is actually sustained by so many names being dropped from our rolls. There is loss of hearty support and cordial sympathy and fellowship as well.

What are we doing to bring our suspended brethren back into membership? No Lodge can undertake a more worthy project than that of re-instating members suspended for non-payment of dues. Let us show such brethren that we have not forgotten them. I would urge that strong committees from each Lodge be formed to interview these suspended members and endeavor to bring them again into good standing in their respective Lodges so that they might once more take part in our deliberations and lend active support to our work.

Two outstanding events of great importance to us, not only as Masons, but as members of the great Commonwealth of British peoples, occurred during the past year.

First, was a visit to our Dominion of Their Most Gracious Majesties King George VI and his truly Royal Consort, our beloved Queen Elizabeth. The Dominion-wide demonstration to Their Majesties must have removed definitely any doubt that may have existed anywhere in the world that we in Canada are lukewarm in our allegiance to the Crown and our adherence to the British Commonwealth of Nations.

Then, on July 19th last, His Most Gracious Majesty King George, Past Grand Master of The Grand Lodge of Scotland, installed his brother H. R. H. The Duke of Kent as Grand Master of The United Grand Lodge of England; he having been elected in March last to succeed his uncle, H. R. H. The Duke of Connaught.

Now, brethren, I want to quote you excerpts from the Antient Charges before I make any comment upon them. I would refer you to Sections 4 and 5 of The Constitutions of The Grand Lodge of New Brunswick:

"You should be cautious in your words and carriage, that the most penetrating stranger shall not be able to discover or find out what is not proper to be intimated; and sometimes you shall divert a discourse, and manage it prudently for the honor of the worshipful fraternity.

"You are to act as becomes a moral and wise man; particularly not to let your family, friends, or neighbors know the concerns of the lodge but wisely to consult your own honor, and that of your antient brotherhood."

It has been brought to my attention very forcibly this past year that some of the brethren talk outside the lodge room concerning happenings within it. This must not be. These portions of the Antient Charges I have but just quoted are part of our Masonic Law and must be strictly adhered to. I have heard street talk concerning the doings within our lodge room and much harm can be done by such. Our tongues must be curbed and our thoughts withheld. We should practise those truly Masonic virtues, "Silence and Circumspection."

If any brother knows of any valid reason why an applicant should not be accepted it is his duty to make the same known to the chairman of the investigating committee or his Worshipful Master and allow him to judge the matter upon its merits. The report of such Committee or Master to the lodge should be sufficient evidence for the brethren to vote upon. In no case should any such ideas or knowledge be aired before the uninitiated or profane. Brethren, I urge that we be more careful in the future.

## VISITATIONS.

During this past year it has been my pleasure to visit the following lodges, at each of which I received a very cordial greeting and was royally entertained.

Sunbury No. 42, Fredericton Jct.; Grand Lake No. 47, Minto; Keith No. 23, Moncton, where I installed the Worshipful Master and his officers. Likewise at Saint John's No. 2; Hibernia No. 3; The New Brunswick No. 22; Union of Portland No. 10, all of this city, and The Corinthian No. 13, Hampton.

Then followed Albion No. 1, Saint John; Howard No. 15, Hillsboro; Salisbury No. 20, Salisbury; Ashlar No. 36, McAdam; Bethel No. 40, Edmundston; Campbellton No. 32, Campbellton; Restigouche No. 25, Dalhousie; Colebrooke No. 39, Grand Falls; Carleton No. 35, East Florenceville; Saint Martins No. 30, Saint Martins; Saint George No. 12, Saint George; Steven No. 37, Petitcodiac.

In addition to these official visits I have been present at nearly all of the regular meetings of the various lodges in the city and West Saint John as well as The Corinthian of Hampton and find the work of a very high order.

On June 20th, Grand Lodge was invited to visit Union Lodge of Portland No. 10 to be present at the "raising" of Brother Murray MacLaren, the Lieut.-Governor of our Province. I am pleased to say that I was greatly impressed upon this visit to witness the presence of the Worshipful Masters and officers of all the city lodges in their Lodge regalia and also to note the great number of visitors present. The night was truly an inspiring one and must have been very impressive to Bros. MacLaren and Crawford, our latest Rhodes Scholar from New Brunswick, who was also "raised" at this time.

During my visits about the Province, particularly to the River districts, I had the pleasure of meeting many brethren from the State of Maine. These Masons attended upon me as well as though they had been of our own juris-

diction and goes to show the universality of Freemasonry and the unity between ourselves and our great neighbour to the South. I wish to thank them heartily for their support.

I also wish to thank the many brethren of our own jurisdiction who attended upon me during my many visits and for the loyal support they have accorded me. At each visit I was attended by many who had travelled long distances to be present. It is very gratifying to feel that one's efforts in this direction could receive so much support and I again thank these brethren.

On my visits I found the several degrees conferred by the various lodges of a high character and the officers very proficient in their work. The work, in all cases, was carried on with dignity befitting our noble Craft and the ritual of that high standard demanded by this Grand Lodge. No one lodge can be singled out as excelling any other in this respect. I have found a very much improved rendition of our ritual which speaks well for the labors of our District Deputy Grand Masters and shows me that they are proficient and able to instruct and direct the various lodges under their supervision.

The first and most indispensable requisite for becoming a good Mason is regularity of attendance on the meetings and work of the lodge. The instruction of the lodge is delivered orally, and therefore it can only be secured by hearing. The more frequently a brother appears in lodge to witness the proceedings, the greater will be his love for Masonry. Every Free and Accepted Mason, who desires to understand the elementary principles of the Order, should be earnest in acquiring a competent knowledge of the lectures.

One item I have found in my visits which deserves some comment here is that pertaining to reports of Audit Committees. In some few cases I have found that such reports are not included in the regular minutes of the meeting at which they may happen to be presented to the lodge.

Such reports, together with that of the Treasurer, should be to my mind, entered in full in the minutes and I recommend that this become a practice in the future.

Also I feel that Grand Lodge has not taken unto itself sufficient supervision of its subordinate lodges in so far as their financial standing is concerned. I feel that Grand Lodge should know and have a full picture of the financial condition of each of the subordinate lodges in this jurisdiction and I recommend that, beginning this year ending December 27th, that each lodge be required to forward to the Grand Secretary a copy of their auditor's report together with a copy of the treasurer's statement of receipts and expenditures and that the Grand Secretary keep these on file with the Annual Return from each lodge for reference, should it be required at any time.

Another item I would draw to your attention is the lack of knowledge of the Constitutions of this Grand Lodge and also of lodge By-Laws exhibited by many officers of subordinate lodges. Sufficient study is not given to these two necessary books and I urge that more time be spent by all officers in the study of these. By so doing much information will be gleaned and make for better government of the lodge. If officers know their constitutions and By-Laws errors cannot creep in to disrupt harmony and accord.

As some of my predecessors have done before me so I now draw to the attention of those lodges who still base their night of meeting on a phase of the moon. This should have been outmoded long ago and I ask that serious consideration to this change be made by those lodges still using it. In one case this year one Lodge met twice in the same month. Most By-Laws state that the lodge shall meet once during each calendar month. Moon phases will not permit of such if strictly adhered to. I urge a change from this method of calculation.

In regard to By-Laws of lodges. I have been called upon this past year to give my sanction to the revision of such from four lodges. One lodge went so far as to revise their

By-Laws and have them printed before submitting them for editing and sanction. Masters and Secretaries must remember that drafts of changes must be forwarded through the Grand Secretary for my information and correction, if any. To all lodges that have not forwarded copies of their by-laws to the Grand Secretary's office I would suggest that they do so without loss of time as it is required that he have same on file for reference when required.

I am sorry to have to state here that I have been called upon this year to exercise my prerogative in respect to suspension of officers for unmasonic conduct. Charges of such a character were laid by direction of the Board of General Purposes against a Worshipful Master and his Secretary. It was my unpleasant duty to suspend them from office and the Board have since removed them from further participating as such again. I hope, brethren, that in future officers and members of our beloved Order will so conduct themselves that it will never be necessary for a Grand Master to have to exercise this prerogative. It is very upsetting to the Grand Master and cannot make for harmony and peace among the brethren.

I want to thank the Past Grand Masters for the loyal and hearty support they have given me during this past year. This office of Grand Master is not an easy one. Much time and effort is required to do the best one can and support such as I have had from our Past Grand Masters has been of such a character as to lighten my burden very considerably. If all Past Masters of subordinate lodges would give the same support to their Worshipful Masters as I have had from our Past Grand Masters our Craft would thrive and flourish beyond our dreams.

Brethren, in 1942 we will celebrate our 75th birthday and I do not think it too early to begin our preparations for this great event in our history. I would suggest to you that you form a strong committee to consider this matter and direct them as to how the celebrations are to be financed. Our General Account cannot be called upon

for this purpose as our funds are only sufficient to finance our yearly needs. The large decrease in our numbers annually also decreases our income, consequently Grand Lodge could not afford any expenditure in this direction.

I desire before closing to sincerely thank my associate officers for their promptness and willingness to assist me on all occasions in the discharge of the numerous duties pertaining to this office — more especially do I extend my thanks to the Grand Secretary, who has accompanied me on all of my visits to the various lodges, for the uniform courtesy and kindness which have always characterized him in the discharge of his duties. For this year as your Grand Master I again thank you and trust that the years ahead will show us progress and prosperity.

A report from the District Deputy Grand Master for District No. 4 concerning conditions obtaining in Woodstock Lodge No. 11, as regards the audit of the books of the Secretary and the action of the Worshipful Master of the Lodge toward himself in his official capacity as District Deputy were of such a character that the Board ordered charges of unmasonic conduct be preferred against the two officers named and their trial proceeded with.

Upon cause being shown and an admission of guilt by the Secretary of the Lodge it was resolved that the Board take no further action than that taken by the M:W: The Grand Master in suspending this officer from his office and his subsequent permanent removal as Secretary of the Lodge and a strong expression of the extreme misapprobation of his conduct which made the laying of the charges necessary.

In the case of the Worshipful Master of the Lodge the Board, after due consideration of the several charges laid against the brother resolved "that if a similar letter to that received from Secretary of the Lodge be received from the Worshipful Master and it be to the satisfaction of the M:W: The Grand Master, that the Brother be suspended from all benefits of the Order for a period of one year. If such a letter be not received then the brother to be expelled from the Order. In any case he to lose his rank as Past Master.

The Deputy Grand Master likewise presented the accounts of the V. W. Grand Treasurer, and the Report of the Auditors thereon. We note that it has again been necessary to sell a \$1,000 Bond in order to strengthen the funds of the General Account and would recommend that careful supervision be given to all expenditures and that all bills be properly approved before being handed to the Grand Treasurer for payment, also that proper receipts be obtained in every case for payments made.

A record should be kept of all regalia, supplies, etc., bought and sold, and a better system adopted for items that might be classed as petty cash payments.

We feel that according to ordinary business practice, more information should be given covering travelling expenses in connection with all Grand Lodge visitations. Only one of the D. D. G. M. has given this information.

The Bonds held in the safety deposit box, Bank of Nova Scotia, to the amount of \$70,000.00 have been examined and found to be in order.

The sections of the Constitutions of the Grand Lodge of New Brunswick relating to the elections were read, and

On written nomination and ballots cast, M:W: John Thornton was again elected Most Worshipful Grand Master, and was declared so elected amid general applause.

Porter presented and read the report of the Committee on the Address of the Grand Master, and, on motion, duly seconded, the report was received and approved and ordered to be printed in full in the Annual Proceedings, and that the recommendations contained therein be adopted and effective at once.

#### REPORT ON GRAND MASTER'S ADDRESS.

August 24, 1939.

*To the Grand Lodge of Free and Accepted Masons of New Brunswick:*

The Committee to which was referred the Grand Master's address beg leave to report as follows:

We note with pleasure that harmony and fraternity prevail throughout our jurisdiction and that our relations with Sister Grand Lodges continue to be most friendly and harmonious; also that the internal conditions in this juris-

diction are improving, that the several degrees are being conferred in a proper manner, and able and proficient instruction is being given throughout the jurisdiction. We believe that the thanks of Grand Lodge are due to the Most Worshipful The Grand Master for his leadership during the last year.

The committee note with regret the large list of influential members who have been gathered in by the grim reaper. We mourn the loss of these brethren, but their passing also brings home to us the necessity for replacing them by others of equal earnestness and ability.

With this thought in mind, your committee has considered the reference made by the Grand Master to the losses by withdrawals and suspensions. This is a matter which is receiving attention not only in Masonic circles, but in fraternal circles generally throughout the continent. It is very easy to blame the depression for this condition, but your committee feel that the matter should be regarded less superficially and more fundamentally. Must not one of two things be true? Either the brother has never been properly impressed with the beauties and objects of the Order, and so has lost his desire to remain a member; or else if he is being suspended in spite of his own desires, there may be a lack of fraternal consideration on the part of those suspending him. At any rate your committee would endorse the suggestion of the Grand Master that a strong committee be formed in each lodge to interview all members threatened with suspension in an endeavour to keep those members in good standing and to excite and encourage their active interest and support in the work of the lodge.

The Grand Master has drawn attention to the necessity of officers of subordinate lodges being familiar with the constitutions of this Grand Lodge and of their own lodge's by-laws. Such knowledge is indispensable to a proper fulfilling of the duties of office. Such knowledge combined with a proper knowledge of the ritual will go a long way,

but we would not by any means have any officer feel that more was not required of him than this, if his lodge is to be an active and growing unit in our fraternity. Your committee concurs in the recommendation of the Grand Master that Grand Lodge should increase its supervision of the subordinate lodges in so far as their financial standing is concerned; and that as a step to this end, each subordinate lodge be required to forward to the Grand Secretary a copy of their auditor's report, together with a copy of the treasurer's statement of receipts and expenditures.

Your committee commend the action of the Grand Master in drawing attention to sections 4 and 5 of the Constitutions, and inasmuch as this report will form part of the proceedings to be printed, your committee will make no comment on the regrettable incident which necessitated the Grand Master to exercise his prerogative and the Board of General Purposes to take such drastic action.

Your committee note with interest the reference to the installation on July 19th last of H. R. H. the Duke of Kent as Grand Master of the United Grand Lodge of England, and also the reference to the fact that in 1942 this Grand Lodge will celebrate its seventy-fifth birthday. We concur in the suggestion that a committee be formed to consider the question of a proper celebration in that year.

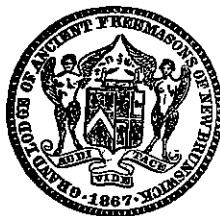

## REPORTS OF DISTRICT DEPUTY GRAND MASTERS

### DISTRICT No. 1.

*To the Most Worshipful Grand Master:*

I have pleasure in submitting my annual report, and in doing so wish to thank you for the honour conferred in continuing me as your Deputy in this District for the year now closing.

#### BETHEL LODGE No. 40, EDMUNDSTON.

On March 3rd paid an official visit to this Lodge and was well received, the Worshipful Master, Ronald D. Baird, meeting me at the train and accompanying me to the hotel. W. Bro. Baird had been re-elected to the chair for this term and I found the Lodge continuing to make progress. Witnessed the conferring of the second degree upon a promising brother and it was a pleasure to hear him examined by his father, a Past Master of the Lodge. It was announced that at the next night of meeting the father would confer the third degree on his son, and this would be the first time such an occurrence would have taken place in Bethel Lodge. The brethren are interested in the study of Masonry, and voted to purchase some books with a view to starting a Masonic library.

#### COLEBROOKE LODGE No. 39, GRAND FALLS.

Official visit was made to this Lodge on April 5th. After arrival at the hotel had the pleasure of calls there from the Worshipful Master, Harold J. Fraser, and the Secretary, P. M. Harley L. Wright. W. Bro. Fraser was re-elected to the chair this year, and seemed keener in his work, if possible, than last year. The Lodge passed three

candidates to the Fellow Craft degree and everything went along very well indeed. Was particularly pleased with the candidates who were all young men of splendid mien, and they had fine examinations,— correct, clear and distinct,— and reflected credit not only upon themselves, but upon their instructors and the Lodge. In listening to the minutes of the previous meeting was interested in an item which told of a brother who had been initiated Entered Apprentice in Colebrooke Lodge on May 5, 1912, and was now anxious to receive further degrees in a Lodge in Ontario where he now resides. The matter was being arranged through the Grand Lodge offices of the two grand jurisdictions. A notice of motion was introduced to change by-laws to provide for regular communication to be held on a fixed night according to the calendar, rather than according to the moon, and if the Lodge adopts the change, it will mean that all of the Lodges in this District now meet according to calendar dates. There was need, no doubt, when travel was slow by horse and buggy, to have the meeting on a night that would be on or near the full moon, but the fixed calendar date seems more convenient. On June 7th had the great pleasure of accompanying you on your official visit to the Lodge, on which occasion V. W. Robert D. Magee, Grand Secretary, and W. Bro. William B. Jones, D. D. G. M., District No. 3, as well as many brethren from this District and Lodges in Maine, were present. The third degree was conferred upon the three candidates, whom I had previously seen receive their second degree.

#### BENJAMIN LODGE NO. 31, ANDOVER.

Made my visit on May 4th, and enjoyed meeting the brethren of this fine Lodge again. Worshipful Master George Brooks and his officers conferred the second degree upon a worthy candidate in a creditable manner. In balloting, two applicants were accepted to receive the degrees of the Order. Considerable business was before

the Lodge, principal of which was that of redecorating the interior of the Lodge building. The property is a commodious structure, a credit to the Order and community, and the improvements have benefitted it considerably. They plan to make further more extensive renovations later I understand. The Lodge is continuing to receive many candidates seeking Masonic light, and all signs point to continued success in the work here.

#### CARLETON LODGE NO. 35, EAST FLORENCEVILLE.

Was present unofficially on April 13th when the work of the evening was the third degree. On May 11th paid official visit and saw a young man receive his first degree. It was a notable event in the history of Carleton Lodge in that the initiate was of the third generation in the Lodge, he being the first of a third generation in that Lodge to receive the degrees. His grandfather was a charter member, who later became Worshipful Master, and his father, Past Master Hedley F. Jewett, is Chaplain and was present at the initiation. Was very pleased at finding the affairs of Carleton Lodge in such good condition and it was like old times finding the position of Worshipful Master being capably filled by W. Bro. Charles R. Caldwell, who had served ably in that capacity some years ago.

#### HARTLAND LODGE NO. 46, HARTLAND.

My own Lodge, the youngest in the District, is carrying on in the usual manner, making some progress each year. Purchase was made from savings of a \$500.00 Dominion of Canada bond, and an additional room was rented from the owners of the buildings in which the Lodge meets, which the members have fitted up and are using as a club room. I did not visit the Lodge officially but have been present at all of its meetings but one during the year.

## WOODSTOCK LODGE No. 11, WOODSTOCK.

I was present at several of the meetings of this Lodge. The first occasion was on January 5th at your request, as Grand Lodge had received communications from Woodstock telling of some difficulties they were having. I had accepted the invitation, but unfortunately contracted a cold, and had to forego the pleasure of attending.
