

First Conference of Grand Lodges A.F. & A.M. of British North America

Held at Toronto, Ontario, February 28th, 1949

By invitation—on February 24th, 1947—thirtyone representatives of the Masonic Grand Lodges of British North America met at the Seigniory Club, Montobello, Quebec, to consider the formation of an All Canada Conference of Grand Lodges. The original idea being the child of M:W: Charles S. Hamilton, the then Grand Master of the Grand Lodge of Canada in the Province of Ontario, and to him must go the accolade. His efforts were crowned with success -for on February 28th, 1949, representatives from all of the Grand Lodges in Canada and from the English and Scottish Constitutions of Newfoundland met in Toronto to make an actual fact of the original idea and the first All-Canada Conference of Masonic Grand Lodges of British North America became—it is hoped -one of the most momentous acts of the Grand Lodges concerned therewith.

The guiding heads of this Conference have been well and wisely chosen; the Executive Committee have outstanding ability and the subjects which will be offered for consideration at the bi-ennial meetings cannot but be of large import to all the member bodies. Those that have already been offered contain much for the advancement of our Institution and the ability with which they have been presented not only attest to the soundness of the original undertaking but also to the broadness of the minds of those who took so much of their own valuable time to prepare them.

This Grand Lodge feels that the effort has been well worth while and any expense incurred is of small moment when compared with the larger outlook and benefit to the Craft—wheresoever dispersed.

Apart from the subjects that may, from time to time, be presented to the attending delegates is the association of those attending. Surely it will cement that brotherly love and affection which will unite us into one common band or society of friends or brothers and make of this Institution across the hills, valleys and plains of our Canada a body of men prepared the better through this unity to combat those unseen powers that would destroy our way of life and make of it chaos. Our unity must be for the betterment of mankind and the uplift of the souls of our fellows. Therefore we reiterate the statementthe All Canada Conference is the biggest thing Canadian Masonry has ever attempted and successfully launched. May it never be allowed to lag or be superceded by any other thing which will detract from its unity of purpose.

82nd Annual Communication

OF THE

GRAND LODGE OF NEW BRUNSWICK

Saint John, N. B., August 25th, 1949.

THE EIGHTY-SECOND ANNUAL COMMUNIcation of "The Grand Lodge of the Antient and Honourable Fraternity of Free and Accepted Masons of New Brunswick" was held at the Masonic Temple, Germain Street, in the City of Saint John, on Thursday, the twenty-fifth day of August, A.D. 1949, A.L. 5949.

Most Worshipful Donald Campbell Malcolm assumed the Throne and Grand Lodge was opened in Ample Form at 10.00 o'clock a.m., followed by solemn prayer by the V:W: Grand Chaplain, Rev. J. A. Berridge, as follows:—

"Eternal source of Life and Light! We humbly implore Thy divine favor upon this occasion, and upon the Institution in whose services we are engaged. Make it yet more helpful and beneficial to our race, and inspire all who are connected with it with an ardent love to Thee, to each other, and to every member of the human family. Enable us so to legislate that we may keep in view the best interests of the great brotherhood.

"In Thee, O God, do we put our trust. Be Thou our friend, conductor and guide in the unseen vicissi-

tudes of life before us, and bring us all at last to see the Great Light, inaccessible and full of glory, in Thy presence, where we shall behold Thee with unclouded vision for evermore. Amen."

The Proclamation calling the Eighty-second Annual Communication of Grand Lodge was read by the V:W: Grand Secretary.

The Most Worshipful Grand Master welcomed the brethren to Grand Lodge as follows:—

This is your Assembly, and I trust that you will not only learn what has transpired during the past year, but may also carry away from our considerations, thoughts that you may turn into actions—for the benefit of your Lodge or Lodges, which in turn may rebound to the credit and greater honour of our Beloved Order.

To our Distinguished Visitors, the same welcome applies—we welcome you in every sense that our great Fraternity stands for. We hope that you may leave with us something for the good of the Craft—also that you may receive some inspiration, whilst sojourning in our midst. We fully realize that you have made sacrifices and put yourselves out in order to be present with us. We sincerely appreciate the efforts you have made to attend upon our Eighty-second Annual Communication. Your aid and presence will greatly add to our assembly.

All present are conversant with history now in the making—and probably realize how close disaster may be upon our civilization.

One can, perhaps, understand the thoughts, or

rather the ignorance of certain peoples towards our standard of liberty, but to me it is incomprehensible how persons living in our free countries—enjoying all the blessings of freedom—can even think of, let alone work for the destruction of our way of living and would wish to plunge us into chaos, such as appears to be enjoyed, or rather endured, in the beforementioned countries.

It is the personal duty of every Mason to ferret out and expose all such people in our country, so that our land may be cleansed of such pestilential beings.

Our Order can only flourish in a peaceful atmosphere—although it has withstood the ravages of time and warfare. Let us seek Peace, but not at the loss of Honour.

If this welcome is too much like a sermon, I still give it to you as it is. And repeat, I welcome all of you, and thank you for your attendance.

When Grand Lodge resumed labour—with R:W: Robert L. Algie, Deputy Grand Master, in the Grand East—the Most Worshipful Grand Master not being at the moment in attendance, delivered the following Address for him:—

GRAND MASTER'S ADDRESS

To the M: W: Grand Lodge of F. & A M. of New Brunswick

MY BRETHREN:-

With fraternal greetings I extend to each of you a most sincere and cordial welcome to this, the 82nd Annual Communication of our Grand Lodge, and trust that your visit with us will be both pleasant and profitable. To many of us who attend this meeting year after year it is a great source of pleasure to meet and greet old friends and make new acquaint-ances. To those of you who come here for the first time as representatives of your Mother Lodge, I would say to you to make yourselves acquainted with your neighbours and form those friendships which will be of lasting benefit to you through their associations.

For so great a privilege we should render our grateful thanks to Almighty God to whom we should ever look for direction.

We are assembled as a deliberate body to pass judgment upon the acts and deeds of the present administration and to counsel together for the welfare and prosperity of Masonry in this Grand Jurisdiction. Individual effort may achieve much but if we are to avail ourselves of the accumulated wisdom of all those

here assembled, this can best be accomplished through co-operation and working harmoniously. Therefore, it is my hope that you will discharge the duties and responsibility assigned as representatives by freely entering into our discussions and deliberations.

One year ago you elected me for the second time as your Grand Master and I had hope of accomplishing much but an indisposition has made it impossible for me to do all that I have set myself to do. This I regret exceedingly.

Special invitations were not extended this year to many whom we should like to have had with us, and to those who have come we extend a special welcome with the hope that this communication will prove pleasant to you.

I was very pleased to have our Sacred Service at this morning's session of Grand Lodge arranged and conducted in so capable a manner by our Very Worshipful Grand Chaplain, Rev. J. A. Berridge. It is well to render praise and thanksgiving to the Supreme Architect of the Universe and to dedicate anew our lives in His service.

During the year we have been called upon to mourn the loss of many distinguished brethren. Our heartfelt sympathy goes out to the bereaved friends and relatives of those whose passing we mourn, not only in our own Jurisdiction but in our Sister Jurisdictions as well. It was my pleasure to install the officers of Keith Lodge No. 23, on Dec. 27th, of Ashlar No. 36, Saint John's No. 2, and Tweedie and Acacia jointly.

At this point it was necessary for me to ask the assistance of R:W: Past Grand Master Hoyt who installed the officers of Hibernia No. 3, Corinthian No. 13, New Brunswick No. 22, and Union Lodge of Port-

land No. 10. This valued brother also dedicated Cherry Mountain No. 50 at Harvey Station, N. B., and consecrated the new hall for Grand Lake Lodge No. 47. Minto. To R:W: the Deputy Grand Master Robert L. Algie, I assigned visits to Zetland Lodge No. 24, Salisbury Lodge No. 20, Howard Lodge No. 15, Saint Andrew's No. 16, Albert Lodge No. 34.

In the visits I was able to make, we were received with graciousness and unfailing courtesy and a sincere interest in the ritual was manifest at all times. The efforts of the W: Masters, Past Masters and Officers and also to the excellent work of the D:D:G: Masters, shows that Masonry is deep-seated in their hearts and augurs well for the future.

Being unable to attend the Grand Masters' Association Assembly in Washington in February, 1 appointed R:W: Albert C. Lemmon as my special deputy to attend these meetings and also to the All-Canada Conference which was held in Toronto following the Washington meetings. This Officer, with the Deputy Grand Master and the Grand Secretary, formed the official representatives of this Grand Lodge at the Regional Conference of the Eastern provinces held in Charlottetown in May. Their reports show great progress being made in advancing the principles for which we stand and a strengthening of the ties which unite all of the several Grand Lodges attending these meetings. It was our pleasure to attend divine service with the Union Lodge of Portland to the Church of Saint John and Saint Stephen on October 31st last, and Grand Lodge together with the several Lodges of Saint John attended divine service June 26th at Saint David's United Church where the Very Worshipful Grand Chaplain brought us inspiration.

For all of these services rendered me I tender my heart-felt thanks and for the many expressions of good-will sent me from all sections of our jurisdiction, it has been inspiring and strengthening during a period of inactivity forced upon me.

To borrow from our friend and brother, Frank S. Land, Founder and Secretary General of the Order of De Molay in an address delivered to the Grand Lodge of Indiana, I would not try to give any interpretation of degrees or to discuss philosophies but rather to attest to the evangelism and power of Freemasonry as a great factor in daily living. To me, if Freemasonry is to achieve its goal, it must become a day-to-day practice of eternal Truths. Perhaps the most difficult hurdle for most of us in daily living, is to be good.

Freemasonry, through its morals and dogmas. lights the way for happier living. There is hardly a moment in your life or mine when we must make rapid decisions, when we must decide to do right or to do wrong. It takes a lot of courage to live today and it takes real courage to think rightly. I have in mind a professor in one of our large eastern universities. He is very popular on the campus and students flock to his lectures. He was telling not long ago about one of these sessions when, at the conclusion of his lecture, a large crowd of young men gathered around him, asking questions and voicing their approval of his remarks. Dismissing the group, he concluded: "Young men, don't forget to play the game of life." Finally, one chap, just a little more alert than the others, said, "Prexy, how are we going to play the game of life when we don't know where the goal posts are?" That has been the cry of nations and people ever since the dawn of time. Freemasonry has been telling you and me that there is a code, if lived prop-

erly, which leads to happiness, contentment and great spiritual security. I am mindful, as you must be, that Freemasonry of today is the evolution of the teachings and ideals of many men who lived and died through the ages past. Yet the source of these eternal verities is in Almighty God from out of whose hands the centuries fall like grains of sand. Marvelous has been the prodigality of His love in the world of nature and in the realm of grace. The majesty of the mountains, the witchery of the forests, the grandeur of the sea, the coloring of the canyons, the fertility of the valleys, the beauty of the rose, all bespeak of His thoughtful care for our creature comfort. The home and school and church testify to the provisions of His grace in nurturing our mental, moral and spiritual welfare. These are not little things with God. With one hand He may be throwing rings about the planet Saturn, with the other hand giving form and perfume and beauty to the rose. We can thank God for the pathfinders and trail blazers and prophets of the yesteryear who pushed their way on foot, on horseback, in covered wagons and in the canoes, across the continent, fording streams, penetrating forests, scaling mountain fastness, over burning sands and through dangers manifold to open up this great country for colonization; for the missionaries who brought the Divine Word to a backward and belated race; for the educators who instituted schools and universities for the enrichment of the lives of the people, and for the men, countless and without number, who placed a Masonic Altar at every crossroad, that men might be free.

Somewhere these Grand Worthies are looking down upon us out of the web of antiquity, because the world has not always recognized its truly great men. It has been strangely blind. By a cruel irony of fate the world has often maligned, mistreated, insulted and oftentimes killed those truly great men whom a succeeding generation has sainted and adored. Many times they cannonaded while living and canonized them when they were dead, but the hooting mob of yesterday has often returned to gather up the scattered ashes into history's golden urn. Today, out of the mists of centuries, Freemasonry rises in the full stature of its majestic greatness, the sleepless sentinel of our great institutions. The future belongs not to rigid absolutes, whether they are primeval rocks or unyielding social arrangements, but to the thing that can grow, whether it is a tree, Christianity, democracy or Freemasonry.

It is strange that a principle as familiar as this should today need underscoring, but we are living in years of uncertainty and fear, and fear induces a kind of spiritual astigmatism. To be sure, in our generation we have reason for our fears and every justification to resist the threat that creates them. We have assumed that peace is the normal state of civilized society but it has been rudely interrupted by ambitious war lords twice in a generation. We are finding the world proceeding from one crisis to another. Men now are beginning to believe that there is no reason why we should not expect these recurring emergencies. The world is in for a state of tension for at least another generation. This is not an easy doctrine to accept. One reason for our difficulty in accepting it is a misreading of history. We look longingly back on the 18th century and the comparative peace of the Victorian age and think of that as normal. It was not normal. The Victorian peace was due to a fortunate combination of circumstances that will not recur. Sea power became dominant at a time when

the British Empire, with world outposts, was able to use its fleet as a global policeman.

An accomplished American diplomat, Hugh Wilson, wrote in his memoirs between the world wars: "To us the Victorian era of stability was normal. We needed a lifetime to realize, and some of us have not yet realized, that the Victorian era was an historical phenomenon, so unusual that it will be cited with the age of Augustus as one of the two great periods of peace and security in the history of Western civilization." It should be easier for us to deal with the period of tension in which we are now living—and that seems to stretch indefinitely ahead—if we realize that except for the two interruptions mentioned by Mr. Wilson, this has been the normal experience of mankind.

A few moments ago I stated that the future belongs to the thing that can grow; a tree can demolish a rock. There is no future for a system of anti-God communism or any other ism, any more than there is a future for a rock stranded by a glacier. Ultimately, the irresistible power of a thing that can grow will shatter it. That is why Christianity, Freemasonry and democracy, rightly interpreted, are the last best hope of earth. Thus we know the Craft is rooted in the principle of growth. It is built not on a fixed creed or on a system of regimented ideas, but on the sure knowledge that frontiers are never stationary. It is free men who dare to think Freedom is an invitation to a life of courage and it is only through free thought, freely expressed, that the spirit of a people can be kept alive. You and I know something about adventure; in fact, we pass through it every day, for life is one adventure after another. The greatest adventurer of all time was Jesus, who declared He came to teach men the Fatherhood of God, the forgiveness

of sins and life everlasting. Two thousand years have passed since Jesus started this adventure and millions of people have caught at least a part of His vision and have tried to adventure with Him. If we live up to our profession of faith, we have a tremendous responsibility—poor sinners that we are—to carry on the work He entrusted to us, that we might build a living church, a living Freemasonry and a living democracy to the glory of Almighty God.

Today the treacherous unexplored areas of the world are not in continents or the seas; they are in the minds and hearts of men. It takes courage, and lots of it, to live today. Freemasonry uncovers the foundations of righteous living by seeking a restoration of religious faith—faith in God and in God's presence and power: Faith in man as the child of God; and in what, under God, we can do to build a new but better world. There are enough men in this room to evangelize the world for God and Masonry's concept of the Brotherhood of man. No man is so pernicious a drone as an idle Mason. Only a few seek to set the world on fire with our teachings, while the great mass of Brethren are lighting only a match. We count our Brethren in the millions—our leaders in the tens. The fires of Freemasonry must be kept burning and the white heat of faith generated, for the good of humanity. We are living in a day that is fraught with materialism. Men live and spend their whole lives husbanding stocks and securities; fighting for places of power and ambitious for honors. Others spend an entire lifetime earning a pittance that barely enables them and their families to live. The invisible things of God seem very, very far away. May I close with this one thought: "What doth it profit a man if he gain the whole world and lose his soul? What doth it profit a man if he gain the whole world

and lose his spiritual sense; loses the narrow path that leads to the footstool of God?"

For the gift of your highest office, twice bestowed, I humbly and sincerely thank you.

During the year, Cherry Mountain Lodge of Harvey Station, York Co., N. B., received its charter; being dedicated by R:W: James S. Hoyt, P.G.M., who also consecrated the new building for Grand Lake Lodge, No. 47, at Minto, N. B. We now have an active Masonic family of 46 Lodges all of which appear to be in a flourishing condition from the reports they have furnished.

The M:W: Grand Master being unable to attend the Washington and Toronto conventions, he delegated R:W: Albert C. Lemmon as his representative and with this officer I attended the annual convention of Grand Masters and Grand Secretarys of North

America at Washington, D.C., in February last, and the All-Canada Conference in Toronto in March.

The All-Canada Conference appears to me to hold a more vital place in our Masonry than does the Washington conferences. The Washington conference certainly does enlarge the scope of our Masonic knowledge and fraternal relations but does not materially add to the knowledge which could be used particularly in this jurisdiction, while the All-Canada Conference brings the Canadian Masonic family much closer together and subjects peculiar to our Canadian Masonry are discussed and hold a much more vital interest to us and which can be of service to each Grand Lodge attending. I would not suggest that we discontinue membership in the two conferences held in Washington as the Grand Master might feel that it would be to his advantage to attend these conventions during his tenure of office as it would give him the broader outlook of the whole North American Continent and many from other portions of the Masonic World which we do not regularly get to meet and exchange views with. The policy he might dictate will be for the best government of the Craft.

The Maritime Regional Conference is one of very vital interest to the Grand Lodges attending and I feel that these do fill an important place in our relations with our sister Grand Lodges near by. It would be my suggestion that the Grand Lodge of New Brunswick appoint more than three delegates to attend the All-Canada and Maritime Regional Conferences from year to year than we have been sending in the past and, if possible, one delegate should pay a fraternal visit to the Western Conference to observe their procedures and bring to us the value of their years of experience in their Masonic work other than ritualistic. This also would be a matter of pol-

icy for the Grand Master to dictate and direct; I feel that it should be the Grand Master who would attend such a convention if it be at all possible, failing which he could appoint a delegate capable of bringing back to us the experience he would undoubtedly gain by this union.

I have to report that Miss Joan M. Buckley, who has been the secretary to the Grand Secretary for nearly four years, resigned her position to be married. It has been my pleasure to appoint in her stead Miss A. Joyce Wilkes whom I feel will be a capable successor to this young lady and I would ask Grand Lodge to ratify the appointment.

My thanks to the Secretaries of the subordinate Lodges for their co-operation during the year is tendered. There have been a number of new secretaries appointed since December, 1948, and they seem to have sufficient grasp of their duties to make it unnecessary for them to write this office for much assistance but that which has been sought has been on points of procedure not regularly met with, and it has been a pleasure to be of assistance to all who have asked for advice.

AUDITORS' REPORT

To the Grand Lodge of Free and Accepted Masons of New Brunswick:

We, your committee appointed to audit the books and accounts of the V:W: Grand Secretary and the V:W: Grand Treasurer report as follows:—

We checked the entries in the Cash Book of the Grand Secretary and found cash listed as \$9,155.23 of which \$7,075.58 was deposited to credit of General Account and \$2,079.65, largely cheques, was on hand. This was checked by your committee. We also examined the Ledger and found the records clear in both books.

The books of the Grand Treasurer were also examined and are a picture of neatness and accuracy. Receipts and expenditures were checked and vouchers were examined. The bank balances were checked and bonds totalling \$99,000.00 held at the Bank of Nova Scotia, Prince William Street, were examined and found in order.

Insurance policies are held covering Grand Lodge Regalia \$2,500.00 and Oil Paintings \$4,800.00.

If regular meetings of the Board of General Purposes are not held, we would suggest that some arrangement be made for passing for payment bills against Grand Lodge.

REPORT OF COMMITTEE ON MASONIC EDUCATION

To the Grand Lodge of Free and Accepted Masons of New Brunswick:

V:W: Bro. H. I. Knowles being absent from the city, has asked me to make report on the Education Committee's affairs for the year.

The duties of your committee on Masonic education may be summarized in these few words: To help more Masons learn more about Masonry. Our activities since the advent of our scheme of education has been largely concerned with fundamentals attempting to awaken the Craft as a whole and the newer Masons in particular to the need, the importance, and the beneficient possibilities of a well balanced educational programme operative throughout our province. While our efforts have yielded encouraging results in some portions of the jurisdiction, we fear that a large number of the Lodges have neglected any endeavor to advance this very important phase of Masonry. The goal we have set for fruitful attainment still lies far ahead.

During the past two years the chairman of this committee has gone to great pains in preparing and editing the Masonic Digest, which is forwarded the secretary of each Lodge for distribution with his notices and it is hoped that this little paper is being agreeably received.

Masonic plays have been produced by some of the Lodges with good effect and assist Lodge attendance thereby. The members who take part in these plays are to be commended for their interest and their endeavor to further the educational possibilities by this type of entertainment. We feel that more of this

could be attempted by other Lodges to good advantage.

Your Committee recommend that the Worshipful Master of Lodges be encouraged to appoint a Lodge Committee on Education, with carefully selected chairmen. Many bulletins on Masonic subjects are available for the interested Mason and any request will receive prompt attention. Lodge membership will profit immeasurably from such activity and Masonry will be advanced proportionally.

REPORT OF THE GRAND HISTORIAN

Saint John, N. B., August 25, 1949.

To the Most Worshipful Grand Master, Officers and Members of the Grand Lodge, F. & A. M. of N. B.

Most Worshipful Grand Master and Brethren:

I beg to submit the following report as your Grand Historian:—

I appreciate, Most Worshipful Grand Master, the privilege of serving you a second year in this office

and I thank you most sincerely for the opportunity to do so.

To each secretary from whom I had not heard up to that time I sent the following letter:

Office of the Grand Historian, 27 Bromley Ave., Moncton, February 16, 1949.

Dear Brother Secretary:

"We are anxious to make some progress during the winter months toward bringing the histories of the individual Lodges up-to-date. Several have done just that, but there are a number from whom we have not heard. No one realizes more fully than I do how the days slip by and that you, brother, are a busy man. But the task is an important one and, without your assistance, it is difficult to make much progress.

"You are proud of your Lodge and justly so. We have its history written up to the year ______ I earnestly ask you, if you do not have the time yourself, to request the Worshipful Master to appoint a committee to assist you. This plan has worked well in some of our Lodges and, by the way, it may be managed to provide an interest for some members who are not especially busy with other Masonic matters.

"Notes may be made from the regular records. Mention of any items of interest through the years will be welcome; the names of the Masters and other Officers; those who have held Grand Lodge offices; buildings dedicated; and so on—all will be gladly received.

"I am sure you can appreciate how anxious I am to be in a position to make a favourable report when 160

Grand Lodge assembles. Please let me hear from Your Lodge is important. Its story is imnortant. Our Grand Master will be grateful to you as well as myself for any help you can give us. I shall eagerly await your reply acknowledging the receipt of this letter.

In response to this appeal there were those who did not deign the courtesy of a reply of any kind. But, on the other hand, there were those who made hopeful promise and others who sent in most valuable material.

Since I took office, the following have been heard from, most of whom have now brought their histories up-to-date:-

Albion No. 1, Hibernia No. 3, Sussex No. 4, Sussex No. 7, Carleton Union No. 8, Union Lodge of Portland No. 10, The Corinthian No. 13, Alley No. 14, Salisbury No. 20, Zion No. 21, New Brunswick No. 22. Keith No. 23, Saint John No. 27, Lebanon No. 28, Campbellton No. 32, Albert No. 34, Carleton No. 35, Colebrooke No. 39, Bethel No. 40, Tweedie No. 41, Sunbury No. 42, Westmorland No. 44, Fownes No. 45, Hartland No. 46, Tobique No. 48, Acacia No. 49, and Cherry Mountain No. 50.

Thus some twenty-seven Lodges have added to the material delivered to me by V:W: Herbert I. Knowles, my immediate predecessor in this office.

I wish to express my gratitude to the secretaries

and others belonging to these Lodges who have responded so courteously and ably. Certain of these brethren have displayed a keen historic sense and have gone out of their way to be helpful. My thanks are due also to the Grand Secretary, to Wor. Bro. Williamson of "The Corinthian," to Bro. Bedford of Keith Lodge, and to others as well as to several outside of this Jurisdiction.

We now have six of the large uniform binders in use which are rapidly being filled up. I have added my own observations about such matters as the Moncton Masonic Library and the educational efforts of its Board and comments on the Conferences, etc., which would not appear in the official reports.

Included also is a copy of our distinguished Brother Charles F. Sanford's address on "The Origin of Speculative or Symbolic Freemasonry," and the excellent dissertation delivered by the Grand Chaplain in Grand Lodge last August, and many other items which have a permanent interest.

During a recent visit to The Corinthian Lodge in Hampton I was shown relics of great historic value belonging to the long-defunct Midian Lodge at Clifton and rescued from final loss by a thoughtful young brother who saw them, as he said, "kicking around the old lodge room." There must be in our Jurisdiction many such things which would constitute attractive and informative exhibits. I am strongly of the opinion that the time has come to make some provision for the preservation and display of such objects as the Midian relics even if begun in a very small way such as procuring an inexpensive cabinet with glass front.

Directed by a motion duly passed in the last meet-

ing of the Board of General Purposes to bring forward a recommendation I beg to submit the following:—

Your Grand Historian recommends that provision be made by our Grand Lodge for the care and display of objects of Masonic historic interest which are rightfully the property of the Grand Lodge or may become so by gift or otherwise and that the Grand Master appoint a committee to deal with the matter.

The lapse of time, the ruthless hand of ignorance and the devastations of war have laid waste and destroyed many valuable monuments of antiquity and the spirit of apathy and neglect has allowed many priceless relics and objects associated with the lives and labors of our pioneers to crumble into dust or to be relegated to the scrap heap. Handwrought jewels of silver, aprons fashioned with loving care, pillars of solid mahogany, ancient documents and records breathing forth the atmosphere of colonial days—all should have an honored place among our treasures.

Brethren, I appeal for your greater and continued interest in the History Department of our beloved Fraternity in this grand old Province of New Brunswick.

when Grand Lodge take recess it take recess until 8.00 p.m., when the first Order of Business will be the Election of Grand Lodge Officers." Carried.

It was moved by V:W: Grand Secretary and seconded by R:W: J. S. Hoyt, that the present application form to the Fund of Benevolence be referred to the Board of General Purposes for revision. Carried.

It was moved by W: B. L. Skidmore and seconded by Bro. R. E. March, that the Wardens of Subordinate Lodges be elective Officers and that the matter be referred to the Board of General Purposes. Carried.

The Special Committee appointed August 26th, 1948, by the M:W: the Grand Master to consider and make recommendation regarding Scholarships and Contributions to the New Brunswick Protestant Orphans' Home, under the chairmanship of R:W: Charles F. Sanford, make and give Notice of Motion as follows:—

"Your Committee recommend and hereby make motion that the per capita tax on members of the Order in this Province be increased from seventy-five cents (75¢) to two dollars (\$2.00) per annum and that four Scholarships for four years of seven hundred and fifty dollars (\$750.00) each be granted to such four applicants as may be approved by a Committee of Grand Lodge to be appointed for that purpose. That the Scholarships be used in the University of New Brunswick; that also a like sum of three thousand dollars (\$3,000.00) be granted to the New Brunswick Protestant Orphans' Home."

The above to apply to that portion of the Constitutions dealing with and under the heading "Of Fees," page 74, last paragraph.

It was moved by W: C. L. Taylor and seconded by W: S. I. Underhill, that the matter of scholarships

and grant to the New Brunswick Protestant Orphans' Home lay over to the next annual Communication of Grand Lodge to be holden August 24, 1950. The Lodges to give this matter their consideration during the recess. Carried.

Agreeable to Notice of Motion given in the Proclamation the Grand Secretary moved as follows:

By direction of Grand Lodge at the last Annual Communication held August 26, 1948, and to conform to the resolution presented by the Board of General Purposes at the Annual Communication of Grand Lodge held August 28, 1947, Notice of Motion is hereby given to amend that portion of the Constitutions and General Regulations of Grand Lodge dealing with "Of Fees" as follows:—

"That the last paragraph on page 74 of the Constitutions read as follows: 'For every member, each Lodge shall pay towards the fund for Grand Lodge purposes, one dollar per annum." (This to supersede the former payment of seventy-five cents per member per annum).

It was moved by R:W: R. D. Stewart and seconded by W: A. M. Jensen that the motion be adopted. Carried.

Agreeable to Notice of Motion duly given in the Proclamation of Grand Lodge it was moved by R:W: C. J. MacDonald and seconded by V:W: L. M. Wilson that the amendment as proposed be accepted and adopted. Carried.

"Notice is hereby given that it will be moved at the next Annual Communication of Grand Lodge to be held August 25, 1949, to amend that portion of the Constitutions dealing with the distribution of Lodges by District by removing Ashlar Lodge No. 36 from District No. 5 and adding it to District No. 6: District No. 5 to contain Lodges Nos. 5, 7, 12, 14, 26, 38, and District No. 6 to contain Lodges Nos. 6, 33, 36, 42, 47, 50.

It was moved by the Grand Secretary and seconded by the Grand Treasurer and carried: —

"That an appropriation of five hundred dollars (\$500.00) be made to the Grand Master to help to pay the expenses of visiting and instruction during the year."

"That a sum not to exceed twenty-five dollars (\$25.00) be allowed the District Deputy Grand Masters to defray travelling expenses on their District visits, if they find it necessary and that expense reports be submitted to the office of the Grand Secretary with their annual reports to the Grand Master."

"That the sum of fifty dollars (\$50.00) be set aside for use by the Grand Historian."

"That an appropriation of five hundred dollars be made to the Committee on Masonic Education."

The Special Committee on the Grand Master's Address made report as follows:—

To the Most Worshipful Grand Lodge of Free and Accepted Masons of New Brunswick:

The Special Committee to whom was referred the Address of the Most Worshipful Grand Master, beg to submit the following report.

We join with all the Brethren in having our Grand Master with us today after his long and serious illness, and we trust that the Great Architect of the Universe will, in His wisdom, give renewed health and strength to our Grand Master, for many more years of service.

We congratulate the Most Worshipful Grand Master on the completion of another most successful vear of this Grand Lodge, and the appreciation and thanks of Grand Lodge are due him for his leadership and devotion to the Craft.

We join with the Grand Master in his warm words of welcome to our distinguished visitors, and congratulate him on the very distinct honour conferred by the Grand Lodge of the State of Maine.

We join with the Grand Master in his expressions of regret at the passing of many prominent Masons since the last Communication of this Grand Lodge, both in our own and sister Jurisdictions.

The enthusiasm and energy of our Grand Master has again been shown in the large number of visits which he has made to the individual Lodges, and the invitations he has accepted for Installation of Officers, and we can assure him that all of the Brethren expressed their deepest sorrow when his illness did not permit him to complete the agenda which he had arranged during the earlier part of this year.

We are glad to note that this Grand Lodge was again represented at the Grand Masters' Association in Washington, the Eastern Canada Conference at Charlottetown, and the All-Canada Conference at Toronto, as much good was accomplished by the work of these representatives.
