## ANNUAL MEETING

### Saint John, N. B., August 23rd, 1951.

The Annual Meeting of "The Masonic Grand Lodge Corporation" was held this morning in the Masonic Temple, in the City of Saint John, at 9:30 o'clock, pursuant to notice given in the Proclamation summoning the Annual Communication of Grand Lodge.

Those present are listed as being in attendance at Grand Lodge.

The meeting was called to order at the hour appointed by the President.

V:W: Murray Latham, Grand Treasurer, presented and read the statement of the Corporation Accounts for the past year. (Copies had been previously distributed to the Brethren present). The Statement set forth the Receipts and Expenditures on General Account and also of the Fund of Benevolence and a list of the Assets of the Fund. The Grand Treasurer's Statement had previously been considered and adopted by the Board of Directors of the Corporation.

On motion by R:W: Bro. Charles F. Sanford, seconded by R:W: Bro. Thomas A. Robinson, the Statement of the Grand Treasurer was received and laid on the table.

The Audit Committee submitted a detailed report

as to the Accounts; after the report had been read a motion was made by R:W: J. W. Duncan, seconded by Bro. A. E. Horton, and adopted:—

"That the Accounts of the V:W: Grand Treasurer be taken from the table; that they and the report of the Auditors, as printed and in the hands of the Brethren, be received and that they both be presented to Grand Lodge with a view of being printed in the Annual Proceedings." Carried.

It was moved by V:W: Murray Latham, seconded by R:W: A. C. Lemmon, that the salary of the Grand Secretary's Assistant be \$1,500.00 per annum.

The Annual Meeting of the "Masonic Grand Lodge Corporation," on motion, duly seconded, then adjourned.

# 84th Annual Communication

OF THE GRAND LODGE OF NEW BRUNSWICK

### Saint John, N. B., August 23rd, 1951.

THE EIGHTY-FOURTH ANNUAL COMMUNIcation of "The Grand Lodge of the Antient and Honourable Fraternity of Free and Accepted Masons of New Brunswick" was held at the Masonic Temple, Germain Street, in the City of Saint John, on Thursday, the twenty-third day of August, A.D. 1951, A.L. 5951.

Most Worshipful Dougald Joseph McMaster Mc-Lean assumed the Throne and Grand Lodge was opened in Ample Form at 10:00 o'clock a.m., followed by solemn prayer by the R:W: Grand Chaplain, Rev. Arthur E. Coleman, as follows:—

"Most merciful God, Supreme Architect of heaven and earth, unto whom all hearts are open, all desires known, and from whom no secrets are hid, cleanse the thoughts of our hearts by the inspiration and guidance of Thy Holy Spirit, that we may perfectly love Thee and worthily magnify Thy Holy Name.

"Grant such love and devotion to Thee our Creator, such adherence to the principles of Freemasonry, such unity of mind and high purpose, such harmony and fellowship, such loyalty to duty and noble tenets

of our Order, that all things thought, spoken and done here in this Grand Lodge may be for the advancement of Freemasonry and for the good of all people, and finally for our own salvation in that blessed Kingdom where the righteous shall find rest.

"Hear us, O Merciful God, as we sum up all our hopes, our prayers, our thanksgiving and pray as Thy blessed Son has taught us all to say:

"Our Father, Who art in heaven, Hallowed be Thy Name, Thy Kingdom come, Thy will be done on earth as it is in heaven. Give us this day our daily bread, and forgive us our trespasses as we forgive those who trespass against us. And lead us not into temptation but deliver us from evil. For Thine is the Kingdom and the power and the glory, forever and ever. Amen.

"So mote it be."

The Proclamation calling the Eighty-fourth Annual Communication of Grand Lodge was read by the V:W: Grand Secretary.

The Most Worshipful Grand Master welcomed the Brethren to Grand Lodge as follows:---

It is a very pleasant duty to again welcome the members of Grand Lodge and our Distinguished Guests both as your Representative Head, and personally.

This is your Assembly, and I trust that you will not only learn what has transpired during the past year, but may also carry away from our considerations, thoughts that you may turn into actions—for the benefit of your Lodge or Lodges, which in turn may rebound to the credit and greater honor of our Beloved Order. To our Distinguished Visitors, the same welcome applies—we welcome you in every sense that our great Fraternity stands for. We hope that you may leave with us something for the good of the Craft also that you may receive some inspiration whilst sojourning in our midst. We fully realize that you have made sacrifices and put yourselves out in order to be present with us. We sincerely appreciate the efforts you have made to attend upon our Eightyfourth Annual Communication. Your aid and presence will greatly add to our assembly.

All present are conversant with history now in the making—and probably realize how close disaster may be upon our civilization.

One can, perhaps, understand the thoughts, or rather the ignorance of certain peoples towards our standard of liberty, but to me it is incomprehensible how persons living in our free countries—enjoying all the blessings of freedom—can even think of, let alone work for the destruction of our way of living and would wish to plunge us into chaos, such as appears to be enjoyed, or rather endured, in the before-mentioned countries.

It is the personal duty of every Mason to ferret out and expose all such people in our country, so that our land may be cleansed of such pestilential beings.

Our Order can only flourish in a peaceful atmosphere—although it has withstood the ravages of time and warfare. Let us seek Peace, but not at the loss of Honor.

I regret to learn that the application for Dispensation to form Tyrian Youth Lodge has been withdrawn. It is most regretable that this should happen and I trust the very zealous brethren who were associated in the contemplation of forming this new Lodge will not have lost their zeal and will renew their application at an early date so that we may enlarge our Masonic family to the benefit of themselves and this Grand Lodge.

#### FUND OF BENEVOLENCE

From comments I have heard regarding our Fund of Benevolence I feel that the Craft should be briefed

in a small way on this subject. A common belief seems to be that each Subordinate Lodge contributes to this Fund annually, but such is not the case. No part of our Fees or Dues goes to it. Nor would I recommend that such should happen. In such case each Lodge would be right in assuming that it had full call upon the Fund for all of its benevolent requirements and such a thing would soon bring chaos to the Fund—there just would not be any.

It has grown to its present proportions principally by its own efforts, that is by judicious investments. It is true that in the dim past somewhere in the vicinity of \$2,000.00 was voted to the Fund from General Account over a period—according to our Grand Lodge records—of five or six years, and an amount of \$20,000.00 was utilized from the Fire Insurances on this building at the time of its destruction in 1929. Outside of these amounts, its own interest account has been its life.

The Fund is secured in that only the interest of our investments can be used for the relief of pressing need and if it had not grown as it has we would be unable to do the small things we do for our needy or distressed.

To show "good faith" it is expected that each Lodge that contemplates calling upon our Fund for help will first make a fitting contribution from its own funds or by a canvass among its own membership. The amount so contributed should be stated on the petition to the Committee who administer our Fund and it is not considered proper for any Lodge to so contribute and then expect the Fund to reimburse it on such expenditure.

Personally I feel that the Fund is large enough

at present to carry on our needs. It has been our practice in the past to build bigger and higher the Capital Account as unexpended balance would permit. At any time that it might be required so to do, the Committee administering this Fund could authorize the sale of such of the Bonds as might be needed to augment cash account to meet the demands of the moment but such sale so authorized would reduce the income accordingly and would not be sound business.

I feel that if we would place such portion of our unexpended balance as may be expedient, each year in a reserve fund apart from capital account to be used by the Committee as they may deem wise and reasonable at any time we would give ourselves a small fund from which we could draw authorized amounts to meet needs of the moment. I have in mind particularly the All Canada Conference of March last. At this gathering the Host Grand Lodge-which was Manitoba-thanked the Grand Lodges present for their support during the floods which devastated Winnipeg the year before. Brethren you can imagine my feelings-and those of my associate delegates-when we realized that the Grand Lodge of New Brunswick contributed not one farthing to our Brothers in their time of distress and need. I was ashamed and disturbed that we would permit such a thing to happen. I am sure that if "the shoe had been on the other foot" and we had been assailed by some great disaster, Manitoba, as well as all of the other Sister Grand Lodges, would have swiftly come to our assistance. And so I say to you, some part of our unexpended balance each year should be set apart as an available fund to take care of just such an emergency. I sincerely trust that this matter will be given immediate thought and action.

#### GENERAL ACCOUNT

Our General Account appears to be large. Some will say too large—but we must consider many aspects of this fact. Accounts are payable to Grand Lodge beginning January 1st. At this period about 50 per cent of the Lodges make their returns and pay the amounts due. The balance of the Lodges drag along through the rest of the term up to July—and in some cases August. From then to December there is no income and our bank balance as of July 31st must carry all expenditures of Grand Lodge until the new year rolls around. Our fixed charges—rent, salaries and other items are covered by this balance.

In the past we have used "Fees" as part of our General Account. This was necessary as the "Dues" are not sufficient to carry Grand Lodge for a whole year. This is easily discernable when we note that we have approximately 8,000 members on which \$1.00 per capita is paid and our natural expenditures amount to over \$9.000.00. There is the possibility of our having no fees payable to Grand Lodge in any given year and in such case we become insolvent. Every one present knows what this would mean. It would become necessary then to make a levy on the Craft by an assessment-which always causes an upset in the finances of Subordinate Lodges. Masonry costs us little in this Province. Initiation Fees are mostly at a minimum as are our Annual Dues. Many of the Subordinate Lodges just eke out a bare existence using both Fees and Dues to survive.

Fees should be "extras" in all Lodges. Dues should be sufficient to carry the expenses of every Lodge and I would suggest to you now that each Lodge looks to itself for a correction of this matter. I would also strongly suggest to the next Grand Master that he set up a strong financial committee to go deeply into this subject with a view to increasing our per capita tax to give Grand Lodge sufficient income to carry on adequately the business of Grand Lodge without too much curtailment, for instance— It was anticipated this year to reprint our Cipher Ritual—which is much needed. The great upswing in the cost of materials and labor caused us to hesitate before committing Grand Lodge to an expenditure which might have been somewhat embarrassing. Had we authorized the reprinting it would have cost us about 100 per cent more than the first issue and left our financial structure very weak indeed.

I have but touched on these subjects in a small way and to bring the facts before you, but something must be done very soon to strengthen the finances of Grand Lodge before we get ourselves into trouble. I do not desire to become involved in any controversy or debate on these subjects at this time but recommend to you all that you give the matter rational study and that a strong province-wide committee will bring in a suitable resolution—either now or at next Grand Lodge—to correct our rather weak condition. In this day of rapidly rising costs of every commodity something must soon be done or we shall find ourselves in financial trouble.

#### VISITATIONS

During the past year I did not accomplish, within the jurisdiction, all I hoped to do — the following Lodges were visited: Ashlar No. 36, New Brunswick No. 22, Steven No. 37, Victoria No. 26, Sussex No. 4.

Visitations were made to the following Lodges for the purpose of installing the officers — St. George

No. 12, St. John's No. 2, Union Lodge of Portland No. 10, Mananook No. 38, Lebanon No. 28. I also installed the officers in Tweedie No. 41 and Acacia No. 49 at a joint meeting of these Lodges.

On all these visitations I was received with warm welcome and found the brethren enthusiastic about Masonry. All lodges visited are enjoying healthful increase and are in flourishing condition.

On an invitation from Worshipful Master Northrup I attended a meeting of Albert Lodge No. 34 held the evening of December 12th and witnessed Worshipful Brother Northrup raise his three sons to the sublime degree of Master Mason. This was unique, not only in our jurisdiction, but I believe in Masonry. On different occasions three or more blood brothers have been raised at one communication of a lodge but not while their father was the Worshipful Master of the lodge. I am pleased to say our Grand Historian was present also, for Masonic history was being made that night.

On every visitation I was accompanied by a large retinue of Grand Lodge officers, and can only say that I am and will always be profoundly grateful for their support.

One year ago I recommended that the District Deputy Grand Master hold annual meetings in their respective districts, a suggestion that the Secretaries of the lodges could get together at the same time and have the Grand Secretary meet with them and make an effort to smooth out the functioning of their offices. One such meeting was held by District Deputy Wylie of District No. 6, and while there was no set-up under which the district meeting could adopt motions, at the same time, minutes could be kept and recommendations and suggestions made to be submitted in the Deputy's report. I am of the opinion still that this matter should be taken into consideration and the necessary legislation adopted whereby district meetings will be held in accordance with Grand Lodge procedure.

On May 6th Grand Lodge accompanied by brethren from various Lodges throughout the Jurisdiction, on the invitation of the Right Woshipful Grand Chaplain, attended Divine service in Trinity Church, when Brother Coleman delivered a very fitting and inspiring sermon, selecting as his text — the words of the Psalmist: "Except the Lord build the house, they labor in vain that build it." About three hundred Masons were in attendance.

### VISITATIONS TO SISTER GRAND JURISDICTIONS CENTENNIAL OF GRAND LODGE OF CALIFORNIA

It was my rare privilege and pleasure, accompanied by my wife, to attend the Centennial of the Grand Lodge of California held in the city of San Francisco October 7th to October 14th, 1950. We travelled by plane from Pennfield airport leaving on the afternoon of October 5th, and with night stops at Boston and New York, arrived in San Francisco the evening of October 7th. We were met by Brother Terry of that city and taken to the St. Frances Hotel. Next day (Sunday afternoon) we met Most Worshipful Grand Master Ellsworth Meyer and some of the distinguished visitors. That evening we attended a "get acquainted dinner" in the Italian room of the hotel and later attended the Standard Symphony hour in the War Memorial Grand Opera House. On Monday, after the opening of Grand Lodge, the visiting Grand Masters, Past Grand Masters, Grand Secretaries and other

guests were presented to and received welcome from Most Worshipful Brother Meyer, who in his own inimitable manner, greeted and welcomed the seventy-eight distinguished guests, having some individual word of greeting for each. Everything possible was planned by our California Brethren for the entertainment of their guests, no stone was left unturned in their efforts to attend to our comfort and enjoyment.

Grand Lodge assembled in the Civic Auditorium and for the first time Master Masons were permitted to attend a communication of Grand Lodge. About five thousand were present the first day. Much business was transacted and carried on most efficiently during the sessions of Grand Lodge. Recommendations were dealt with individually and discussed freely and for the most part adopted and approved.

The message of the Grand Master was edifying and inspiring, as were the addresses delivered by several of the visiting Grand Masters. I repeat a few of the closing remarks of Grand Master Meyer, some of these you may have read or heard before, but I think you will find in them as clear a picture of Masonry as can be set forth. Masonry is not a religion but it is religious. It does not require a particular church affiliation and only asks a candidate whether he believes in a Supreme Being and some form of future existence. It is not a political organization, but it does impress upon its members that they have civic duties to perform through channels of expression outside its Lodges. It is not a benefit society. It offers no form of insurance but it need yield to none in works of charity. It does not seek the front page, but it does not shun the light of inquiry. It is a secret society as to its modes of recognition and pass words but there is no secrecy as to its organization, principles or purposes. It denies the claims of dictators, political or religious, but it is loyal to Governments established by free peoples. For many centuries Masonry has united at its altars of reverence, men of good will who have striven by every resource of their art to make tangible the power of Brotherhood, the worth of virtue and the reality of the ideal. Masons will continue to build the temple of humanity among the nations and in the hearts of men.

We visited the Masonic home for aged Masons and their wives or widows, and witnessed the wonderful work being done by the Masons of California for those who are in the evening time of life, providing for their comfort, preserving their happiness and strengthening their belief in the brotherhood of man and the fatherhood of God. The guests of the home with whom we talked had only the highest praise for these brethren and Freemasonry.

As I mentioned earlier no opportunity to provide for the pleasure of the visitors was overlooked and our brethren were efficiency itself in carrying out the program, from attendance at the Grand Opera to visiting points of historical and national interest. The war memorial opera house is the birth place of what is now the United Nations assembly. The Muir woods with its cathedral grove where the delegates who first assembled to form that United Nations assembly held a memorial service for the late President of the United States, Franklin D. Roosevelt. We visited San Francisco's Chinatown, had a boat sail around Alcatraz thereby sailing under the Golden Gate Bridge as well as travelling over it on the way to Muir woods.

Brethren the Grand Lodge of California celebrated one hundred years of Masonry in a manner befitting the occasion, and I would say that the searchers for

gold, who one hundred years ago, formed the lodges out of which the Grand Lodge of California grew handed on to posterity riches far greater than the gold which they unearthed. Gold, if you wish to call it such, is still to be found in California, the pure gold of hospitality, the richness of kindness, the immeasurable wealth of friendship is still there in the hearts and in the personalities of its people.

#### GRAND LODGE OF NORTH CAROLINA

In April of this year we, (my wife and I), accepted the kind invitation of Most Worshipful Grand Master Caldwell of North Carolina and motored down to Chapel Hill in that fair state and attended the one hundred and sixty-fourth communication of the Grand Lodge of North Carolina. It was very pleasant for us to be able to renew acquaintances made at other visitations. One of the highlights of the communication was the laying of a corner stone by the officers of Grand Lodge. We had a very enjoyable visit.

#### EASTERN LODGE No. 7, EASTPORT, MAINE

I regretted being unable to accept the invitation of Most Worshipful Brother Lander of Maine to attend the one hundred and thirty-second Communication of his Grand Lodge, but I am happy to report that I was able, along with some of the Grand Lodge Officers, to join with the brethren of Eastern Lodge when on June 25th of this year, they celebrated their Sesqui-Centennial. Past Grand Master Murchie delivered a very fitting address at the building in which the Lodge first met. I was pleased to extend congratulations and best wishes from this Grand Lodge and the New Brunswick brethren.

Much to my disappointment I was unable to attend the Annual Communications of the Grand Lodge of

Canada in Ontario, and the Grand Lodge of Nova Scotia. I also received an invitation from the Grand Master of Massachusetts to attend either their quarterly or annual communication, but press of daily tasks prevented me from accepting.

#### GRAND MASTERS CONFERENCE OF NORTH AMERICA

I attended the Conference of Grand Masters held in Washington, D. C., February 20th and 21st of this year. After a warm welcome extended by Grand Master Davison of the District of Columbia, the Conference got underway and the following agenda was carried out:---

"The Spiritual Force of Freemasonry," Wallace E. Caldwell, G. M. of North Carolina; "Inaugurating Educational Programs," Morgan J. Smead, G. M. of Michigan; "A Uniform Basis of Recognition," C. Wheeler Barnes, G. M. of Colorado: "Freemasonry and its Doctrine of Universality," Orestes Frodden, G. M. of Chile: "Freemasonry and Its Members," Gail Huhn, G. M. of Washington; "Freemasonry and Youth," Francis H. Auld, G. M. of Saskatchewan; "Candidate Investigation," Okey S. Sheets, G. M. of West Virginia.

All the above mentioned addresses carried much enlightening and inspiring information concerning Freemasonry — revelent to the various topics.

On Wednesday morning February 21st., the members of the Conference attended a breakfast in honor of the President of the United States as guests of Brother Frank S. Land. In reporting this I can do no better than quote in part what is recorded in the Conference Proceedings. Present and addressing the Brethren for short periods were Chief Justice Vinson, Secretary of State Acheson, Secretary of Defense Marshall and Speaker of the House Rayburn.

The head table was also graced by other high ranking officials and cabinet members. This stirring event was brought to a fitting climax by an inspiring address by the President who was graciously presented by our host. All who were privileged to attend were inspired by this contact with our renowned brethren.

I feel that attendance at the Conference of Grand Masters should be a must, as the Grand Master is thereby enabled to meet his contemporaries and exchange Masonic views and learn first hand what the other jurisdictions are doing. As I said last year, man is confined only by the limits of earth. I was quoting at that time, I have since learned that we are closer neighbors with those who live in the fartherest corners of this continent, than our grandfathers or even our fathers were to those who lived in adjoining provinces. And I firmly believe that it is good for us to become acquainted with and know our neighbor.

#### ALL CANADA CONFERENCE

From Washington we proceeded to Winnipeg to attend the All Canada Conference. The following agenda was carried out:---

"Masonic Relief and its relation to present day social legislation"; "Should Masonic Functions and projects receive more publicity?"; "Freemasonry in South America"; "Has Freemasonry any obligation to the Church?"; "How Can Freemasonry best serve in a National Emergency?"; "Freemasonry and Youth —What is our obligation?"; "Are Masonic Lodges looked upon in the same high regard today as in the past?"; "Lodge of Research"; "Masonic Education"; "Should constituent lodges give publicity through local publications?" Your delegation to this Conference presented the subject "Should Masonic Functions and Projects Receive More Publicity," and led in the discussion of the subject "Has Freemasonry Any Obligation to the Church?"

#### FAITH

Faith in certain fundamentals has carried our people to a very high level of spiritual and material well being. No claim is made, nor should be, that we have achieved the ultimate. The fundamentals by which we achieved an undreamed richness of heritage are: Belief and faith in God - Belief and faith in the individual — Belief and faith in works. These faiths have led to development of a system of government and in a code of conduct, undergirded by a set of written rights and responsibilities which stand the test side by side with other forms of religious structure. Allegiance to these faiths held and strengthened through the years. At this most historic time, when our ideals are being seriously assailed again, it is time to re-state our faith in those elementary faiths -all anchored in the first "Belief and Faith in God." And since no faith is deeper than the work it generates, it is a good idea to take a look at the work as represented by the segment that we do something about: we individually and we in our social groups. We as individuals and as a group must maintain our allegiance to these fundamental faiths and strive to live them in our works.

In closing I wish to express my appreciation and thanks to those who have so willingly and cheerfully assisted me on every occasion. The Past Grand Masters and other Grand Lodge officers who have so faithfully attended me on official visitations. I speak my thanks to the Grand Secretary, the magnetic needle

of Masonry in this jurisdiction ever pointing out the right way, and I also commend him as a road leveller. I know he has removed many rough parts from my pathway during the last two years. I also voice my gratitude to my employers who have always co-operated in every way in making the duty of serving you, not only a privilege but a joy and pleasure.



V:W: H. I. Knowles, chairman of the Committee on Masonic Education presented the report of that committee, which was received. It was moved by R:W: H. A. Porter, seconded by R:W: A. S. Robinson, that the report be sent back to the committee for more specific amplification on the problems of method of further forwarding their recommendation.

#### REPORT OF COMMITTEE ON MASONIC EDUCATION

To the Grand Lodge of Free and Accepted Masons of New Brunswick:----

Five years have passed since the Lodge System of Masonic Education was introduced in this Grand Jurisdiction. The Lodge System is designed to function through an educational committee appointed by the Master of a Lodge and to give the candidate pertinent information on Masonry not covered by the Ritual. Apparently few Lodges, if any, are working the System. Consequently it has failed to accomplish its purpose. However, the importance of supplementary instruction for the candidate has not diminished. Indeed, it is a subject of lively interest in most Masonic circles. Believing that Grand Lodge is conscious of its responsibility for leadership in this matter, your committee intends to examine other means of making available to the candidate, Masonic information which every newly-made Mason should have.

In many of the Jurisdictions in North America this is accomplished by giving the candidate a series of pamphlets one after each Degree. The Masonic information contained in these pamphlets is much the same as that found in the booklet which was issued in connection with the Lodge System of Masonic Edu-

cation. Therefore, much of the subject matter of the Lodge System booklet, together with certain articles published in the Masonic Digest, could be used in preparing a suitable booklet for presentation to the candidate when made a Master Mason. Whether a single booklet is preferable to a series of pamphlets is one question which requires careful consideration. Another is whether the Lodge should pay for the booklet presented to the candidate or should this be an contribution of Grand Lodge. Evidently the whole matter is one which must come before Grand Lodge for the approval of any proposals the committee may make.

Copies of the Masonic Digest issued during the past year were mailed to the Secretary of each Lodge for distribution to the membership as heretofore.

Inasmuch as this educational effort appears to justify the cost—about \$250.00 annually—the publication will be continued.

#### REPORT OF THE GRAND HISTORIAN

#### Saint John, N. B., August 23, 1951.

To the Most Worshipful, The Grand Master, Officers and Brethren of The Grand Lodge, Free and Accepted Masons of New Brunswick:—

Most Worshipful Sir and Brethren:

I beg to submit the following report for the year intervening between the last Convocation of Grand Lodge and this.

Thanks to the frequent reminders on the part of our Grand Master to the Secretaries of the Lodges I did not find it necessary to send out my customary circular letters to them during the year as many followed his instructions and sent me their Notices whenever anything of special interest came up.

I thank the Grand Master for this help and for the list of representatives from the Grand Lodges in the United States and Canada who, with him, attended the historic celebration in California.

I am indebted also to the Grand Secretary for notes on the laying of the cornerstone of the new Masonic building in Chatham, and to Past Master Douglas Hannah for further interesting material from Zetland Lodge.

The correspondence in connection with the Eastern Conference in Quebec has been turned over to me by Most Worshipful R. V. Harris, who attended to the duties of secretary in my absence owing to my illness.

During my stay in Ontario last autumn I was privileged to visit Lodges in Grimsby, Hamilton and Toronto, in all of which I was received with great courtesy and kindness. In Union Lodge No. 7 in the town of Grimsby I was shown documents of considerable historic interest and was presented with two copies of the history of that fine old Lodge—one for our collection and one for myself.

Accounts of interesting events during the year in our own Jurisdiction have been added to our binders, such as the raising by Worshipful Brother Orin Northrup of three of his sons in one communication of his Lodge in the village of Albert. I was privileged to accompany the Grand Master on that occasion.

I have experienced a personal bereavement in the passing of our late beloved Past Grand Master Dr. Malcolm, who first entrusted me with the duties of this office and I am sure you all feel as I do.

I wish to urge upon all to take an interest in our history department. It is important to us and will be more so to those who come after us.

Let me also earnestly request you to lend your help that any relics that are of interest to the Craft which you can save from destruction be preserved by you. Whether in this office or otherwise, I shall be very glad to lend any assistance I can to this end.

The lapse of Time, the ruthless Hand of Ignorance and the Devastations of War have laid waste and destroyed many valuable monuments of Antiquity upon which the utmost exertions of Human Genius have been employed.

How much more those lesser, intimate things associated with the story of our own Jurisdiction! I grant you many care nothing about such things and see no value in them, but on the other hand, many do, and for their sakes, at least, our interest and assistance should be maintained.

In closing, I wish to thank very much the many

Likewise on written nomination and ballot cast in each case the scrutineers reported that the following brethren had received the majority of all votes cast and they were accordingly declared duly elected: R:W: Deputy Grand Master, Andrew D. McCain (35); R:W: Senior Grand Warden, Gordon H. Scott (13): R:W: Junior Grand Warden, Foster C. Thurston (3); V:W: Grand Chaplain, Rev. John R. Humphreys (22); V:W: Grand Treasurer, Murray Latham (3).

On open nomination and vote W: Brother William Robert Powell was elected Grand Tyler.

Past Grand Master James S. Hoyt now assumed the Grand East and requested the Grand Director of Ceremonies to present the Most Worshipful Grand Master-elect at the Altar. After solemn prayer the

Grand Master-elect was duly obligated and then invested with the jewel of his office and installed Most Worshipful Grand Master of the Grand Lodge of Free and Accepted Masons of New Brunswick and was accordingly so proclaimed from the South, the West, and the East and accorded Grand Honors.

Most Worshipful Brother Duncan thanked the Brethren for their confidence in him by electing him their Grand Master and Past Grand Master Hoyt for his kind office in installing him. He then appointed the following Officers and they were duly installed as well as the other elected Officers into their respective stations:----


