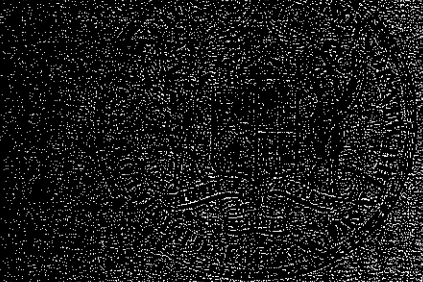

ANNUAL MEETING

Saint John, N. B.,  
August 28th, 1952.

The Annual Meeting of "The Masonic Grand Lodge Corporation" was held this morning in the Masonic Temple, in the City of Saint John, at 9:30 o'clock, pursuant to notice given in the Proclamation summoning the Annual Communication of Grand Lodge.

Those present are listed as being in attendance at Grand Lodge.

The meeting was called to order at the hour appointed by the President.

V:W: Murray Latham, Grand Treasurer, presented and read the statement of the Corporation Accounts for the past year. (Copies had been previously distributed to the Brethren present). The Statement set forth the Receipts and Expenditures on General Account and also of the Fund of Benevolence and a list of the Assets of the Fund. The Grand Treasurer's Statement had previously been considered and adopted by the Board of Directors of the Corporation.

On motion by R:W: Bro. W. P. Barnhill, seconded by V:W: Bro. R. D. Magee, the Statement of the Grand Treasurer was received and laid on the table.

The Audit Committee submitted a detailed report as to the Accounts; after the report had been read

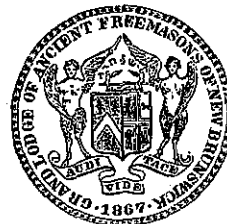
a motion was made by R:W: W. P. Barnhill, seconded by R:W: D. J. M. McLean and adopted:—

THE EIGHTY-FIFTH ANNUAL COMMUNICATION of "The Grand Lodge of the Antient and Honourable Fraternity of Free and Accepted Masons of New Brunswick" was held at the Masonic Temple, Germain Street, in the City of Saint John, on Thursday, the twenty-eight day of August, A.D. 1952, A.L. 5952.

Most Worshipful James William Duncan assumed the Throne and Grand Lodge was opened in Ample Form at 10:00 o'clock a.m., followed by solemn prayer by the R:W: Grand Chaplain, Rev. John R. Humphreys, as follows:—

"Most merciful God, Supreme Architect of heaven and earth, unto whom all hearts are open, all desires known, and from whom no secrets are hid, cleanse the thoughts of our hearts by the inspiration and guidance of Thy Holy Spirit, that we may perfectly love Thee and worthily magnify Thy Holy Name.

"Grant such love and devotion to Thee our Creator, such adherence to the principles of Freemasonry, such unity of mind and high purpose, such harmony and fellowship, such loyalty to duty and noble tenets

of our Order, that all things thought, spoken and done here in this Grand Lodge may be for the advancement of Freemasonry and for the good of all people, and finally for our own salvation in that blessed Kingdom where the righteous shall find rest.

"Hear us, O Merciful God, as we sum up all our hopes, our prayers, our thanksgiving and pray as Thy blessed Son has taught us all to say:

"Our Father, Who art in heaven, Hallowed be Thy Name, Thy Kingdom come, Thy will be done on earth as it is in heaven. Give us this day our daily bread, and forgive us our trespasses as we forgive those who trespass against us. And lead us not into temptation but deliver us from evil. For Thine is the Kingdom and the power and the glory, forever and ever. Amen.

"So mote it be."

The Proclamation calling the Eighty-fifth Annual Communication of Grand Lodge was read by the V:W: Grand Secretary.

The Most Worshipful Grand Master welcomed the Brethren to Grand Lodge as follows:—

It is a very pleasant duty to again welcome the members of Grand Lodge and our Distinguished Guests both as your Representative Head, and personally.

This is your Assembly, and I trust that you will not only learn what has transpired during the past year, but may also carry away from our considerations, thoughts that you may turn into actions—for the benefit of your Lodge or Lodges, which in turn may rebound to the credit and greater honor of our Beloved Order.

To our Distinguished Visitors, the same welcome applies—we welcome you in every sense that our great Fraternity stands for. We hope that you may leave with us something for the good of the Craft—also that you may receive some inspiration whilst sojourning in our midst. We fully realize that you have made sacrifices and put yourselves out in order to be present with us. We sincerely appreciate the efforts you have made to attend upon our Eighty-fifth Annual Communication. Your aid and presence will greatly add to our assembly.

All present are conversant with history now in the making—and probably realize how close disaster may be upon our civilization.

One can, perhaps, understand the thoughts, or rather the ignorance of certain peoples towards our standard of liberty but to me it is incomprehensible how persons living in our free countries — enjoying all the blessings of freedom — can even think of, let alone work for the destruction of our way of living and would wish to plunge us into chaos, such as appears to be enjoyed, or rather endured, in the before-mentioned countries.

It is the personal duty of every Mason to ferret out and expose all such people in our country, so that our land may be cleansed of such pestilential beings.

Our Order can only flourish in a peaceful atmosphere—although it has withstood the ravages of time and warfare. Let us seek Peace, but not at the loss of Honor.

### GRAND MASTER'S ADDRESS

*To the M: W: Grand Lodge of F. & A. Masons of New Brunswick:*

At the end of another Masonic Year we again assemble and with deep gratitude, thank Almighty God for the privilege which has been given us of coming together to review our past endeavors and agree to

plan for the accomplishment of many things which we trust will be of benefit to mankind outside of, as well as, within our Lodge rooms.

I extend to each of you fraternal greetings and bid you welcome to our 85th Annual Communication and whether this is your first opportunity of attending this gathering as a new member of this Grand Lodge or if you have been here many times before, be assured that this is your Grand Lodge and the reports to which you listen as presented by the several Grand Lodge Officers are records of their efforts on your behalf and your interest; deliberations and example will be the gauge by which you elect future Grand Officers and therefore the future of this Grand Organization lies in a great measure within your hands.

Rev. Thomas S. Roy, Grand Master of Massachusetts. This address of such a high calibre it was one of the highlights

of their annual communication and was what one might expect from such an outstanding speaker as Dr. Roy.

A short history of the Lodge was given by Wor. Bro. John T. Reid. Your Grand Master made a short address to the Craft and we were again privileged to hear from Dr. Roy at this time. Following these ceremonies a dinner was served and the assembled Brethren and their ladies attended a dance to complete the Anniversary Celebration.

Your Grand Master accompanied by our V:Wor. Grand Secretary attended the Grand Masters' Conference at Washington on February 20th and 21st and were not only well received but were able to hear and enjoy papers on such subjects as:—

1. The Romance of Freemasonry by Rev. Thos. S. Roy, D.D.G.M. of Massachusetts.
2. Masonic Responsibility for Good Citizenship by Oliver Dabezies, G.M. of Louisiana.
3. Landmarks in Freemasonry, by Chandler C. Cohagen, G.M. of Montana.

Also heard were Committee reports and new work proposed to be carried forward in the interests of our order.

Established as a new facility of the Conference was a Commission on Information for Recognition whose duty it shall be to assemble and collate information on Grand Lodges as a service to the member Grand Lodges of the Grand Masters' Conference. Those Grand Lodges who feel that such a facility has great potentialities are requested to send voluntary contributions to the Commission, the sum of \$25.00 being suggested for those whose membership does not exceed 20,000.

Although I do not think we have many visitors from outside our Jurisdiction which require us to know details of their mode of recognition I feel that the small amount requested of \$25.00 should be forwarded and I would so recommend.

During the week of June 9th your Grand Master and Grand Secretary visited by invitation the Grand Lodge of Nova Scotia and were most cordially treated by the Grand Master Harry M. Standish and his many friends. At their hands I was presented with the Erasmus James Philipps Medal in token of high regard to your Grand Jurisdiction and I assure you, your Grand Master wears it with pleasure and admiration. I should tell you that during this visit I was honored as I attended three other Masonic Meetings, each of which it is my privilege to be a member. Nova Scotia could not do too much for us, in fact they presented a special flag of their Province to us, they being the only Province of Canada, enjoying this right.

I know of no dissatisfaction from any source. We have had one visit from a group of Masons from Ohio who demonstrated their degree work on one Mason from our Jurisdiction and I understand a return trip



is to be made by members from this Jurisdiction. I would favor more visitations within our own boundaries rather than go afield.

I would point out to the D.D.G.M.'s for next year that they should keep informed as to the detailed working of each Lodge and encourage closer adherence to our Constitution and By-laws.

A few items which no doubt will be before them could be:—

1. Reprint of our Ritual in Cipher.
2. Preparation of standard certificates and (or) jewel to be presented for long years of meritorious service.
3. List to whom Lodge Meeting Notices are to be sent.
4. Special Dispensations.
5. Funeral Services.
6. Dignity of our Order.

I would say just a word about Masonic Funerals, a subject which will be touched upon here today, enough to tell us that here we have a duty to perform; one which leaves a very lasting impression upon the bereaved ones in particular. May I just say at this time, let us each make sure this great Fraternity will be held in high esteem by our acts as we remember those who have gone to that undiscovered country from which no traveller returns.

The impressive dignity of our Order has been mentioned and each of us does realize that Masonry has always been considered definitely above the average among the Fraternities and Masonry and Masons have always been favorably commented upon for their outward appearance, with proper dress. We have an outstanding heritage to maintain, progress cannot remain

stationary; be sure the part you play causes advancement.

This Order, of which each of us are justly proud, has stood the test of time (both fair and otherwise) over a great period of time. Our only endeavor is simply to make good men better and together enjoy that great fellowship as those who want to follow the teachings of Him who gave us "The Golden Rule."

Be very careful, My Brother, before you are party to any change taking place in our Constitution, our By-laws or our Way of Life.

The threats of war are still with us. Greed and avarice, lust and hatred appear to be paramount in the minds of men. The simple doctrine of the Prince of Peace is yet forgotten. I earnestly pray that before another year passes into history that the steadying influence of Freemasonry may be firmly implanted upon the consciences of people everywhere; that we, individually and collectively, and united as one great Fraternity for good, may exert a persistent effort to enforce the doctrine of the Brotherhood of Man and the Fatherhood of God, and thereby dispel the thought that Might must triumph over Right.

We must be constantly alert, lest the rich heritage of freedom and democracy be denied us. We must be forever proud of our citizenship in a free land, ever remembering it is our duty as citizens of Canada to exercise our right of Franchise. We must firmly oppose the introduction of any politics into Masonry, but there should be no compunction whatever in the injection of Masonry into politics. All forms of Isms are repugnant to Freemasonry save that of zealous Patriotism and true Canadianism.

In conclusion I must tell you, my year in office as

your Grand Master has been most pleasant and enjoyable.

If I have achieved any measure of success, merited any accomplishments whatever, it has been due to the genuine assistance accorded to me in the true spirit of Masonic Brotherhood.

I would thank every member of each Committee and appointed officer for their fine service and particularly our V:W: Grand Secretary and his staff for their very valuable labors.

In my Masonic career, I have been guided by this bit, of philosophic wisdom:— "To be just, upright, sober and industrious, amenable to the law, and to faithfully discharge the duties of office, whether serving the government or affiliated with a private enterprise; together with an everlasting realization that he is a Mason, and that the Order is judged through his personal actions, stamps the man a credit to his Blue Lodge and a desirable citizen of our Great Country.

Such has been my aim and ambition throughout.

Brethren I am deeply grateful to each and all of you, of every rank and distinction in the Grand Jurisdiction of New Brunswick.

May the blessing of Heaven rest upon you and our Brethren wherever located. May Brotherly love prevail and every Moral and Social Virtue Cement Us.

If such there be, Masters are urged to communicate with the Grand Secretary who will give all assistance possible in preparing reports for the consideration by the Board.

We, your committee appointed to audit the books and accounts of the V:W: Grand Secretary and the V:W: Grand Treasurer report as follows:—

The Grand Secretary's cash book showed receipts for fees and dues, etc. of \$10,275.95 and this was deposited in the Bank of Nova Scotia to the credit of the General Account.

The Grand Treasurer's books for the General Account and the Benevolent Account were also examined. Receipts and Expenditures were checked and vouchers were produced covering payments. The bank balances were verified. Bonds at par value \$102,000 held in a safety deposit box in the Bank of Nova Scotia, Prince William Street, Saint John, were checked and found correct.

Insurance Policies are on hand covering Grand Lodge Regalia \$2,500.00 and Oil Paintings \$4,800.00.

REPORT OF COMMITTEE ON  
MASONIC EDUCATION

In the last report of the Committee on Masonic Education reference was made to the booklet system of Masonic education whereby the candidate is given informative booklets on Freemasonry.

The proposition has been the subject of an investigation regarding the suitability of the booklet system for this Grand jurisdiction. Inasmuch as the work of the committee in this regard has not been finished it is not possible to make an adequate report at this time.

The activity of the committee during the past year has been confined mostly to the publication of the Masonic Digest. The cost is still a modest one, being equivalent to one cent a copy for a four-page issue delivered to a Lodge. The last issue of twelve pages cost about two and one-half cents a copy. Total expenditure on the Masonic Digest for the year was \$394.00. As heretofore the co-operation of Lodge Secretaries, who enclose a copy of the Masonic Digest with a Lodge notice of meeting, has made it possible for the Craft to receive a copy at a minimum cost.

## REPORT OF THE GRAND HISTORIAN

*To the Most Worshipful, the Grand Master,  
Officers and Brethren of the Grand Lodge,  
Free and Accepted Masons of New Brunswick—*

Most Worshipful Sir and Brethren:

I wish to express my thanks for the privilege of serving again during the Masonic year now closing in the office of Grand Historian.

A great deal of my writing time during the year was consumed in the editing and general preparation of the reports of the Third and Fourth Conferences of the Grand Lodges of Eastern Canada held in Charlottetown and Quebec City respectively and in winding up the affairs of the Conference, which has discontinued its meetings.

This duty fell to me as Secretary of the Conference. As I was ill during the Quebec Sessions and unable to attend my work for that gathering was very kindly looked after by W:M: Bro. R. V. Harris, Grand Secretary of the Grand Jurisdiction of Nova Scotia, to whom I tender sincere thanks. Consequently much securing of material, etc., for compiling the books had to be done by correspondence after I recovered sufficiently to work. The section dealing with the Charlottetown Conference was not available for a considerable time due to the critical and prolonged illness of the President, M:W: George G. Wood. However, all was completed at last, the books sent to the proper parties and all financial matters adjusted. This work tied in with that of my office in this Grand Lodge as the books are now important records of a Masonic movement which proved intensely interesting and instructive for a period of four years.

I attended the Special Communication of St. John's

Lodge No. 2 on April 5th during its 150th Anniversary celebration,—an historic occasion indeed. Notice of Motion having been given and published in the Proclamation calling Grand Lodge, the following changes in the Constitutions and General Regulations of the Grand Lodge of New Brunswick were amended as follows:—

"Of Public and Funeral Processions," the following paragraph numbered (6) In the alternative the following procedure may be adopted: The Masonic fu-

neral service may be conducted for any deceased brother, who has requested the same, at a funeral home or his residence; on the evening preceding the interment of his body, provided that the necessary dispensation is obtained and all other formalities observed as required in the five preceding paragraphs under this heading."

**"Of Jewels":**—After the words "to be of silver" (page 77) "Provided that any Lodge constituted for at least one hundred (100) years may, by vote of the Lodge, have the above jewels of gold or gold plate."

**"Of Collars":**—After the word "ribbon" line (5) "Provided that any Lodge constituted for at least one hundred (100) years may by vote of the Lodge use gold or gold-plated chain."

**"Of Aprons":**—"The metal parts of the Aprons of Past Masters and Master Masons of any Lodge constituted at least one hundred (100) years and which has elected to use gold or gold plate on its regalia shall be finished in gold or gold plate."

M:W: Brother Duncan called upon M:W: Rev. Thos. C. Roy, the Grand Master of Massachusetts and M:W: Harry M. Standish, Past Grand Master of Nova Scotia and asked them to accept on behalf of himself and the Grand Lodge of New Brunswick, honorary membership as Past Grand Master of the Grand Lodge of New Brunswick and presented them with certificates of membership.

At this point M:W: Brother Reginald E. Goldsmith, P.G.M. asked the permission of M:W: Brother Duncan to address Grand Lodge which was accorded him. M:W: Brother Goldsmith then, on behalf of the Grand Master of the Grand Lodge of New Hampshire presented to M:W: Brother Harry M. Standish,

P:G:M: of the Grand Lodge of Nova Scotia, New Hampshire's Jeremy L. Cross Medal of Merit. He then called upon M:W: Brother Duncan and in like manner presented him with a like Jewel, then surprised the V:W: Grand Secretary by also decorating him in the same manner.

Grand Lodge then took recess.

Grand Lodge resumed labour at eight o'clock p.m. and the first order of business was the Election of Officers.

The M:W: Grand Master directed the Grand Secretary to read that portion of the Constitution dealing with the "Election of Grand Lodge Officers" which was accordingly done. The Grand Master then appointed as scrutineers: R:W: W. P. Barnhill, and V:W: Bros. George B. Ingraham, C. W. Lobban, Fred E. Mallory, Wilson Wylie, who were pledged and the elections proceeded.

On written nomination James William Duncan was re-elected Grand Master and was accordingly so declared.

Likewise on written nomination and ballot cast in each case the scrutineers reported that the following brethren had received the majority of all votes cast and they were accordingly declared duly elected: R:W: Deputy Grand Master, Robert B. Graham (23); R:W: Senior Grand Warden, Ernest H. Cameron (22); R:W: Junior Grand Warden, Albert G. Hoar (22); V:W: Grand Chaplain, Canon The Rev. W. P. Haigh (8); V:W: Grand Treasurer, Kenneth R. Nelson (1).

On open nomination and vote Brother William Robert Powell was elected Grand Tyler.

Past Grand Master Dougald J. M. McLean now

assumed the Grand East and requested the Grand Director of Ceremonies to present the Most Worshipful Grand Master at the altar. After solemn prayer the Grand Master was duly invested with the jewel of his office and installed Most Worshipful Grand Master of the Grand Lodge of Free and Accepted Masons of New Brunswick and was accordingly so proclaimed from the South, the West, and the East and accorded Grand Honours.

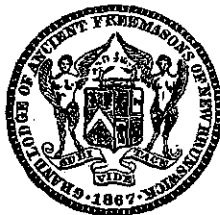

## REPORTS Of District Deputy Grand Masters

### DISTRICT No. 1

In closing, I wish to express my thanks for my appointment to this office and while I do not feel that I have accomplished anything of consequence during the past year; if re-appointed for a further term will make a special effort to carry out the duties of the office in a more efficient manner.

Here we see some of the oldest active Masons I know of taking part in the work and they are to be congratulated for their interest.

June 15, 1952—I attended Divine Service with Miramichi Lodge No. 18 at Loggieville, where we had a very large turnout of members from Miramichi and Northumberland Lodges, and also a few from other Lodges. Headed by the North Shore Regimental Band from Chatham, we marched through Loggieville to the Church but our return was marred by a very heavy rainstorm which caused us to break procession.

June 22, 1952—I attended Divine Service with Lodge St. John's No. 27 at Bathurst which was largely attended and headed by the Newcastle Band and accompanied by a good many visiting Brethren marched to the Presbyterian Church, where an impressive service was held.

This is not good for candidates nor does it improve the morale of the Lodge, and I trust the forthcoming year may see a great improvement along this line. This Lodge has the material and when the effort is put forward can confer a degree second to none in the Province.

During the year Miramichi Lodge No. 18 was host to Tweedie Lodge No. 41 of Moncton, N. B. They arrived by bus and were given a real Miramichi welcome. There was a large attendance and the M. M. Degree was conferred in a very excellent manner.

Later in the month, Miramichi Lodge returned the visit to Tweedie Lodge but unfortunately Wor. Bro. Godfrey could not go for business reasons. His place was ably taken by Wor. Bro. H. H. Simmonds, who in a very excellent manner conducted the ceremonies of the M. M. Degree. After this night's work the Brethren were royally entertained at luncheon. This exchange of fraternal visits should be encouraged and



goes far to bring the Lodges and members closer together.

August 17, 1952—I attended with you, sir, and other Grand Lodge Officers, Divine Service at the United Church in Campbellton, which was to open the ceremonies of celebration of the 75th Anniversary of Campbellton Lodge No. 32. August 18, 1952—I accompanied you, sir, and your accompanying suite and visited Campbellton Lodge No. 32 to the 75th Anniversary Communication of this Lodge. It was a real pleasure to be at this communication and hear the addresses given by yourself, sir, and your guest, the Most Worshipful Grand Master Roy of the Grand Lodge of Massachusetts. The highlight of this session was the dedication of a set of working tools which have been presented to Campbellton Lodge by the wife of W:B: A. A. Andrew. It shows the esteem in which his beloved wife held him and acknowledged her approval of the work which he loved and devoted a great part of his time to. I am sure that the Campbellton Lodge as a whole will greatly appreciate this generous token of esteem and will remember Wor. Bro. Andrew and his work for years to come.

At the banquet in the evening which was attended

by a large number of Masons, their wives or lady friends, we heard an address by yourself, sir, and Most Worshipful Bro. Roy, both of which will be remembered for a long time.

What was very impressive and appropriate was the violin music provided by a very talented young lady and her accompanist, who furnished us with delightful music of bygone days.

The evening of celebration was concluded with a dance in the Masonic hall when a large gathering enjoyed the wonderful music provided for the occasion.

Best wishes were extended to Campbellton Lodge No. 32 for continued success and prosperity.

This concludes my third report to you as your D. D. G. M. for District No. 3, and I thank you most sincerely for the opportunity of serving you in this capacity and trust my humble efforts have in some way been worthy of the office.

I wish to thank all Lodges in my jurisdiction for the support and assistance, and wishing them every success in their work.

On December 27 I visited Cherry Mountain Lodge at Harvey Station for the purpose of installing the Master and officers for the ensuing year, I had as my Director W: Bro. Sam Page of Alexandria Lodge. This was a very enthusiastic meeting — as are all the meetings of this Lodge the reason being that the members of this Lodge take their Masonry seriously and are interested in the welfare of their Lodge.

On January 3rd I visited Ashlar Lodge at McAdam to install their Master and Officers, on this occasion I had as my Director W: Bro. H. F. McElman of Alexandria Lodge. This ceremony was carried out according to ancient usage.

On January 7th I paid an official visit to Alexandria Lodge for the purpose of installing their incoming Master into his office. The other officers were installed by R:W: Bro. W. J. Maxwell. The Director on this occasion was again W: Bro. McElman.



On May 1st along with other Grand Lodge Officers I attended on the Grand Master on his official visit to Hiram Lodge. This was a very enthusiastic meeting and there was a large attendance of members. One interesting feature commented on by the Grand Master was the large attendance of Past Masters of Hiram Lodge as well as many from surrounding Lodges. The E. A. degree was conferred in the usual excellent manner which we always associate with Hiram Lodge.

On May 3rd I again attended on the Grand Master on his visit to Sunbury Lodge at Fredericton Junction. Here again there was a good attendance of Past Masters and other members. The E.A. degree was conferred in a very excellent manner after which the Grand Master gave a very inspiring address.

On April 17th, I attended Ashlar Lodge to see our R.C.M.P. team confer the M.M. degree, W: Bro. Phillips of Hiram Lodge occupied the East. There was a very large number of Brethren present — about 350 representing many Lodges on both sides of International Boundary. The M.M. degree was conferred in a very able manner and was very enthusiastically received by those present.

On May 14th, I attended Grand Lake Lodge to take part along with the members of the R.C.M.P. team in conferring the M.M. degree on two candidates. This was also a largely attended meeting and the work of the team was warmly received.

My thanks to the Grand Secretary and other members of Grand Lodge who have rendered me considerable assistance.
