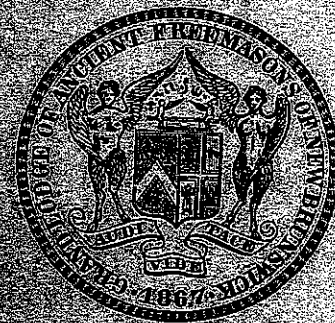

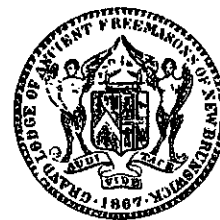

TOWARD THE MIDDLE CHAMBER

There are many great moments in the life of a Mason. For me, one of them was when you granted me the honour and privilege of serving as the Grand Chaplain of this Grand Lodge. Should the Supreme Architect see fit to employ me in executing His designs for another thirty years, this will still be unforgettable.

I say "thirty years", because I can yet recall another great moment for me in Masonry. It was at a point which I have never heard particularly mentioned by my Brethren, but I recall vividly when the Worshipful Master turned to me and said:

"It will be necessary that you make an advance by a flight of Winding Stairs, consisting of three, five, and seven steps, into a place representing

the Middle Chamber of King Solomon's Temple, there to receive the wages of a Fellowcraft, which according to our ancient Brethren were Corn, Wine and Oil."

The Legend of the Fellowcraft Degree is too often overshadowed by that of the Sublime Degree which follows it; but for thirty years I have treasured it. The Entered Apprentice Degree is said to represent birth and the beginning of knowledge, of Light in Masonry. The Master Mason Degree represents full maturity, wisdom, and responsibility. Between them, the Fellowcraft Degree represents manhood and the years of service and ever-enlarging understanding. To this I would draw your attention today.

As we in memory, then, stand once more at the foot of the Winding Stairs, let us remember two things:

First, the Candidate has to climb the stairs himself. This is a suitable thing for all Master Masons to remember. Regardless of how far we may have advanced in Masonry, further progress depends upon our own efforts. Not only the first step in the Winding Stairs, but every step which follows, and every step still before us will be conquered only if we put forth our efforts to achieve it. We must walk, not wait; we must climb, not linger. Stairs, on the whole, make poor living places. True Masonic life depends upon continued progress in Freemasonry. We have set our feet upon the stairs of life, which lead always toward more Light until at last "the day dawns and the shadows flee away". We dare not linger.

Secondly, however, the Candidate is assured that although his progress depends upon his own efforts, he does not climb alone. He is informed that the number Three represents the Great Officers of the Lodge, the Worshipful Master and the Senior and Junior Wardens. They, in turn, are symbolic of the whole Lodge which is itself a microcosm of the mighty Fraternity of Freemasons. Each Fellowcraft who has gone before him, and every Master Mason in the Fraternity is symbolically at his side to admonish, to guide, and to support. He is a wise Master Mason who remembers that he ever bears this responsibility toward his Brethren, particularly to those who follow him upon the Winding Stairs.

Having thus begun, and being so encouraged, the Fellowcraft finds himself upon the first landing of the quest in which he is engaged. Before him is a higher flight, consisting of five steps. Here again, he climbs, two great truths must come home to him:

First, his attention is again directed to the orders of architecture. He is reminded that the efforts he is putting forth must have as their aim a sense of the beauty of symmetry, that his life as a Mason must possess that order which reflects . . . and it can never do more than reflect . . . "that beauty and order which reigns forever before (the) throne" of the Supreme Architect. If he has paid even moderate attention to the earlier part of the Lecture, he will realize that there is material in plenty for the construction of his Masonic edifice. There is variety from which he may choose, but choose he must, for the edifice he will raise in Masonry will be his alone.

Secondly, he is taught that the construction of this Masonic edifice is not beyond his natural limitations. The Supreme Architect has provided him with the five senses common to all mankind and it is within the limitations of his ability to see, hear, feel, taste, and smell that his work as a Fellowcraft can and must be done. Nothing is or will be asked of him beyond his ability, aided as that will be by the support of his brethren and the Light he will obtain in Freemasonry.

It would be profitable to meditate farther upon his situation, but the Fellowcraft has now attained the second landing and sees before him an even harder task. The final flight of seven steps must now be made. As he climbs, once again two lessons may be learned:

First, it is not expected of either man or Mason that he remain upon the purely sensory level of existence. With the rest of creation, he possesses animal existence. But to reach the Middle Chamber set before and above

him, he must acquire mastery of the mind and of moral qualities. The Seven Liberal Arts and Sciences were, to our ancient Brethren, the limits of a complete and perfect education. It is said that the last man who was a master of knowledge in all its branches died during the Sixteenth Century. The intellectual explosion, so often mentioned these days, had by that time increased knowledge to the point where a lifetime has ever since been too short for one man to possess all knowledge. The age of specialization had already begun. All the more reason why the true Fellowcraft will endeavour to possess knowledge which will make him a man rich in both mind and spirit.

Secondly, he sees the necessity for courage and faith in all the endeavours of mankind. By now he is thoroughly aware that the stairs *wind*. They do not lead directly to the goal; the future is unknown. Not only in Masonry, but in life itself, there is the basic quality of mystery. What lies around the turn in the winding stairs of life no one can say. The Master Mason who knows and accepts this fact has learned the Legend of the Fellowcraft Degree to his great advantage.

Because he *does* come up the stair and the stair *does* lead Somewhere. Just because the future is unknown, it does not follow that there is no future. This is one lesson that Masonry might well speak out more forcefully, because today the whole world fears that very thing. If we cannot see God, they say, it must be because there is *no* God. Or, in modern dialect, "God is dead". The truth is that none of us here as yet come fully up the stair. When we do, we shall see the letter 'G'.

We shall also receive our wages for the labour we expended in the building of our Temple. "To our ancient Brethren" corn (or as we in the West would call it, grain), wine, and oil were the symbols of wealth, health, and prosperity. Dr. Carl Claudy says: "In ancient days the grapes in the vineyard, the olives in the grove, and the grain of the field were not only wealth but the measure of trade; so many skins of wine, so many cruses of oil, so many bushels of corn were then as are dollars and cents today."

But they were more than something as prosaic as that. A sheaf of wheat suspended near a waterford signified "Plenty". Wine meant refreshment in a land of hot winds and unsafe water. Oil brought gladness and healing. The Good Samaritan, you will remember, poured oil into the traveller's wounds.

Let us, then, look at ourselves upon our Masonic pilgrimage. With foot firmly set upon the way, supported by the great and widespread Fraternity, making wise selection of materials of symmetry and beauty for our Buildings, using to the full our natural abilities, striving for the utmost in knowledge and moral excellence, with courage to spur us onward and faith to sustain us in our endeavours, we climb upward on the Winding Stairs. And when, the last step taken and the last turn rounded, we arrive at the Middle Chamber in the Eternal Lodge Above, may the Supreme Architect say of each one of us:

"His very foot has music in it As he comes up the stair!"

February 21st to 23rd; Washington, D. C., to attend the Conference of Grand Masters and Grand Secretaries of North America. This conference was most instructive and informative and one that I will endeavour to practise in the year ahead.

May 1st to May 4th: To the Grand Lodge of Maine accompanied by Most Wor. P.G.M. C. D. Dickison and the Grand Secretary, where we were most hospitably received and entertained.

I would like to express my appreciation of the D.D. G.M.'s who have held district meetings during this term of office. These meetings are most important to all subordinate Lodges so that the ritual will improve to a greater degree of Perfection. The Grand Lodge Ritual Committee has spent considerable time and effort to eliminate errors and has been willing at all times to attend these meetings to assist any W.M. or Lodge Officer who is interested in seeing that his Lodge is carrying out the correct Ritual in their Lodge. Each D.D. G.M. should organize and see that at least one meeting is held in his district during his term of office. It is only by these that we can hope to have uniform work in our New Brunswick Lodges.

It is my hope that your Grand Lodge Ritual Committee will continue to revise the ritual so that its appeal will continue to interest all who ask admission to our doors.

The Board of General Purposes gave approval to the Committee on Masonic Scholarships (Wor. Bro. John B. McNair, P.G.M. Arthur S. Robinson and P.G.M. Henry D. Hopkins) to award five additional scholarships. Considerable interest has been shown and your Committee had much difficulty in selecting these from over fifty applicants.

The Order of DeMolay has the support of the Board of General Purposes. While no new Chapters, were formed, considerable interest is shown in several localities and it is the hope that these will become activated in the coming year. I have urged the Lodges where these Chapters might be formed to do their part wherever possible.

During the year we had the misfortune to lose through death a devoted office employee in the person of Mrs. Henderson. She very capably carried on the work for over fifteen years. She was always willing to assist and her advice was sought by many. We have been fortunate in securing the services of Miss Florence Roberts who has shown in the short time that she has been with us that she, too, is a capable and devoted employee. Upon the death of Mrs. Henderson, your Grand Secretary was placed on a full time basis with Grand Lodge. This should have been done years ago. With the ex-

cellent fund of Masonic information that he can provide and give to interested Masons, this long needed service can now be supplied in a friendly and courteous manner to our brethren.

The Brethren will notice in the Proclamation a notice of motion respecting the change in dates for our Annual Communication. In my opinion, the adoption of this change in the constitution as set forth in this notice will serve to better our attendance at Grand Lodge and assist many brethren who find it impossible to attend during the middle of the week. I strongly urge the adoption of this amendment to the constitution.

To my Deputy Grand Master, Right Worshipful Brother Chester C. Craig, I wish to express my sincere appreciation for his assistance on many occasions and particularly wherein he acted as my representative in the recognition accorded Most Worshipful Bro. N. T. Avaré at Amherst and also on the occasion of the centennial communication of the New Brunswick Lodge No. 22 at Saint John.

While grateful to many of the Grand Lodge officers and Past Masters for their presence and assistance on my visits to the subordinate lodges, I am especially indebted to Most Worshipful Past Grand Master C. D. Dickison for his advice, co-operation and personal assistance during this term of my office as your Grand Master. His experience and wise counsel has contributed in great measure to ease the burden and responsibilities of my office.

During the coming year your Grand Lodge will be celebrating its centennial year along with the rest of Canada. A strong committee has been selected to draw up a program of interest to all Masons in New Brunswick. I would urge all Lodges in the jurisdiction to draw up their own centennial programs and play an active part in this celebration. Wherever possible Lodges in the various districts, town or cities where they exist, should be cleaned and painted up on the outside with appropriate signs to show that we are an active Masonic organization.

An effort in certain localities has been made to familiarize our Masonic bodies with our Roman Catholic friends. In Chatham a Knights of Columbus banquet was held where members of Northumberland Lodge No. 17 and Miramichi Lodge No. 18 were invited to attend. A number of these did and were delighted at the friendly atmosphere that existed. P.G.M. Dickison spoke on behalf of our Fraternity. Later in March bowling was enjoyed by both groups.

Many of you, no doubt, were privileged on Sunday, January 30th, to witness program "Destination" on CHSJ—

TV with a half hour allotted for a talk on Masonry. The panel consisted of P.G.M. H. D. Hopkins, Bro. Rev. John Humphreys and our Grand Secretary A. C. Lemmon. Many favourable comments were received from this presentation.

STATE OF THE ORDER

In my travels around the Province and visitations to the various Lodges I have generally found a good response from all the W.M.'s and Lodge Officers a genuine desire on their part to conduct their meetings in a truly Masonic manner. It is rather disheartening to find in many cases the small turnout of members at some of these meetings when one visits Lodges which boast membership of 300-400 and find a few faithful 40-50 in attendance. We wonder how active these Lodges are. The prestige of Freemasonry starts at the subordinate Lodge level. The level of Leadership starts with the elected Master of these. We must have more proficiency in the East. A Master is expected to be Master of his Lodge, not a weakling to be pushed around. The membership statistics of many of our Lodges make depressing reading. Even with all this, Masonic building goes on. The benevolent work of the Craft should not diminish. A time of moral decay, of increasing crime, of a world wide struggle between might and right, is also the time to adhere religiously to the fundamental teachings of Freemasonry. To weaken the substance of Masonry by making Masonry conform to the passing fancies of the day is to violate our obligations as Masons.

Our work, the work of all who are teachers of Masonry, is to give those who may seek instruction, much more than the mechanics of Masonry. We dare not mark closed on any masonic endeavour. Our work is to explore with those who seek to learn, we must be always ready to give instructions to those who come to us, but more we must give them the higher vision. We must give them a dramatic picture of their own potentialities in exploring untrodden paths with the light of Masonry.

I feel that my striving and work in the Grand Mastership will have been justified if there are even a few young men, mature men, or even men in the golden years, who will be willing to pick up the working tools which I must sooner or later lay down. If I have encouraged even a few to exemplify Masonry in their lives, then I will feel that my body and mind have been well repaid for the effort I have put forth to vitalize and promote Masonry in this Grand Jurisdiction.

May the Supreme Architect of the Universe be with you, all my brethren in Freemasonry, in the years ahead.

REPORT OF THE BOARD OF GENERAL PURPOSES

TO THE GRAND LODGE OF FREE AND ACCEPTED MASONS OF NEW BRUNSWICK:

Four meetings of the board were held during the year. At the July 10, 1965 meeting, Rt. Wor. Bro. A. G. Knowlton, Senior Grand Warden, was elected Vice-President of the board.

The new edition of the ritual is in process of printing, and should be available soon for distribution.

Scholarship awards were increased from four to six, in 1965, amounting to \$3,000.00 and were allotted to students attending, or planning to attend various universities.

The Most Worshipful the Grand Master appointed the following members to be a co-ordinating committee in respect to Centennial Celebrations in 1967, namely, Most Wor. Bro. R. T. Pearson, Most Wor. Bro. D. A. Somerville, Rt. Wor. Bro. C. C. Craig, Rt. Wor. Bro. W. J. Bambury and Rt. Wor. Bro. L. W. Vincent.

On July 18, 1965, our Grand Lodge suffered a regrettable loss in the sudden passing of the Grand Secretary's assistant, Mrs Eleanor S. Henderson. She served this Grand Lodge diligently and faithfully for a period of fifteen years. This circumstance necessitated an adjustment in the office of Grand Secretary. The Board approved the full time employment of the Grand Secretary, Rt. Wor. Bro. A. C. Lemmon, as well as the services of Miss Florence Roberts, as his assistant. Salary compensations have been approved.

During the year, Victoria Lodge No. 26, Milltown, N.B., suffered a complete loss in a disastrous fire. Sussex Lodge No. 7, St. Stephen, N. B., extended the courtesy that Victoria Lodge meet in their building in St. Stephen, which courtesy has been accepted. A duplicate charter is being prepared for Victoria Lodge, to replace that destroyed in the fire.

The 1960 edition of the Constitution and Regulations of Grand Lodge will be depleted during this year, and a new edition is authorized.

The reports of the Grand Treasurer, the Auditors and the Grand Secretary were submitted at the May 1966 meeting, and approved for presentation to the Grand Lodge, at the annual communication to be held in Saint John, N. B., May 26th, 1966.

**Report Of The Grand Historian Of The Grand Lodge
Of Free And Accepted Masons Of New Brunswick,
Canada, May 26th 1966.**

Most Worshipful The Grand Master, Honored Guests, Wardens and Brethren:

Herewith I beg to present my report for the Masonic Year of 1965 - 1966.

Free Masonry in this jurisdiction is in an exceptionally healthy and happy condition.

In this report I shall mention a few of the most outstanding events of the period indicated.

I extend to all who have been called upon to mourn the death of loved ones and friends my sincere and heart-felt sympathy. It would not be possible to mention in detail all such, much as they merit notice. However, there are certain ones whose passing I must call attention to feeling sure all would wish it done that due honor may be accorded in our records.

The death of Thomas Andrew Robinson, Past Grand Director of Ceremonies, who for two years accompanied me as I attended to my duties as Grand Master of the Jurisdiction of New Brunswick. Tommy, as he was affectionately called by all who knew him, discharged the duties of his office with exceptional ability and grace, thereby winning for our Masons the friendship and esteem of distinguished brethren throughout the American Continent.

He died in the Moncton Hospital Friday, August 6th, 1965. His funeral service was held in his church, St. George's Anglican, Moncton, N. B. at 2 p.m. August 9th. Our Emergent Communication was held in St. George's Chapel, Sunday, August 8th, at 8.30 p.m. All the pallbearers and honorary pallbearers were members of the fraternity. The Masonic Service was in charge of Worshipful Brother Vaughn Scott. Representatives of the T. Eaton Company, for whom he worked for many years were in attendance. After the service his body was conveyed to Collingwood, Ontario, where it was interred with Masonic honors in the Presbyterian Cemetery there. He is survived by his widow, Julia Free. Many relatives and friends in Ontario as well as the Masons in the Collingwood area paid honor to our departed brother.

Tommy was a member of Ivanhoe Preceptory, a Past Master of Keith Lodge, No. 23, 32nd Degree member of the Scottish Rite, a member of the Royal Order of Scotland, a veteran of World War One and an official of St. George's Church, and rose to distinction in all, universally beloved and respected.

Announcement for Masonic Scholarship awards for 1965 has been made by our Grand Master M. W. Perley E. Roy as follows:

Charlotte Lind Lord, Rollingdam, Charlotte County; John Michael Jeffries, Forest Hills, Saint John; David Alan Eagles, River Glade; Jeffrey Norman Lubin, Saint John; Etta Mary MacWilliam, St. Stephen; Patricia Coles Chown, Saint John.

The four previous awards which are for the 1965 term as well include William James Grant, Pownall, P. E. I.; Raymond Leslie Jackson, Harvey Station; Lynn Alfred Nason, Fredericton Junction; Frank James MacKinley, Chatham.

The Masonic Scholarships Committee, in addition to the Grand Master Roy, is Lt. Gov. the Hon. John B. McNair, Fredericton; Dr. A. S. Robinson, Moncton, your Grand Historian; Henry D. Hopkins, Q. C., Saint John and A. C. Lemmon, Grand Secretary.

Another stalwart, called to the Great Beyond, during the Masonic Year was Wor. Brother Roy E. Crawford. Brother Crawford has filled many offices in our Order, both in his lodge and in the Grand Lodge. His employment during later years was with the St. John Harbour Board and the National Harbour Board. His death occurred December 9th, with funeral services December 12th. He was a Past Master of St. John Lodge No. 2, active for nearly 60 years. His son, Prof. Wm. J. H. Crawford, Vice-President of Mount Allison University, Sackville, is also keenly interested in The Ancient Craft.

The sudden death of the assistant to the Grand Secretary, Mrs. E. S. Henderson, came to the entire fraternity as a great shock; no one realizing the frail condition of her health. She had been associated with the office for some 15 years, having come to us in 1950. By her great kindness and helpfulness, she had won a high place in the regard of all. Her call came in the latter part of July. Her body was laid to rest in Fernhill Cemetery, Saint John. Our Grand Secretary was one of the pallbearers.

Wor. Brother John T. Reid of Campbellton was honored by his lodge Christmas Day, a gift from them as well as one from Alexander Chapter of the O. E. S. being presented to him. It was his 91st birthday and members throughout the province join with them in congratulations to Bro. Reid.

It is sad to record the passing of another one of the best known and most popular Masons in the person of Rt. Wor. Bro. Robert Laird Algie, P.D.G.M., a Past Master of Keith Lodge, Moncton and for eleven years their secretary. He died suddenly Friday, April 2nd and was buried April 5th. He had

recently returned to his native Ontario and taken up his residence in Acton where he entered at once in lodge work, Y.M.C.A. and Church. Bro. Herbert Ritchie, Secretary of the Lodge wrote me of the memorial service held in Robert's honor and conducted by the Master of the lodge with which he had affiliated in Acton. The Master was assisted in the service by D.D.G.M. of the Wellington District. The Service was well attended. Bob was a veteran of World War One.

Victoria Lodge sustained a severe loss on September 30th when fire destroyed their Hall, and all their equipment and regalia. Their total loss was at least \$6000 covered to about half that amount by insurance. Sussex Lodge of St. Stephen, at once threw open their doors to their unfortunate brethren of Victoria.

All the lodges were glad to receive from the Grand Secretary a detailed description of the proper way to honor the Royal Toast.

It is noteworthy that most of our lodges have increased their dues to at least \$10.00 per annum and many insist on payment in advance. Also many of the lodges include in their monthly notices announcements of the installations, etc. of the Boys' Order of Demolay. This is an excellent attitude as the interest and support of the Masons is absolutely necessary to the boys in conducting their business meetings and degree work.

Wednesday, October 20th, 1965, Wor. Bro. Herman E. Sullivan, Treasurer of Hibernia Lodge No. 3 presided at an Emergent Communication and raised four candidates to the sublime degree of Master Mason, three of whom were his own sons. This was a unique occurrence. Quite frequently a father raises his son and occasionally two, but three, this is indeed an event, also in this case, the father presided throughout the evening. The Grand Lodge room was filled to capacity. Herman, in his address, mentioned how greatly he had desired such an occurrence and his wish to preside at it. All present were pleased to see his wish fulfilled.

The names of the sons being raised by their father are: Herman Andrew Sullivan; Charles Kenneth Sullivan; and David Lawrence Sullivan. Also raised at that time was the good friend of the boys Robert Lloyd Arsenault. "Special Sullivan Refreshments" were served after the close of the meetings.

I have a letter from our Grand Secretary re our late Grand Organist, Bro. Dr. H. C. Dunlop which is of interest. He was out of this rank for 3 years from 1943 to 1945; then resumed again till his death making a total of 31 years service.

Tuesday, October 13th, at a special communication, Westmorland Lodge conferred honorary membership on Rt. Wor. Philip Drader and R.W. Lloyd Vincent.

Brother Stuart Brown recently sent me a snapshot taken by him of White Hart Lodge No. 2 Here is buried Joseph Montford, first, last and only Grand Master of America. The lodge building is the only one in America built exclusively and used continuously for Masonic purposes. This stands intact with the original furniture. Stuart also wrote me he had taken a snap of Montford's grave. The location is Halifax, N.S.

In the regular notice of the January communication of The New Brunswick Lodge No. 22 Wor. Bro. T. Leslie Bank, Acting Wor. Master, gave the following intimation: "The New Brunswick Lodge will celebrate its 100th anniversary of its founding on Tuesday, February 8, 1966. Through the courtesy of Hibernia Lodge, arrangements have been made for an exchange of meeting dates for February. The installation of Officers will take place at this meeting on February 8th, instead of in January as usual. It was hoped that the Grand Master and Officers of Grand Lodge would be present. However, he was prevented by illness and his duties were ably carried out by Past Grand Master James Stanley Hoyt. I was tendered a special invitation to be present. I was most happy to accept and enjoyed it greatly.

It was noted during the evening that Bro. Albert Hoar had been Secretary of the Lodge for 28 yrs. This is an outstanding record. A Past Master's Jewel was presented to Wor. Bro. Banks, also his commission as Grand Representative of the Grand Lodge of Florida near the Grand Lodge of New Brunswick. This last was done by M. W. Past G. Master, Ralph T. Pearson.

Rt. Wor. Allison G. Knowlton, as representative of the Grand Lodge of South Dakota was presented with his commission by Past Grand Master Arthur S. Robinson. It was a happy and eventful evening of which the New Brunswick Lodge may well be proud. Their booklet issued on this occasion was an attractive one. The feature of the communication was the reading of the 100 years history of the lodge compiled and delivered by Wor. Brother Banks.

Again the New Brunswick Lodge came into the limelight by holding its visiting Master's Night, Wednesday, November 24th. On this occasion all the presiding Worshipful Masters of District No. 1 were especially invited to attend. All were delighted to comply, except one prevented by sickness in his home.

Exchange of visits seems to have been a special feature, during the current year, not only within our jurisdiction, but

even beyond. One in particular may be cited. It might well be called the "Norman T. Avaré" Night in Alexandra Lodge No. 87 A.F. & A.M. of Amherst, N. S. M.W. P.G.M. Avaré has given Masonry great service in his jurisdiction and is well known beyond it. Worshipful Master E. D. MacMaster presided at the banquet, by which the celebration began in the banquet room and in the regular lodge meeting which followed. The toast to the honoured guest was proposed by M. W. Past Grand Master R. V. Harris, for many years Grand Secretary of Nova Scotia, and replied to by P.G.M. Dr. Avaré of course. In the lodge meeting, gifts were presented the honored guest to which he again replied. Masons attended from many points outside the jurisdiction of Nova Scotia and the program, both in the banquet room and in the lodge room were characterized by items both many and varied.

The Ritual Committee has had rather a busy year during this term, owing to the fact that the new Ritual with the addition to the spelling out of words has had to be checked and is now in the printer's hands for final galley proofing, and we hope that this will be forthcoming very soon so that the actual printing will be finished in the early Fall.

Members of the committee have been present at three different District Meetings and assisted in the work on each of these occasions, clarifying wording, modes of procedure and floor work wherever necessary.

November 6th, 1965, with Benjamin Lodge in Andover as hosts, when all three degrees were reviewed, with a large attendance of the brethren of the district being present.

December 11th, 1965, with Hiram Lodge Fredericton as hosts. This was an evening meeting when an hour of the lodge time was placed at the disposal of V:W: Bro. Perkins for consideration of the program which he had outlined.

April 23rd, 1966, with Northumberland Lodge in Newcastle as hosts. The afternoon and evening were spent in conferring the three degrees, the latter of which was work on a live candidate. PRESENTATION OF WARRANT

The Most Worshipful The Grand Master called to the attention of Grand Lodge that Victoria Lodge No. 26 had suffered the loss of their Charter along with all their property in a disastrous fire in September 1965 and that the Charter was now on hand to be presented to a delegation from Victoria Lodge No. 26. In the absence

Irving who represented the Worshipful Master for this occasion. The Charter was engrossed by Worshipful Brother C. Andrew MacVey of Hiram Lodge No. 6 Fredericton, N. B., and is an exact duplicate of the original warrant issued to Victoria Lodge No. 26 in 1870 and is now inscribed by the Grand Secretary as the authorized duplicate. W:B: H. E. Irving accepted the Warrant on behalf of the delegation, expressing his appreciation of the members of Victoria Lodge.

HONORARY MEMBERSHIP

M:W: Bro. James S. Hoyt moved, seconded by W:B: R. V. Limerick and adopted, that Wor. Bro. Charles Andrew MacVey, a Past Grand Deacon of this Grand Lodge, be elected an Honorary Past Senior Grand Warden of this Grand Lodge.

Wor. Bro. MacVey received his degrees in Hiram Lodge No. 6, Fredericton, in 1911, at the age of 31 years. He was Worshipful Master of that Lodge in 1918 and at his advanced age in 1966 engrossed the above mentioned Charter for Victoria Lodge, which is a masterpiece of penmanship and is not the only example of craftsmanship which Wor. Bro. MacVey has completed for this Grand Lodge and for other organizations. His faithful service to his Mother Lodge, this Grand Lodge and Freemasonry in general has been exemplary and the recognition being accorded him with this honorary rank received the approbation and standing ovation of the members of this Grand Lodge. M:W: The Grand Master duly confirmed the action of the Grand Lodge and subsequently the engrossed Certificate was presented to Right Worshipful Bro. MacVey.

Motion by the R:W: Bro. C. H. Jarvis, seconded by W: Bro. A. M. Lawson, and adopted the Grand Lodge recess until 7:30 p.m. when the first order of business shall be the election of Grand Lodge officers.

The customary banquet under the auspices of the Entertainment Committee of Grand Lodge was held in the Banquet Hall at 6:00 p.m.

The special speaker for the occasion was M:W: Bro. Rev. Aubrey L. Burbank, Past Grand Master, Grand Lodge of Maine. M:W: Bro. Burbank was introduced by M:W: Bro. Frank C. Thomas, Past Grand Master and Grand Representative of the Grand Lodge of Maine. A transcript of his address is inserted as part of these proceedings.

ADDRESS BY M:W: BRO. REV. AUBREY L. BURBANK

Past Grand Master, Grand Lodge of Maine

Most Worshipful Brother Thomas, Most Worshipful, the Grand Master, Distinguished Brethren at the head table, my very good friends and brethren of New Brunswick: I want, first of all, to express appreciation for the many courtesies extended to us as your guests, and for this privilege of sharing with you these few moments.

You will recall that the Most Worshipful The Grand Master announced earlier his intention of recalling the Grand Lodge to order at 7:30 rather than at 8:00 o'clock as previously announced. Immediately at the close of the afternoon session he hastened to tell me, rather apologetically, that it was not his intent to cut me short, but that it seemed advisable to get the evening session started as early as possible, all of which reminds me of the minister who felt obliged to go beyond the usual twenty minutes allotted for the saving of souls, and after some forty-five minutes of intense preaching, noticed a gentleman of his captive audience arise from his pew and reel sort of stiff-kneed down the aisle, whereupon he brought his message to an abrupt end. At the close of the service a lady rushed up, and apologetically said, "Reverend, I wouldn't want you to think that my husband was bored with your message, it's just that he walks in his sleep." I certainly wouldn't want that to happen here tonight.

Last evening one of the boys mentioned that you had no audio equipment available at this banquet but that he felt confident I could be heard. I want you to know that I am what is known in the States as a "Shouting Methodist," and if you do not hear me, just raise your hand and I will see that you do.

I think it is safe to say that there is no aspect of Masonry that has not been explored and expounded by countless numbers of authors and speakers and it would be folly for me to think that I could light any new fire in your hearts, but I would endeavor, in my humble way, to rekindle a flame which I believe has been permitted to smoulder, perhaps nigh being extinguished, through apathy and neglect. Perhaps I may be presumptuous in thinking that the same conditions exist here as in the states, but I would, nevertheless, dare speak to you on a subject of great concern to myself, and which I know to be of equal concern to many.

I might preface these remarks with a series of interrogations: "Can Masonry justify its existence in today's world? What has Masonry to offer to the world of this latter 20th century? Has Masonry lost its appeal to the hearts of men?" I could not help noticing how few really young men are present here tonight, and I wonder if that does not say something to us.

It is not my intention to belabor you with historical data but rather with the ideals which have been and must always be the lifeblood of our great fraternity.

Every source of light must have a beginning. It is no less true of Masonry, although no-one has yet determined for certain as to where or what constituted that beginning. You must first clarify your definition of Masonry, and even then there is room for speculation and doubt.

Many historians trace the operative craft to the building of King Solomon's Temple. Others will say that it didn't take form until the formation of Operative Guilds. Those who delve in the speculative art envision the essence of Masonry as manifesting itself in the life and teachings of the Man of Nazareth, while still others find their source in the Garden of Eden. In essence, they are all correct. If, by Masonry, you mean an experience of the heart or soul of man; if, in its theory and practice, man finds satisfaction for the hunger for brotherhood which burns in his breast — to be his brother's keeper; if, on the trestle-board of life, one can find the pattern which will enable him to make of himself a better husband, father, brother or son; and if, through this unique fellowship, one finds fellowship with God, the Father; then indeed is Masonry as old as the ages and as new as each man's emergence from darkness to light.

Obviously, we could go on at great length as to the incidents that contributed to the growth of Masonry, but I wouldn't want anyone walking in their sleep, and the Most Worshipful Grand Master is trying to keep on schedule. We have, however, seen the operative craft emerge from its former state to a fraternity which embraces men of character in all walks of life.

It is further evident that, wherever you initiate the beginning, Masonry, whether operative or speculative, whether in the heart of man or in the government of his earthly labor, is and always has been a deeply religious way of life, established with its first pillar as the Fatherhood of God, and its second as the Brotherhood of man. If, then, the Fatherhood of God be the first pillar of Masonry, and the Brotherhood of man the second: If the Volume of the Sacred Law be our Light and our Guide, how do we measure up in this latter half of the 20th century to the heritage which is ours, and exclusively ours, as Freemasons?

I am sure that you would have expected me to arrive at this point in my message to you this evening, as I earlier made reference to my hope of rekindling a flame, which, I believe, has been permitted to smoulder, and besides, when did you ever know a preacher to stop preaching if given the slightest opportunity? I would therefore put it in the form of further interrogation: "What

are we doing towards the building of a spiritual temple to God in our own hearts — and will the intangible temples that we are building in our communities, our nations, and the world stand the test of time?"

My brethren, the house that each one of us builds depends solely upon us as individuals. As we meet the duties, the urgencies, the labors of life, we are adding stone upon stone to that Temple every day. Will it stand up under the storms and vicissitudes of life? Remember those words from the 127th Psalm: "Except the Lord build the house, they labor in vain who build it." As one good brother once put it: "The foundation of our house should be constructed of faith, the roof of love, the walls of respect, tolerance and kindness. Through the windows should come the light of understanding. In the rooms should be heard the paeans of prayer and praise. Surely, then above the spires and turrets divine approbation will bless the house and make it a Temple of the soul, truly filled with peace, contentment and happiness."

We are living in a chaotic world where the forces of right are battling for their very existence over the forces of evil. All the things which we hold dear, including the principles upon which our Fraternity rests, are being threatened. What part does Masonry play as this drama unfolds before us?

My brethren, Masonry was organized not for material purposes, but to unite the hearts of men in one accord as children of one Almighty Parent and therefore brothers one to another. You and I did not become Masons to get rich or to be famous — but to join in building the Temple of the Soul for each, and the Temple of Brotherhood for all.

It is altogether true that Masonry is not, and was never intended as a religion in itself, yet you will hear countless of our brethren say that Masonry is all the religion they need. Perhaps this may satisfy their present need, but what of this immortal life which is one of the fundamental teachings of the order? What of salvation? What of prayer? What of forgiveness? And don't tell me that you don't need forgiveness — the history of the human race is one continuous history of sin and degradation. Do you find in the Master of your Lodge a father-confessor? Do you sacrifice at the altar of Masonry? Do you worship in spirit and in truth? And now I must ask your forgiveness, in that it was not my intention to preach a sermon here tonight. I merely mean to point out that, as we have been reminded, the moment we are born, we begin to die. Since we cannot determine the length of life, we must give attention to the living it more deeply, and in this endeavor religion and fraternalism go hand in hand. Our fraternity is not a religious organization, although it is religious in character, and if we follow its precepts, we cannot help but approach our choice of religion.

I am sure that you cannot be ignorant of the fact that there exists, in some circles today, a rather wide gulf between the church and our fraternity, and that it is an ever-widening gulf. As a minister, but also as a Mason in the ministry, it has caused me no little concern. I can understand a certain amount of narrow-mindedness and even fanatacism on the part of certain of the clergy, but I can also see that we, as a fraternity, are not entirely without blame. We are not above reproach in this matter.

I tell you, brethren, by all that's good and holy, you cannot truly practice your masonry and turn your back on the church.

You wonder sometimes why you don't get a warmer reception from the minister when you attend worship services, as a body, in your local church. Well, let's be honest with ourselves and take an impartial look at the situation. You will understand, of course, that this is not true in all cases, but it's true in enough of them to make it a matter of concern. Here is a meager, unrepresentative group of masons, perhaps fifteen or twenty out of a lodge membership of two to four hundred or more, attending the services in a body — not to worship, really, but, like the Pharisees, to be seen of men, pretending before the world that they are defenders of the faith, of truth and righteousness — temple-builders, if you will — expecting praise and acclamation to be heaped upon them by the minister. Perhaps it's the one time of the entire year that you will see many of those particular individuals in the church. Oh, I know, this is harsh — a serious indictment of the fraternity — but it's something that needs to be said.

What kind of example are they setting for their children or grandchildren? What kind of example are they setting in the community? Does this reflect well on the fraternity? Will a child on the street point to one of these men adorned with a little white apron and say, "I want to be like him when I grow up?" Is this the kind of Temple that will be a source of community pride?

You talk about building a Temple to God in your heart! How can you build such a spiritual temple when you don't know what a Temple looks like on the inside?

Masonry is as vital a force today as it ever was, and never in its history has it faced a greater challenge in the defence of those things for which it stands. It is battling for its very existence. If there be a failure, it will not be Masonry that fails, but Masons who no longer practice that which they learned at Masonry's altar.

Throughout history, Masonry has led every movement for progress, and has survived every attack. Today it faces its most glorious opportunity. Ours is a magnificent heritage. As you and I live our Masonry, so shall Masonry live. Our very existence depends upon the character of our members, and that, in turn, depends upon our spiritual faith. If we are to carry on and perfect

the structure which our fathers built — if we are to adorn the Temple through lives lived in the service of God and fellow-man, we must have a deep and abiding faith.

We cannot afford to be lethargic, sleeping Masons. We must be dedicated . . . We must be motivated . . . We must be consecrated Masons. Let us, then, rise up, my brethren, to the opportunity, the challenge, and the need that lies before us. "Know ye not that ye are the Temple of God, and that the Spirit of God dwelleth in you? If any man defile the Temple of God, him shall God destroy; for the Temple of God is holy, which Temple ye are."

If it has appeared to you that I have been preaching tonight, I must confess that you are right, but I hope that you will understand that I have been speaking from the heart, and perhaps I could close in no better way than to share with you words from the pen of one of our world-famous brethren, the late Brother Edgar A. Guest. What I have failed to put over through the spoken word, he has immortalized in his inimitable way with the pen.

"I'd rather see a sermon than hear one any day;
I'd rather one should walk with me than merely tell the way.
The eye's a better pupil and more willing than the ear,
Fine counsel is confusing, but example's always clear;
And the best of all the preachers are the men who live their creeds,
For to see good put in action is what everybody needs.

I can learn to do it if you'll let me see it done;
I can watch your hands in action, but your tongue too fast may run.
And the lecture you deliver may be very wise and true,
But I'd rather get my lessons by observing what you do;
For I might misunderstand you and the high advice you give,
But there's no misunderstanding how you act and how you live.

When I see an act of kindness, I am eager to be kind.
When a weaker brother stumbles and a strong man stays behind
Just to see if he can help him, then the wish grows strong in me
To become as big and thoughtful as I know that friend to be.
And all travellers can witness that the best of guides to-day.
Is not the one who tells them, but the one who shows the way.

One good man teaches many, men believe what they behold;
One deed of kindness noticed is worth forty that are told.
Who stands with men of honor learns to hold his honor dear,
For right living speaks a language which to every one is clear.
Though an able speaker charm me with his eloquence, I say,
I'd rather see a sermon than to hear one any day."

Thank You, Brethren.

The M:W: The Grand Master expressed appreciation and personal thanks to M:W: Bro. Burbank for his timely and interesting address, on behalf of The Grand Lodge and the capacity audience.

Limerick were appointed scrutineers, who were duly sworn.
