A special thank you to Miss Doreen Ross, Stenographer, for keeping us all on the right track. The dedication of such efficient staff could not but make the Grand Master's decisions somewhat easier. Our Masonic Senior Citizens Complex, "The Quinn House" at St. Andrews is completely filled and working smoothly under the capable guidance of a committee from St. Mark's Lodge No. 5. In addition, requests were received by our Masonic Charities and Housing in 1990 for increased housing projects.

June 16, 1990 I took part in the official opening of the Seniors Complex at Woodstock, N.B. Their units too are full and are run very nicely by a Committee from Woodstock Lodge No. 100.

Most of you are aware, the proposed Seniors Complex at Woodstock was put on hold as the need in that area no longer exists.

It is possible that any increased government spending on the Seniors Complex in New Brunswick in 1991 could provide the Masonic Lodge with the opportunity to extend its building program. VISITATIONS

In my second year as your Grand Master, I am pleased to report that I have completed the Official Visitations of our 51 lodges in this Jurisdiction. An additional 87 visitations were made this year for other purposes within and outside New Brunswick.

The Grand Lodge of New Brunswick was invited in 1990 to rededicate the Cornerstone, laid 100 years ago, at Wesley Memorial United Church, Moncton. As a part of their year long celebration to honour that important event, your Grand Master, accompanied by Grand Lodge Officers and approximately 300 Masonic brethren, attended service at that Church, Nov. 4th at 11:00 a.m. and performed the Rededication Ceremony. Incidentally, this cornerstone was laid by Past Grand Master, M:W:Bro. Thomas Walker, and I was very pleased as your Grand Master to go back 100 years later and follow in the footsteps of such a worthy brother.

Centennial Lodge No. 53, requiring additional space and facilities to function properly, moved from their old site at Maugerville to a newly acquired building at Oromocto. On April 1991 I did conduct the Consecration Service, with my Grand Lodge Officers and many visitors, dedicating this building to the service of Freemasonry.

A complete listing of my Official and Unofficial Visits for 1990 and 1991 will be contained in the Proceedings.

ALL CANADA CONFERENCE - 1991

In this year, your Grand Lodge participated in the All Canada Conference in Winnipeg, March 15-16. It was attended by representatives from Masonic Jurisdictions across Canada and from New Brunswick by your Grand Master, Deputy Grand Master - Rt. Wor. Bro. Orville Mason and Rt. Wor. Bro. Stirling Scribner, Grand Secretary. While no paper was presented by your representatives, the ones presented did generate considerable discussion. I noted that, while each Jurisdiction operates somewhat differently, yet all are operating with a single objective in mind of making masonry strong in Canada. Considerable dialogue took place during the year on Prince Hall Masonry and, from reports received, it seems that much has to be done yet to arrive at a mutual operational understanding.

EDUCATIONAL PROGRAM

The benefits of our "Mentor Program" are now taking effect. New brethren coming into our ranks now show a far greater understanding and acceptability of the requirements of masonry and will, I am sure, become good officer material of the future. The Officers training manual, which Education Chairman Mr. Morris Linkletter and his Committee are presently revising and updating, has proven to be a very time-consuming project. It will, however, be available to our lodges later in 1991.

Our Education Committee has revised the "Friend to Friend" booklet to conform with our requirement in New Brunswick and will now be available in all lodges for use.

Rt. Wor. Bro. Ronald Caines, Editor of "Mostly Masonry", Rt. Wor. Bro. Gordon Rattray - Grand Historian, Rt. Wor. Bro. Fergus Price, Chairman of our Ritual Committee and Chairmen and Members of the Committees of Grand Lodge, I sincerely thank you for all of the help and assistance given me during my time as your Grand Master. I am sure the incoming Grand Master will find a very fine and qualified and ready to accede to his requirements.

DISTRICT DEPUTY GRAND MASTERS

I have been very fortunate in the past two years to have had seven very devoted and well-qualified officers as my District Deputy Grand Masters. Brethren, your work has been exceptional and the increased interest in our lodge building and ritual work reflects your dedication in the concerns of your district. The peace and harmony prevailing in our lodges undoubtedly stem from good officer selection and your capable guidance in lodge matters.

On behalf of myself and Grand Lodge, I say thank you for a job well done.

GENERAL COMMENTS

The slight improvement in membership noticed in 1989-90 seems to be now encouraging, as lodge notices show an increasing number of new candidates applying for membership in our fraternity. The loss of members through Suspensions, Demits and Withdrawals are still alarmingly high and this appears to be a problem we must now address.

Several brethren, having reached the 50-60 and 70 year plateau in Masonry in 1990, were awarded pins, and I had the honour and pleasure, on your behalf, of presenting some during my visits to their respective lodges. Congratulations and continued good health to each of you.

In 1990 our Scholarship Committee awarded 20 \$1,000 bursaries and, from comments received from recipients, surely indicated the Awards were much appreciated.

The Board of General Purposes in 1990 approved the award of \$2,500 to the Saint John Regional Hospital Cardiac Care Unit. Your Grand Master, with Rt. Wor. Bro. Gordon Young - Deputy Grand Master, made the presentation.

The City of Moncton celebrated their 100th Anniversary in 1990 and on Dec. 9th awarded one hundred "1990 Moncton Commemorative Medallions". Your Grand Lodge, being invited to recommend a worthy Brother, chose Brother Arthur B. Grear for his volunteer work for over 20 years assisting the Children's Summer Programs at Centennial Park. I accompanied Bro. Grear to City Hall, Moncton to receive his Award and was very pleased to

that ten additional worthy Brothers received similar awards, having been recommended by their respective groups. Congratulations to each of you.

This past year has seen a greater involvement by Masons in community affairs; this is evident by greater utilization of our ties; Semi-Public Installations, which tend to bring families together, and there are increasing programs including the children in the community. Your Grand Master approves such action and commends continual involvement.

The Grand Lodge of New Brunswick will, in 1992, be celebrating its 125th Anniversary, and a committee is very active in developing a program for that special occasion. I would suggest we should all use our time and energy to make this important event a success.

It was recognized for some time that Grand Lodge required a computer to organize its work properly. During my term as your Grand Master one was acquired, and Miss Doreen Ross, our office assistant, with the expertise assistance of Rt. Wor. Bro. Chesley Carey, D.D.G.M., District #1, has been working to achieve the results from it.

Finally, my brethren, it has been a great privilege to be your Grand Master for the past two years, and I thank you for affording me this great honour. Again, I will say how pleased I was at my visitations during the year, having in most cases been well attended, and it afforded me the opportunity to speak with so many brethren which I certainly enjoyed. I was so pleased during the visitations to see the buildings so well looked after and their furnishings in such excellent condition, which certainly indicates interest and pride of the brethren.

We have continued in 1990 to further develop a much closer relationship between lodges, and indications are that we have been somewhat successful. If we continue to extend the hand of brotherly love to our brethren and if we keep in mind that it is our objective to make good men better, then surely we are bound to succeed.

If we further extend our talents to the community around us we can accept the challenges of the 90's, which can best be summed up in this fashion. As Master Masons we have three goals for

which we must strive and to which we must dedicate our lives. We seek improvement, to set an example, and to realize that the responsibility rests upon our shoulders. If we accept these goals, Freemasonry will move ahead and we will build for the future.

Again, my brethren, I thank you for the pleasure and privilege of filling this all-important office as your Grand Master and may the able assistance given me through my term be extended to my successor in office. Thank you and may you continue to have good health and happiness.

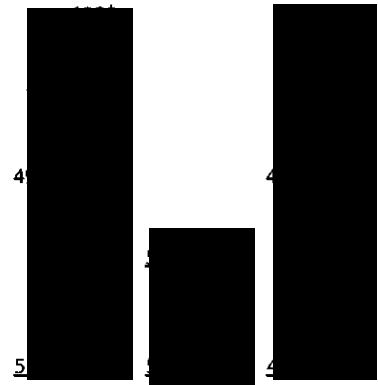

The Financial Statement you received with the Proclamation shows an accurate account of the Finances of Grand Lodge as of December 31, 1990. They include Grand Lodge Investments as well as the Profit and Loss Statement and the Benevolent Fund Investments, Revenue and Disbursements.

The Finance Committee met on several occasions during the year and fully reviewed Grand Lodge Finances. The Investments with Investors Syndicate were reviewed and updated. We also recommend that the unconditional grant of \$550.00 be given to each Lodge in the Jurisdiction and that \$20,000 again be given for scholarships.

During the year, on direction of the Board of General Purposes we were able to assist a Lodge in the purchase of a new building with a loan of \$10,000 at a rate favourable to both Grand Lodge and the borrower.

Benevolent grants from the Fund of Benevolence have increased over the last two years, but remain only a small portion of the revenue generated from this account.
